OSHA to Expand the Use of Instance-by-Instance Penalties

EHS Today

A new OSHA policy has gone into effect expanding penalties for instance-by-instance (IBI) citations. The move has the potential to significantly increase the monetary penalty amounts associated with certain violations and signals OSHA's stated commitment to increased enforcement in 2023 and beyond.

IBI citations are those for which OSHA could issue multiple citations, with corresponding penalties, for each instance of alleged non-compliance—separate penalties for each machine, each location, each entry, each employee. Under OSHA's prior policy, which was in place since 1990, OSHA would only apply IBI penalties for willful citations, or situations when an employer knowingly fails to comply with a legal requirement or acts with plain indifference to employee safety.

Under the new policy, which went into effect on March 27, the IBI policy will now apply to high-gravity serious violations in the following areas:

- Falls
- Machine guarding
- Respiratory protection
- Lockout tagout
- Permit required confined space
- Trenching
- Other-than-serious violations specific to recordkeeping.

A serious violation can occur when the workplace hazard could cause an accident or illness that would most likely result in death or serious physical harm, unless the employer did not know or could not have known of the violations. High-gravity violations are those that have a high risk of severe injury and a high probability of occurrence.

The areas of focus listed above are common standards applicable across the manufacturing industry. In addition, many of them regularly appear on OSHA's top 10 list of most cited standards. Under the prior IBI policy, a manufacturer that fails to have proper machine guarding on all of its machines on a factory floor might be cited for one violation. Under the new policy, the penalty amount could be significantly multiplied to account for the number of machines and/or the number of employees potentially at risk.

While the new IBI policy will focus on high-gravity serious violations in the above areas, it will also apply to other-than-serious recordkeeping violations. Therefore, employers with certain types of recordkeeping violations could find themselves subject to significant penalties for failures to record or inaccuracies in the records.

In deciding whether to apply the new IBI policy, OSHA will consider certain factors, such as:

- Whether the employer has received a willful, repeat, or failure to abate violation within the past five years;

the past five years;

- Whether the employer has failed to report a fatality, inpatient hospitalization, amputation, or loss of an eye;
- Whether the proposed citations are related to a fatality/catastrophe; and
- Whether the proposed recordkeeping citations are related to injury or illness(es) that occurred as a result of a serious hazard.

OSHA intends to use the new IBI policy to deter employers from maintaining or failing to fully abate certain violations and hopes that it will encourage employers to be proactive in preventing workplace fatalities and injuries.

On the same day that OSHA announced the new IBI policy, it also released a memorandum reminding OSHA offices of their discretion to not group violations, particularly when (1) violations have a different abatement method, (2) each condition could result in death or serious physical harm, and (3) each condition exposes workers to a related but different hazard. The grouping decisions are also intended to have a deterrent effect on employer behavior.



6 Spring Safety Toolbox Topics for April

April is a time that most people associate with spring—and spring cleaning. Spring cleaning isn't just limited to your home—whether you work in an office or on a construction site, cleaning and organization are vital to maintaining production. In addition to higher productivity, a clean workplace can also reduce injuries, lower absenteeism and promote better health and safety practices.

To start April off on the right foot, why not discuss *5 Ways to Optimize Housekeeping Procedures* as a toolbox talk? April also has a number of national days that you can focus your attention on for toolbox talks, as detailed below.

Distracted Driving Awareness Month

April is Distracted Driving Awareness Month. According to the National Highway Traffic Safety Administration (NHTSA), 3,142 people were killed by distracted driving in 2019. Since distraction is the underlying cause of most incidents, drivers need to learn how to manage the states of mind that contribute to distraction. SafeStart recently created a guide for new drivers to explain the dangers of distraction—as well as carry out a 24/7 safety mandate. *Understanding Distractions: Tips for New Drivers* provides advice on how to avoid distractions behind the wheel by addressing issues like peer pressure, route planning, saving food and drinks for later, and learning to maintain focus.

Driving is one of the riskiest things most of us do every day and it's important to ensure everyone stays safe behind the wheel. SafeStart's driving awareness toolkit also has bike safety toolbox talks that are ready to be delivered, and well-researched blog posts on distraction that are ready to be adapted to fit your next April safety meeting or toolbox talk.

Workplace Violence Awareness Month

April marks the month we observe Workplace Violence Awareness. Even if you don't personally know anyone who has suffered an act of workplace violence, you have likely seen something in the news that has resonated with you. Workplace violence is more common than you think. According to the National Safety Council, workplace physical assaults resulted in 20,870 injuries and 454 fatalities in 2019. The recent pandemic has caused workplace violence to increase. Workplace violence is defined as any act (or threat) of physical violence. It also includes intimidation and verbal abuse that could lead to physical assault and subsequent non-fatal or fatal injuries. OSHA requires all workplaces to provide an environment that is free from recognized hazards like these.

The best way to get ahead of workplace violence is to talk about it. Educate workers on the company's reporting structure for these incidents. Take proactive measures like conducting a risk assessment of the workplace and inform workers of what was identified. Then, do a toolbox talk on workplace violence (both in general and how it applies within your company). This will start a discussion and open the door for managers to do employee check-ins while educating employees on what they can do if they encounter workplace violence.

Worker's Memorial Day

April 28th is Worker's Memorial Day (the National Day of Mourning)—chosen partly because it's the anniversary of the day the Occupational Safety and Health Administration was founded—when lives lost to workplace violence and other fatalities, injuries or illnesses suffered due to occupational hazards are observed. If you want to combine your workplace violence toolbox talk with the national day of mourning, it could offer an eye-opening way to shine a light on this very real problem.

Your April toolbox talk could include a real story (sadly, there are lots of stories online and in the news) of how someone lost their life in the workplace to provide perspective for workers who think it “won’t happen here”. At SafeStart, in addition to grieving the lives lost, we also celebrate the lives saved through our safety training. Since we will never know an exact number, we use industry benchmarks to determine how many fatalities were prevented because workers received safety training. It’s important to ensure those lives lost aren’t forgotten but equally as important to train workers so that similar fatalities do not occur in the future.

National Work Zone Awareness Week

One occupational hazard that often takes the lives of workers occurs because drivers are not obeying traffic laws through construction zones. National Work Zone Awareness Week is April 26–30, 2021. This awareness campaign is held at the start of construction season to encourage safe driving because we’ve all experienced frustration, rushing, fatigue and even complacency when driving through a construction work zone. This is another topic you could pair with a construction toolbox talk topic like worker’s memorial day or cover on its own.

World Health Day

One common theme you may have noticed in these toolbox talk topics is maintaining the health of workers. April 7 is World Health Day. This year, the focus is on building a fairer, healthier world. The COVID-19 pandemic has opened a lot of people’s eyes to some health precautions that had previously been overlooked. But if everyone works together, unnecessary injuries and illnesses can be avoided.

Use World Health Day as an opportunity to highlight your health and safety objectives within your organization. A toolbox talk in April can outline what you want workers to do to help reach those goals. At the end of the day, everyone wants to return home in the same state they arrived at work. To help achieve that goal, encourage discussions after toolbox talks to keep the momentum going and demonstrate to employees that they’re not just a number to the company.

Painter Safety

Painting involves several different areas of safety, from being aware of the chemicals you are using to being sure you are following the proper procedures for working at heights. Although it seems like a lot, if you remember the following tips you can avoid negative consequences of painting.

PAINT SAFETY

If paint is not handled correctly, it can cause health problems, such as:

- Drowsiness
- Dizziness
- Nausea
- Dermatitis
- Internal organ and nerve damage

To avoid these problems, remember:

- Always consult the Material Data Safety Sheet (MSDS) or the instructions for the paint you are using.
 - Be especially aware of what is and isn't safe to mix.
- Close the lids tightly when you are finished with the paint.
- Only buy as much paint as you need at a time.
- If you do have paint leftover after you finish a project, do not store it near heat or ignition sources.
- Wear the proper Personal Protective Equipment such as goggles and gloves, and even respirators if necessary.

WORKING AT HEIGHTS

Many painting jobs involve heights. When working at great heights, always follow the rules for using scaffolds, remember to use proper fall protection, and don't forget to inspect your equipment.

If you are using a ladder, remember:

- Stay away from power lines if you can.
 - If you must work around power lines, do NOT use an aluminum ladder (use a fiberglass ladder instead).
- Be sure you set the ladder at a safe angle.
- Keep the ladder free of paint, mud, or anything else that will cause it to be slippery.
- Do not overreach while you are on the ladder.
 - A good rule of thumb is to make sure your left shoulder doesn't pass the right side of the ladder, and vice versa.
- Be sure you always have three points in contact with the ladder to avoid falling.

◦ "Three points" means at least two feet and a hand, or two hands and a foot.

PAINTING AREA SAFETY

Preparing the environment for painting may be hazardous to your health as well. For example, the old paint you remove before you put the new paint on may be composed of lead, or you could accidentally scrape a wall that contains asbestos. Therefore, remember to wear proper protective clothing, such as coveralls and a respirator or use controlled sanding procedures if you will be exposed to the hazards.

GENERAL TIPS

- Keep unauthorized people and pets away from painting.
- If you are working inside, be sure you have proper ventilation while painting.
- Do not use flammable materials, such as gasoline, to clean your brushes.
 - Always follow your company's procedures for cleanup.
- Rotate tasks throughout the day so you do not overstrain yourself.

Sonoma County increases Living Wage to \$17.65 an hour starting July 1

County of Sonoma

The Sonoma County Board of Supervisors voted unanimously today to raise the county's Living Wage an additional 2.26 percent to \$17.65 an hour, effective July 1.

The increase – the second approved by the Board of Supervisors in three months – is designed to help shield low-wage workers from inflationary pressures that have sharply driven up the price of consumer goods and services over the last two years.

On Dec. 6, 2022, the Board raised the Living Wage to \$17.25 an hour, effective Jan. 1. The 2.74 percent hike matched the cost-of-living adjustment granted to county employees in 2022. At the same time, the Board agreed to consider a second increase in the Living Wage this spring, noting that consumer prices had increased 6 percent over the last year (U.S. Labor Department's consumer price index for all urban consumers, October 2022).

Today's action, combined with the Board's decision in December, will increase the Living Wage by 5 percent this year, matching the cost-of-living adjustment currently proposed to members of Service Employees' International Union Local 1021, the county's largest union.

"Low-wage workers are hurt most by inflation, which erodes their ability to purchase food, shelter, clothing, transportation and other basics," said Supervisor Chris Coursey, chair of the Board of Supervisors. "That's why the Board promised in December to reexamine our Living Wage this spring and consider a second increase. By requiring the county and its contractors to boost wages for their lowest-paid workers, we are setting an example for other employers to match."

The Living Wage ordinance creates a baseline wage for individuals employed directly by the county government and workers in private companies and nonprofits that contract with the County of Sonoma. Most already earn more than the Living Wage hourly rate, but the ordinance ensures they are paid more than the state minimum wage, which rose to \$15.50 an hour on Jan. 1, 2023.

The increase will apply to all new county contracts on July 1 and expand to cover existing contracts on Sept. 30. It generally applies to private companies with six or more employees, if they supply \$25,000 annually or more in contracted services to the county, and to nonprofits that have 25 or more employees and supply more than \$50,000 annually in services to the county. The requirements also apply to entities that annually receive more than \$100,000 in economic development assistance. All county government suppliers must certify they have complied with the Living Wage ordinance during the contracting process.

Employers who contribute to workers' health care or retirement benefits receive a credit of \$1.50 off the hourly rate; employers who contribute to both health care and retirement benefits receive a credit of \$3 off the hourly rate.

The Board of Supervisors first approved a Living Wage ordinance in December 2015 as one way to combat poverty, initially setting the wage at \$15 an hour beginning in July 2016. It raised the wage to \$16.75 an hour in January 2022 and \$17.25 an hour in January 2023.

Four other Northern California counties — Marin, San Francisco, Santa Clara and Santa Cruz — have adopted a Living Wage ordinance, according to the UC Berkeley Labor Center. The cities of Sebastopol, Sonoma and Petaluma have also adopted Living Wage ordinances.

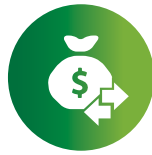

Construction employment increases in 45 states

Dive Brief

Construction employment increased in 45 states in February compared with a year ago, according to analysis of federal employment data by the Associated General Contractors of America.

Texas saw the largest number of jobs added, increasing by 37,900, or 5%, from February 2022 to February 2023. West Virginia saw the largest drop, losing 2,200 jobs, or 6.5%, over that time period.

From January to February, construction employment increased in 24 states, held steady in six and declined in 20 and Washington, D.C. “Unfavorable weather may have held back construction in many states last month compared to January,” said Ken Simonson, the AGC chief economist. “But construction employment continued to expand almost everywhere in February compared to a year ago, despite a slump in homebuilding.”

Dive Insight:

Most construction firms report trouble finding enough workers to keep pace with demand. Many contractors are opting not to bid on projects as a result, because they simply do not have the staffing to complete and deliver the work, according to AGC.

AGC officials have urged Congress and the Biden administration to increase funding for career and technical education and to open doors to permit foreign workers with construction experience to more easily enter the country legally.

The Department of Labor has recently announced initiatives to train and employ women and minorities — underrepresented groups in construction — so that they can find a strong career path and fill the gap in demand. The agency hopes the Infrastructure Investment and Jobs Act will create an opportunity for workers seeking good-paying jobs, who then realize their future in construction.

Nevertheless, the gap is wide. The IIJA will likely continue to push demand higher. Even as large infrastructure projects come to town, builders are competing over a small pool of staff for their work.

The Equal Employment Opportunity Commission, the nation's top enforcer of discrimination laws in the workplace, recently put construction on notice by calling out the industry by name in its proposed Strategic Enforcement Plan.

While it hasn't been formally adopted yet — the politics of an unfilled commissioner's seat have stalled it — observers say the document, which acts as the EEOC's five-year operating roadmap, has already set the tone and course of enforcement at the agency.

That certainly appears to be the case, given a string of EEOC lawsuits and settlements with construction firms since last May, when it held an exploratory hearing to investigate reports of discrimination and harassment in the sector. A recent JD Supra post highlighted at least eight construction-related cases the agency has pursued since that time, which have resulted in companies being on the hook for nearly \$3 million combined in damages and settlement charges.

Then, just last week, the EEOC announced a near-

ly \$2.7 million default judgment against Hanover, Maryland-based construction staffing firm Green JobWorks. The agency's suit against the company alleged it had refused to hire female workers for demolition and laborer positions because of their sex. Green JobWorks, whose website now appears to be defunct, could not be reached for comment.

Taken together, employment and construction lawyers say the writing is on the wall for an industry that is 85.9% male and 87.3% White, according to the Bureau of Labor Statistics, both overrepresentations compared to the broader labor force.

“It will be a busy several years for the construction industry,” said Cameron Hill, a construction and employment attorney in the Chattanooga, Tennessee, office of Baker Donelson. “Contractors should expect a more aggressive EEOC, more unannounced visits to project sites and more investigations and time spent answering questions, and, possibly, more litigation.”

So, what can contractors do to ensure they don't become the EEOC's next target? Lawyers say it all comes down to taking complaints seriously, training around discrimination and harassment, ensuring contracts spell out expectations for GCs and subs and making certain all stakeholders carry enough employment practice liability insurance to cover any potential claims.

That last point is important, since the EEOC's increased focus on the industry will likely lead to a higher awareness of the rules among employees themselves.

“As employees gain knowledge over the next few years about what the EEOC is doing, that could lead to increased litigation as well,” Hill said.

Avoiding retaliation

Lawyers say there is a common pattern in these types of discrimination cases:

- Someone does or says something inappropriate at a jobsite.
- The target of that behavior complains to a supervisor.
- Shortly after complaining, the worker is terminated.
- The former employee sues.

“The fact pattern that keeps me up at night is the retaliation in these cases,” said Kevin Carr, an employment lawyer in Jacksonville, Florida, with Spilman Thomas & Battle. “Not all jurors can relate to being discriminated against, but all jurors understand the idea of being able to complain to their boss without getting fired. Retaliation is one of those things where the coverup can be worse than the crime.”

To avoid falling into that pattern, employers should have multiple channels for filing complaints, and those channels should include individuals other than direct supervisors.

“I like having diversity of individuals identified as people to whom you can report throughout the organization,” Carr said. “Ideally, there would be people of color and different genders, someone young, someone older. But there should be more than just one person.”

When those complaints are fielded, companies need to take them seriously and follow a set policy to investigate them, lawyers say.

Training first

Lessening the chances of becoming a discrimination target hinges on training. Tool talks and sessions about appropriate behavior on the jobsite should now be a given, lawyers say. Indeed, some states, such as New York, already require mandatory sexual harassment training.

But supervisors at all levels of the company also need heightened awareness, direction and training around what to do when a complaint arises.

“Employee handbooks are great, but they aren't worth the paper they're written on unless managers are trained to adhere to those policies and practices,” said Jeff Daitz, a partner and co-chair of the labor and employment law group at Hall Booth Smith in Paramus, New Jersey. “Training can make the difference between liability or no liability in these cases.”

For example, Carr said one common Catch-22 that supervisors find themselves in is when an employee comes forward to lodge a complaint, but then backs away from wanting any action to be pursued.

"The worker comes to a supervisor and says, 'Hey, I don't want you to do anything, I just want you to know,'" Carr says. "Well, an untrained supervisor may not do anything with the complaint. That's a problem."

Instead, supervisors should tell the employee they'll keep the matter as confidential as possible, but that the company insists on a harassment- and discrimination-free environment. "They need to say, 'You've raised this issue, and I need to address it for you and others in the workplace,'" Carr said.

Taking that zero-tolerance approach when an issue comes up will also help contractors apply the policies they have in place consistently. "If you start selectively enforcing the policy, that's a red flag and that's where you're going to get yourself in trouble," said Joseph Herbert III, a partner and co-chair of the construction practice group at Hall Booth Smith.

Put it in writing

Beyond training, expectations should also be codified in contracts at all levels, ensuring there's uniform application for all stakeholders. "You want a contractual obligation for all parties to comply with that anti-harassment and antidiscrimination standpoint," Carr said. That includes mandatory notification requirements when an issue arises.

"A lot of the allegations I see against GCs don't necessarily involve a sin of commission, but rather a sin of omission," Carr said. "It's the situation where the general contractor knew, or should have known, but did nothing."

OSH Appeals Board Decision in Heat Illness Prevention Case Adds Clarity to Provision of Water Requirements

The Department of Industrial Relations' Occupational Safety and Health Appeals Board (OSHAB) has issued a precedential decision regarding the provision of water at outdoor worksites, affirming that it must be as close as practicable to the areas where employees are working to encourage frequent consumption.

"This decision provides clarity and should serve as a reminder that employers must take adequate steps to ensure that potable drinking water is as close as practicable to workers," said Cal/OSHA Chief Jeff Killip. "Staying adequately hydrated is essential to preventing heat illness, particularly during the hot summer months."

The case clarified the definition of what "as close as practicable" means with water placement at the workplace.

Cal/OSHA opened a complaint-initiated safety inspection at the Rios Farming Co. vineyard in St. Helena on August 6, 2018. Inspectors found some workers had to climb through multiple grape trellises to access drinking water. On January 7, 2019, Cal/OSHA cited Rios Farming Co. for a repeat-serious violation for not having water as close as practicable for their employees.

Rios Farming Co. appealed the citation and an administrative law judge affirmed the citation on October 12, 2022, with a modified penalty of \$27,000.

OSHAB issued its decision on February 6, 2023, which clarifies that the term "as close as practicable" in terms

of providing water to prevent heat illness means that the water must be as close as reasonably can be accomplished in order to encourage frequent water consumption. In this case, the ALJ found, and the OSHAB affirmed, that the trellises were an obstacle that discouraged employees from frequently drinking water. The ALJ and Board further found that other reasonable options were available to the employer, such as providing a jug of water in each row where the employees were working or providing individual water bottles that employees could carry with them and refill from the jugs.

The California Division of Occupational Safety and Health, or Cal/OSHA is a division with the Department of Industrial Relations that helps protect workers from health and safety hazards on the job in almost every workplace in California. Employers who have questions or want assistance with workplace health and safety programs can call Cal/OSHA's Consultation Services Branch at 800-963-9424.

Workers who have questions about their rights or have questions about workplace protections can call Cal/OSHA's Bilingual Call Center at 833-579-0927 to speak with a Cal/OSHA representative. Complaints about workplace safety and health hazards can be filed confidentially with Cal/OSHA district offices. 

Capitol Connection Q&A for Contractors

I will put out one ‘fire’ and kindle a second before I send another contractor to a higher power on a CA license question and wrap up in AZ. Here to help you answer your license issues, how can I help you? Got a question?

Q: I would like your help in pursuing a fire alarm license for myself, to be attached to my business. As you may recall, you helped me about 2 years ago to obtain my “C-16” (Fire Protection). I would like to now add fire alarm services for my business. My first question is, do you know if I should pursue a “C-7” (Low Voltage) license, a “C-10” (Electrical) license or both? Second, can I use my “C-16” experience to qualify for the electrical licenses? I’ve been working alongside electrical contractors while doing our fire protection installations.

A: For fire alarms, you would need the “C-10” (Electrical) license. The “C-7” Low Voltage classification specifically doesn’t include fire alarm installation. If you have at least four years of experience doing electrical work and you are comfortable passing the “C-10” exam, then you should be fine. We would be happy to help!

Q: I heard there was something that a Contractor can apply for with the CSLB to be able to collect more than 10% down on a home improvement project. Are you familiar with this?

A: What you are referring to is a Blanket Performance and Payment Bond. From what I understand, it is very difficult to qualify for, there are only a handful of licensees which have this attached to their license. Because they are so rare, I am not an expert on the requirements, but I believe your company needs to be a publicly traded entity and meet financial requirements as well. You’ll want to contact the CSLB for further information.

Q: We are a licensed flooring contractor in Arizona. We need to add a tile license as well. I spoke with someone at the AZ Registrar of Contractors, and they

informed me that if I were to hire another licensed Arizona tile contractor to act as our qualifying party, he/she would need to own at least 25% of our business. Is the same true if I were to hire a CA Licensed tile contractor to be our AZ qualifier?

A: If you were to hire a licensed CA Tile Contractor to be your AZ qualifier, he/she would not be required to own at least 25% of your company as long as they aren’t already licensed in AZ. Each State only has jurisdiction to place rules on ownership within its own State. If the individual is actively licensed in CA, they should qualify for a Waiver of the Trade exam, but they would still be required to take the online Statutes and Rules exam for AZ.

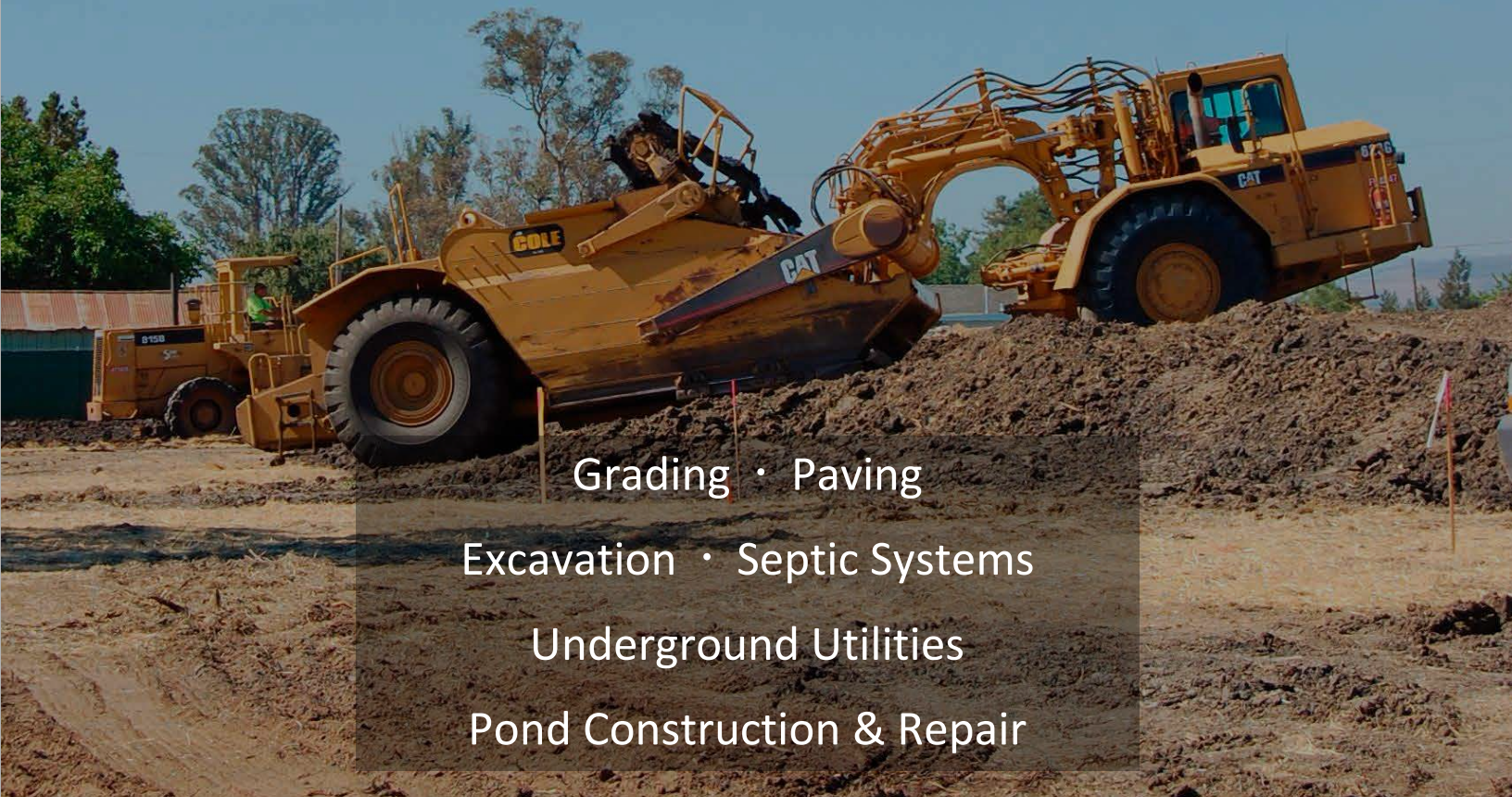
