## Companies Worry about Effect of Inflation on Employees' Well-Being

While many Americans are worried about the high rate of inflation, companies are also worried, albeit for a different reason.

A study released on July 12 from the Society for Human Resource Management (SHRM) Research Institute found that almost 73% of HR professionals reported similar concerns among their organizations—with the highest concentration being found in the industries of agriculture (97%), wholesale trade (95%), utilities and energy (82%), and manufacturing (82%).

“Employers recognize that inflation has a major impact on the well-being of their team,” said Johnny C. Taylor, Jr., SHRM CEO in a statement. “In fact, SHRM research found that 87% of those worried about inflation said their highest concern was the effect on the lives of their employees. But there is no one-size-fits-all approach to how organizations are handling the situation. While some employers are re-examining their strategy when it comes to pay, many others are unsure or not currently considering inflation as a factor in their annual pay raises, instead focusing on pay transparency, competitive compensation as well as the overall employee experience.”

HR professionals reported their organizations' plans for factoring in inflation when granting annual pay raises for 2022. Though the lives of their employees were cited as their greatest concern, more than half of the participants surveyed are either not considering inflation (26%) or are not sure if inflation will be factored into annual pay raises (2%).

Of those who were aware of their organizations' plans for annual pay raises, 63 percent reported that inflation is being considered or accounted for in annual pay raises.

### **Other Key Findings**

Concerns about inflation varied by organization size, with HR professionals in smaller organizations being more likely to be concerned:

- 81% of HR professionals in small organizations (less than 100 employees).
- 74% of HR professionals in medium organizations (100-499 employees).
- 67% of HR professionals in large organizations (500 or more employees).

Of those who indicated inflation was a concern at their organization, the highest concern was with how inflation would affect the lives of their employees:

- 87%: the lives of our employees.
- 70 %: customers and consumers.
- 61% suppliers and wholesale costs.

Small organizations were much more likely than large organizations to consider inflation for annual pay raises. Of the HR professionals who were aware of their companies' plans and reported that inflation is being considered in annual pay raises or accounted for based on standard cost of living adjustments:

- 76% were from small organizations
- 65% were from medium organizations
- 54% were from large organizations



## Keeping Teens Safe in Your Workplace

A tight labor market has companies employing younger workers, including teenagers, to fill open jobs. Keeping these young workers safe is part of the mission of the American Industrial Hygiene Association (AIAH). To create awareness of this issue AIAH has joined with The National Institute for Occupational Safety and Health (NIOSH) to create Safety Matters.

The program is a free, one-hour interactive teaching module and PowerPoint presentation targeted to students in grades 7 through 12, teaching students everything from how to identify hazards at work and predict how workers can be injured or made sick to how workers can communicate with others – including people in authority – when they feel unsafe or threatened.

“Recent statistics speak volumes about the risks posed to young workers and the need for proper education and training of these vulnerable workers,” says Lawrence D. Sloan, CEO of AIHA, in a statement. “For many teenagers, their first job is a rite of passage – a way to save money for college or a first car, while learning real-world work skills that they can

use throughout their career. Employers have a duty to protect young workers and adhere to local, state and federal child labor laws to keep them safe in the workplace.”

### High Injury Rate of Teens

By current estimates, approximately 1.6 million U.S. teens (aged 15-17) have jobs. Every nine minutes, a U.S. teen is injured on the job, and each year, on average, 59,800 workers under the age of 18 are sent to the emergency room for job-related injuries.

Even more alarming, 37 workers under the age of 18 die on the job every year on average. Parents can play a role in helping teenagers advocate for their safety on the job, including encouraging them to ask questions if they feel their health or safety could be at risk.

Teenagers should also be familiar with the laws in their state outlining how late at night teens can work during the school year, as being tired on the job can contribute to potential injuries.

“The best advice for young workers is to know your rights and not be afraid to speak up.”

## **Electrification is Coming for Mid-Size Fleets**

With the electric medium-duty vehicle market booming and sustainability deadlines looming, companies must keep a pulse on these four key industry trends throughout 2023.

Electrification is coming for mid-size fleets, but are businesses prepared? Looking ahead to 2023, the pressure is on, but so are incentives to help mitigate costs. Electric vehicle (EV) tax credits bolstered by the Inflation Reduction Act will be up for grabs; the United States will make strides toward its global commitment of 100% zero-emission medium duty truck sales by 2040; and Californians will gear up for the Advanced Clean Truck regulations to kick off, requiring manufacturers to sell an increasing percentage of zero-emission trucks starting in 2024. Immediately following will be Advanced Clean Fleet regulations, which will likely mandate all operating medium-duty trucks to be electric by 2035 and 50% of them by 2031.

All of these milestones underpin the electric commercial vehicle market's growth, expected to reach \$848 billion by 2030. In the years to come, businesses must prepare for the inevitable, freeing their fleets from fossil fuels. But without a clear path to electrification, many companies don't know where to start in the crowded and ever-changing industry, how to get up to speed on the unique planning needed for electric trucks or which technology solutions to hone in on.

As fleet managers and vendors start preparing in 2023 to navigate the pressures of quickly-approaching deadlines, they must focus on the following key industry changes to make their move to electric a seamless and successful transition.

### **Vendors are Essential for Securing Incentives**

Fleet managers already know how to shop for trucks, but electrifying them and their operating hubs is where the learning curve lies. Managers need help, and EV vendors have an opportunity to grow into true partners.

The 2031 deadline for California-based companies to replace half of their medium-duty commercial truck fossil-fueled engines makes EV fleet deployments mission-critical and highly sought after. To help businesses meet these requirements, California's Hybrid and Zero-Emission Truck and Bus Voucher Incentive Project (HVIP) provides point-of-sale vouchers

to make EVs more affordable.

However, application programs for incentives like HVIP and tax credits as part of the Inflation Reduction Act can be challenging to navigate on your own. That's where vendors can lend a helping hand, guiding customers to source funding programs, complete applications and receive incentives. In order to support customers and be a good partner throughout the voucher process, vendors should continually seek out new and revised funding opportunities to inform potential and current customers of new possibilities and guide them through each step of the application process.

Businesses need EVs to meet zero-emission fleet requirements and share in the ROI, but vendors have to expand their roles to pave the way. They have more experience with incentives, generally having already produced and sold vehicles under those programs, and must use that knowledge to take the onus off of customers. By helping customers with everything from incentives for purchase, to reliable charging infrastructure, to scaling customized EV fleets, vendors can walk hand-in-hand with the businesses at the helm of electrification to make the EV revolution a reality for all.

### **EV Fleets Will Serve as a Recruiting Tool**

According to the Economic Policy Institute, the shift to all-electric vehicles could create over 150,000 jobs by 2030. But it's not just about creating jobs – it's also about improving the quality of them. For drivers, these vehicles are their office, their sales storefront and their break room. Eight or more hours a day – every day. Imagine how much better their day can be when the truck isn't noisy, vibrating, baking with heat from its engine, and spewing unsafe fumes.

Electric trucks have proven to be key recruiting and retention tools for drivers. It's simply a more comfortable driving experience thanks to regenerative braking, which requires far less physical effort than the truck's foundation brakes. Also, the experience of being told to shut off one's vehicle during a delivery stop is a thing of the past. With help from trained fleet managers on route planning, charging, one-pedal driving, avoiding range anxiety, and safety awareness – drivers find electric trucks and vans are safer and more efficient.

Moving from diesel-powered ICE trucks to electric also provides a healthier experience. The Natural Resources Defense Council (NRDC) found that large amounts of diesel exhaust can accumulate inside truck cabs from the driver’s own engine, surrounding trucks and crowded port environments. Inhaling these pollutants for hours at a time has serious health consequences. Once most drivers get in the electric truck – they don’t want to return to fossil fuels.

Driver feedback for electric trucks has been through the roof, and managers must consider the business value they can bring. For companies looking to hire drivers in the new year, EV fleets will serve as a core recruiting tool.

### **Battery and Technology Innovation Will Increase Weight Options**

Medium-duty trucks have been long overlooked, even though they’re critical to powering the backbone of our economy. However, the restricted payloads and limited configurations of Class 3 lightweight vans can’t meet the last-mile delivery needs for many companies.

Given last-mile delivery makes up 53% of total shipping costs, it’s important to explore how all classes of EV trucks can work together to build a better supply chain. It is no surprise that the early last-mile EV innovation comes in Class 2 and Class 3 vehicles – they are easier to build and the technology is simpler when the total weight is only marginally higher than a passenger car or pickup truck.

As we move more into 2023, expect battery and technology innovation that increases payloads and driving ranges for Class 4-6 designs carrying 2-6 tons, even up to 200 miles per charge, which is enough for 95% of urban and suburban daily routes. The performance and utility of new medium-duty trucks is now greater than their gasoline and diesel counterparts, opening doors for a swarm of new fleets to go electric. According to the North American Council on Freight Efficiency (NACFE), electric trucks make sense for Class 3 through 6 now, especially in stable daily fleet routes, while the heavier Class 7 and 8 EVs are usable for a smaller percentage of their roles.

### **Overnight Level 2 Charging is not Dead Yet – or Ever**

Everyone wants quicker Level 3 chargers, but fail to consider the infrastructure and labor costs that come with 30-minute recharging compared to overnight charging. That's why commercial trucking fleets with routes that return to base every night, which includes most last-mile applications, will opt for Level 2 charging in most cases. Level 3 will be for supplemental charging only, unless the vehicle operation is over 14 hours per day.

Level 2 melds the driver lifestyle and most efficient charging techniques, providing cheaper infrastructure, no labor costs during charging and better battery life. In fact, McKinsey found that Level 2 chargers are considerably more affordable, ranging in cost from \$2,500-5,000, while Level 3 chargers cost anywhere from \$15,000 to more than \$40,000. In addition, spreading out the charging over time with Level 2 can lower infrastructure costs by up to 10 times for things like transformers and upgraded utility feeds.

Faster isn't always better (or cost-effective), which is why 2023 will see Level 2 charging remain the norm for commercial fleet depots.

With the electric medium-duty vehicle market booming and sustainability deadlines looming, companies must keep a pulse on these four key industry trends throughout 2023. ## Capitol Connection Q&A for Contractors

**In life as in contractor licenses, there is just one you! An untimely loss has prompted some questions we can all benefit from learning now. I also help clarify the sometimes misunderstood rules on business naming...**

**Q:** I understand there is a limit of three licenses in which Qualifier can be associated with at a given time. Does that limit of 3 follow the person, or the classification? For instance, if I'm John Doe and I have a "B" (General Building) and "C-39" (Roofing) qualification, can I have three licenses per classification, or does it follow the person?

**A:** It follows the individual. A qualifying person can only be on up to three licenses at a time, regardless of classifications, within a one-year period.

**Q:** My Father passed away last weekend. He has a Sole Proprietor license with projects in progress right now. Last year, we had started the process to transfer his personal license to a corporation which my wife and I are part owners in. Setting up the corporation was as far as we got. Now that he is no longer around, am I still able to get his license number in the corporation's name since I am a family member? What do we do about the projects currently in process? Am I permitted to finish them?

**A:** I'm so sorry for your loss. With regards to the current projects, you, as an immediate family member can request a continuance for his license. This must be received by the CSLB within 90 days of his passing. They'll give you a "reasonable amount of time" to continue work in progress and you can even take on new work during that time. At the same time, you can apply for your own license. If you are wanting to keep your dad's license number, you would be required to obtain the license as a Sole Proprietor, and then you can immediately transfer it to the corporation which you and your wife set up. Need more? Call me for further assistance.

**Q:** My brother-in-law is a "C-10" (Electrical) qualifier. He recently left the company he worked for, and he and I are going to start an electrical company. Does it matter what we name the business? He seems to remember the CSLB having an issue with his former Company's business name and there being some back and forth which delayed the licensing process. We don't want to run into any of that!

**A:** The CSLB is very particular about business names. Your business name of course cannot be misleading (i.e., you will not be able to call it "ABC Plumbing"), and it also cannot be too "general" such as "ABC Services" or "Systems Inc". Most anything with "Electrical", "Electric", "Power", "Controls", etc. in the name should work for a "C-10" contracting business. You'll want to check the business name with the CA Secretary of State as well to make sure it's available for use.

## CARBON DIOXIDE FIRE EXTINGUISHER

Carbon dioxide fire extinguishers extinguish fires by taking away the fire's oxygen and removing the heat with an extremely cold discharge. These should not be used by any employee unless they have been properly trained, and it is safe to operate.

### TYPES OF FIRES

The types of fires are listed below:

- Class A- Combustible materials (wood, paper, fabric, refuse)
- Class B- Flammable Liquids or gases, including gasoline, oil, grease, or acetone.
- Class C- Electrical Fires, Energized electrical equipment fires. (anything that is plugged in).
- Class D- Combustible metal fires.
- Class K- Fires that involve cooking oils, grease or animal fat

It is not recommended to use a carbon dioxide fire extinguisher on class A, D, or K fires. Carbon dioxide fire extinguishers either have little to no effect, or can react badly with these fires.

### USING FIRE EXTINGUISHERS

Certain safety related criteria should be met before using a fire extinguisher. This criteria includes, but is not limited to:

- Fire alarm is pulled and the building is evacuated.
- The fire department (911) has been called.
- The fire is small, contained and not spreading beyond its starting point.
- The exit is clear, no imminent danger present, you can fight a fire with your back to the exit.
- It is possible to stay low and avoid smoke.
- The proper extinguisher for the type of fire is immediately available.
- Employee has read instructions and knows how to use the extinguisher.
- When possible use the buddy system.

- Employees should not fight a fire if their personal safety is in doubt.

- Stand several feet from the fire and remember the following:

- o Sweep back and forth at the base of the fire until the fire is completely out.
- o The metal parts of these particular extinguishers can get dangerously cold.
- o Do not walk into an "extinguished area", the fire could reignite without warning.

### PROPER CARE AND MAINTENANCE

It is recommended to inspect the extinguisher at least once a month, while inspecting it should be ensured that:

- The extinguisher is centrally located and not blocked by any objects.
- The pressure is at the recommended level.
- The nozzle and other parts are not obstructed.
- The pin and tamper seal (if applicable) are intact.
- Extinguisher should be free of rust, dents, leaks and signs of wear and tear.
- Fire extinguishers should be pressure tested regularly, when in doubt consult the owner's manual.
- If the extinguisher needs to be recharged or has been damaged, it should be replaced immediately.

### CONCLUSION

The proper use, storage and handling of a carbon dioxide fire extinguisher is a vital element in a fire related emergency. Proper knowledge in the safe operation, and following these safe work practices will help to ensure employees safety.

4. The successful bidder shall comply with the provisions of the Labor Code pertaining to payment of the generally prevailing rate of wages and apprenticeships or other training programs. The Department of Industrial Relations has made available the general prevailing rate of per diem wages in the locality in which the work is to be performed for each craft, classification or type of worker needed to execute the contract, including employer payments for health and welfare, pension, vacation, apprenticeship and similar purposes. Copies of these prevailing rates are available to any interested party upon request and are online at <http://www.dir.ca.gov/DLSR>. The Contractor and all Subcontractors shall pay not less than the specified rates to all workers employed by them in the execution of the Contract. It is the Contractor's responsibility to determine any rate change.
5. The schedule of per diem wages is based upon a working day of eight hours. The rate for holiday and overtime work shall be at least time and one half.
6. The substitution of appropriate securities in lieu of retention amounts from progress payments in accordance with Public Contract Code §22300 is permitted.
