Cal/OSHA Turns Up The Heat on Employers - new indoor heat standards proposed

For almost 20 years, Cal/OSHA has distinguished itself from Federal OSHA by, among other things, its heat illness prevention standard that applies to employers with employees working outdoors. Taking it up a notch, in 2016, SB 1167 was signed into law, which required Cal/OSHA to submit a proposal to the Standards Board on employee protection from indoor heat hazards. Thus began Cal/OSHA's work on an indoor heat illness prevention standard, starting first with several advisory meetings, and several draft standards. On April 22, 2019, Cal/OSHA published what was then its latest draft standard, which we blogged about previously. However the normally slow standards-making process was slowed down even more when the COVID-19 pandemic hit. Nothing has happened on Cal/OSHA's proposed indoor heat standard for the past few years. Until now...

What's Required Under The Proposed Standard

Key requirements of the proposed indoor heat standard are:

- Applies to all indoor work areas where the temperature equals or exceeds 82 degrees Fahrenheit when employees are present.
- Enhanced requirements for indoor work areas where the temperature or heat index equals or exceeds 87 degrees Fahrenheit when employees are present; employees wear clothes that restrict heat removal and temperature equals or exceeds 82 degrees Fahrenheit; or employees work in a high radiant heat area and the temperature equals or exceeds 82 degrees Fahrenheit. One such requirement is to measure and record the temperature or heat index (which is greater) in these hot areas where employees work, and implement various controls measures, for example engineering controls to reduce the temperature or heat index or both. In lieu of measuring and recording, an employer can opt to simply assume a work area is subject the enhanced requirements.
- Allows compliance to be part of employer Injury Illness Prevention Programs, though employers can also choose to have a stand-alone written heat illness prevention program.
- Employees must have access to fresh, pure, suitably cool, and free water as close as practicable to working areas and in cool down areas.
- Employers must establish and maintain one or more cool down areas at all times, and encourage preventive cool-down breaks when employees feel the need.
- Employers must use control measures to minimize the risk of heat illness, such as personal heat-protective equipment, administrative controls, and engineering controls.
- Employers must have effective emergency response procedures.
- Employers must have close monitoring of newly assigned employees and during a heat wave.
- Employees must be trained on indoor heat illness prevention.

What's Next

The Standards Board has one year from publication date to take action on the proposed standard. The soonest the Board could adopt the standard is likely sometime in the summer or fall of 2023, though the regulatory process typically takes longer. While a formal codified heat illness standard may be months to (possibly) years away, California employers should keep in mind that in the absence of a heat illness standard, Cal/OSHA can and does enforce indoor heat hazards under the IIPP standard, under which employers must evaluate site-specific hazards at their workplace.

Workplace Solutions

Employers should stay on the lookout for updates to the indoor heat prevention rulemaking process, and in the interim, employers with hot indoor work areas should review their worksite hazard analyses and ensure that any indoor heat hazards are being controlled.

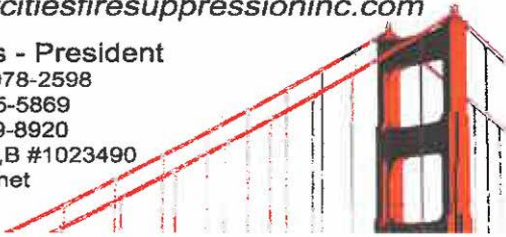

What's the Effect of Office Noise on Health?

Just how many decibels are conducive to healthy workplace?

The answer is 50 according to a new study recently published in the journal Nature Digital Medicine by Sudha Ram, professor of management information systems at the Eller College of Management at the University of Arizona.

The study – part of a larger workplace well-being research – suggests that if employers intend to build or redesign their office spaces with employee health and well-being in mind, they might want to consult acoustical engineers who can help them dial in conditions for good environmental sound, said Sternberg, who is also director of research for the UArizona Andrew Weil Center for Integrative Medicine and a member of the university's BIO5 Institute.

“Everybody knows that loud noise is stressful, and, in fact, extremely loud noise is harmful to your ear,” said study co-author Ester Sternberg, director of the UArizona Institute on Place, Wellbeing & Performance, in an article on the university's website. “But what was new about this is that with even low levels of sound – less than 50 decibels – the stress response is higher.”

The study's co-author, Karthik Srinivasan, an assistant professor at the University of Kansas, points out that, “when we think about well-being, typically we think about emotional or mental well-being. We hardly ever consider the physiological well-being or the actual ‘what's happening in our body,’ which is also important to understand when we're continuously exposed to environmental factors such as sound.”

The new study, which was part of Sternberg's larger research project – called Wellbuilt for Wellbeing – in partnership with the U.S. General Services Administration, determined the results after measuring the impact of sound on office workers who worked in four different buildings. Participants wore two devices for three days. One device, worn around the neck, measured sound levels in the person's work environment. Another, worn on the chest, measured participants' physiological stress and relaxation levels, using heart rate variability, or the varying lengths of time between each heartbeat.

Heart rate variability is a direct result of breathing so as a person inhales, his or her heart rate slightly increases, and it decreases as the person exhales,

causing variability between heartbeats. The researchers measured heart rate variability alongside environmental sound, then used mathematical modeling to determine how changing sound levels affect a person's physiological well-being.

The results showed that when a worker's environmental sound level was above 50 decibels, each 10-decibel increase was related to a 1.9% decrease in physiological well-being. But when office sound was lower than 50 decibels, each 10-decibel increase related to a 5.4% increase in physiological well-being.

Construction's labor gap could bring a hiring evolution

This year's spring construction season could see a change in how firms hire new workers.

Despite January data implying the demand for construction jobs was slowing, the number of open positions for which contractors were hiring grew again in February, according to a report from Associated Builders and Contractors.

So, contrary to how things looked earlier this year, construction's labor shortage remains elevated.

These renewed hiring numbers are an optimistic sign as the industry faces high interest rates, recession fears and "slow implementation of America's infrastructure rebuilding program," said Anirban Basu, ABC's chief economist.

Nevertheless, there simply aren't enough people available to fill those jobs. In fact, a large number of firms opt to not bid on some projects, as they do not have the staffing to deliver the work, according to the Associated General Contractors of America.

Contractors on the ground are seeing the same thing, and say that the industry has a healthy amount of projects, but little staff to deliver them.

"In North Texas we are extremely busy," said Keyan Zandy, CEO of the Skiles Group, a Richardson, Texas-based contractor primarily specializing in health-care projects.

Zandy said the shortage of experienced labor is obvious, as tradesworkers with five or more years on the job are increasingly rare. As construction's most experienced field workers retire, there's a lack of new blood stepping in to fill those spots.

"Our nation's builders, they have a strong project pipeline, they need a strong talent pipeline," said Fraser Patterson, founder and CEO of Skillit, a construction recruiting platform.

Economists and construction execs say that resolving that issue requires a massive shift in the way the industry finds, recruits and retains talent.

A potential return to self-perform "There's a huge amount of the craft workforce knowing its worth and expecting benefits commensurate," Patterson said. Skillit — which counts Brasfield & Gorrie, Haskell and JE Dunn among its clientele — has begun to see a shift toward workers who desire full-time, "W-2" positions, as opposed to seasonal or project-based work, he said.

"Ultimately the labor shortage means you either continue to rely on subcontracting ... or take control of your own destiny," Patterson told Construction Dive. Hiring more full-time tradesworkers is something Patterson said he sees major players doing in the near future.

OSHA steps up enforcement on infrastructure jobs

OSHA is ramping up its capacity to inspect infrastructure projects as federal Infrastructure Investment and Jobs Act money flows into the industry, said the agency's Directorate of Construction Director Scott Ketcham, according to New York City-based law firm Jackson Lewis.

The agency is increasingly focused on construction, and last year inspected construction workplaces more than any other industry. As federal funds flood into construction over the next seven years thanks to the IIJA, OSHA is concerned about protecting workers in the infrastructure sector in particular.

To empower smaller contractors and those new to infrastructure projects to build safely, OSHA also recently released a webpage of resources with best practices, sample safety and health programs and training materials.

OSHA plans to focus on roads, bridges, airports, rail, ports and power and water systems in the coming years, Ketcham said at an American Bar Association meeting in March. OSHA will also be promoting safety helmets and suicide prevention, since the suicide rate in construction is much higher than other industries.

Per Ketcham, the agency realizes that the infusion of federal money into construction will result in bids from smaller companies, which often lack the safety resources that larger and more established firms have. To help address this gap, OSHA developed the webpage to help less-resourced companies that will be working on infrastructure projects.

"This construction infrastructure safety and health webpage is intended to be a resource for contractors and other employers working on improving and building our nation's infrastructure," the website reads. "This is especially important for the critical work being undertaken through the Infrastructure Investment and Jobs Act."

The resource focuses on the four most common types of hazards in construction:

- Falls.
- Struck-by object hazards.
- Caught-in or between hazards.
- Electrocuting.

It also directs contractors to implement and integrate a written safety and health plan, and to engage workers in implementing it. The webpage also contains links to design safety, suicide prevention and many other resources.

OSHA taking action in construction

Ketcham said that OSHA has been issuing more willful citations for trench violations in particular because, most of the time, protective equipment is on site, just not being used. Last year the agency launched an enhanced enforcement initiative to protect workers from the hazard in response to an "alarming" increase in trench-related fatalities.

In addition, a new OSHA rule that took effect in March authorizes its regional administrators to issue new violation types as "instance-by-instance citations," meaning the agency can issue multiple citations for specific violations where it would have in the past only issued one. Repeat citations can now be issued for incidents surrounding lockout/tagout, machine guarding, permit-required confined spaces, respiratory protection, falls and trenches.

OSHA may soon get more resources to keep tabs on infrastructure builds. President Joe Biden's proposed fiscal year 2024 budget would increase the agency's funding by 17%, to \$738.7 million. As part of the increase, OSHA seeks to create 432 new full-time positions, a 21% increase from 2023's fiscal year plans.

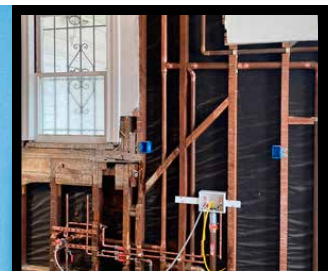

Tracking Worktime and Worksites for Remote Employees

At the outset of the COVID-19 pandemic, employers transitioned millions of employees to remote work. In many industries, the transition back to the office has been slow or nonexistent, drastically reducing the number of American workers who physically report to a jobsite or office each day to perform their jobs. Remote work implicates a broad spectrum of employment law issues, prompting the U.S. Department of Labor's Wage and Hour Division to issue recent guidance about how to accurately track non-exempt, remote employees' worktime and how to determine remote employees' worksite for purposes of Family and Medical Leave Act eligibility.

Tracking Worktime


The DOL's bulletin first addresses teleworking under the Fair Labor Standards Act and emphasizes the employer's obligation to pay nonexempt (hourly) employees for all the time they work each day. This includes compensation for breaks that last up to twenty minutes. The DOL explained that "such short breaks primarily benefit the employer by reducing employee fatigue and helping employees maintain focus and be more productive at work." Office employees typically spend such breaks using the restroom, making a coffee, eating a snack, taking a personal call, or catching up with coworkers. For remote employees, these breaks may be spent on various types of personal or household tasks such as starting or folding laundry, unloading the dishwasher, walking the dog, or beginning dinner. Businesses that track their remote employees' minutes worked and productivity through software or other technological means should be mindful that short breaks are compensable, even when employees spend those breaks performing nonwork tasks.


In contrast, breaks lasting longer than 20 minutes, such as meal breaks, are generally not compensable under the FLSA so long as the employee is completely relieved from all work duties during the break. To be uncompensated, employers must ensure employees are not interrupted with work during the breaks so that employees are able to effectively use such time for their own purposes. If an employer has reason to believe work is performed during an unpaid break (e.g., the employee answers frequent work calls or responds to work emails), the break time must be compensated as worktime. As a best practice, unpaid breaks should be scheduled so employees know when they are expected to return to work and that they will not be expected to perform any work until that specified time has arrived.

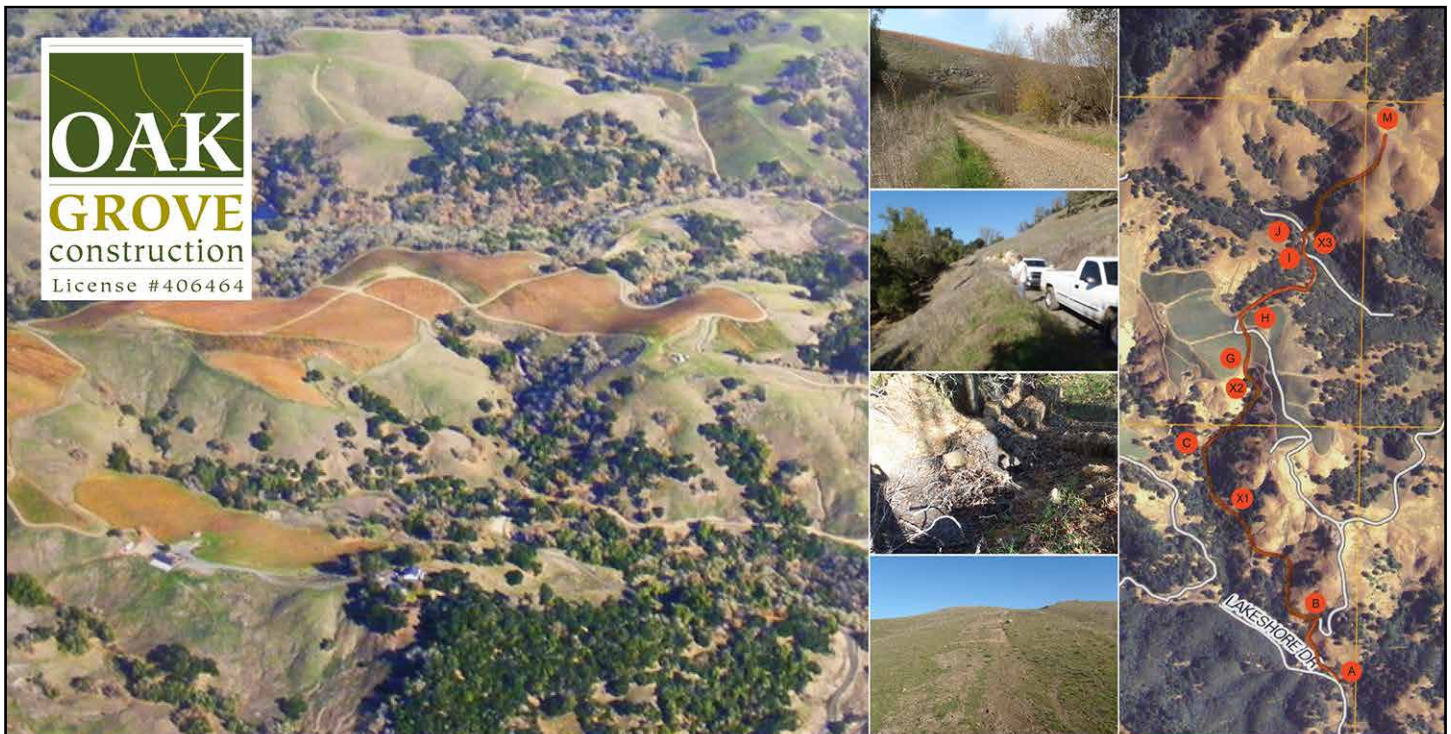

Employers should ensure they have a reasonable reporting procedure for employees to report if they ever work during non-scheduled time and must pay employees for all reported hours of work, even such hours that were not requested by the employer. Beyond the FLSA, employers should also review local and state employment laws for the locations where remote employees are physically working (i.e., their residences), which may require employees to be compensated for all breaks, including breaks lasting longer than 20 minutes.

Tracking Worksites

The DOL's bulletin also addresses how to determine a remote employee's worksite for purposes of FMLA eligibility. As a refresher, employees are generally entitled to FMLA leave once they have worked at least 12 months for the employer, worked 1,250 hours during the 12-month period immediately preceding the leave, and work at a worksite where the employer has at least 50 employees within 75 miles. A remote employee's worksite is not the employee's residence for purposes of determining FMLA eligibility. Instead, the worksite is the office

to which the remote worker reports or from which the remote worker's assignments are made. The DOL clarified, "[t]he count of employees within 75 miles of a worksite includes all employees whose worksite is within that area, including employees who telework and report to or receive assignments from that worksite." This means employers who have remote employees reporting to a worksite or receiving their assignments from a worksite must include those remote employees in their headcount when determining whether they have at least 50 employees within 75 miles for purposes of FMLA eligibility. Including remote employees in the calculation of the total number of employees at a worksite could greatly increase the number of employees who are eligible for FMLA leave in the company. This method of calculation also prevents employers from avoiding FMLA obligations by simply transitioning enough employees to remote work so that the total headcount at a physical worksite (and within 75 miles of it) falls below 50 employees.

- Follow the manufacturer's operating and servicing instructions.
- Never operate the machine from the outside of the cab.
- Elevate loads no higher than necessary.
- Avoid working or moving below elevated loads.
- If you must work beneath an elevated load, securely block it and do a hazard assessment to ensure the blocking will remain severe.
- Always wear a seat belt.
- Check your surrounding while operating a Bobcat to ensure your


safety and the safety of others around you.

- Make sure the bucket is lifted up a bit when moving the Bobcat

to avoid skidding on the ground, but not too high. The bucket should not disrupt your visibility.

- Do not make sharp turns or go up slopes with the bucket raised.
- Avoid steep or uneven slopes and navigate slopes with the heaviest part of the loader facing uphill. Go directly up or down slopes, not across.
- Make sure surrounding workers are aware of the dangers of working near loud and powerful equipment that has limited operator visibility.

Always wear the proper Personal Protective Equipment, (PPE), when operating a Bobcat. This would include safety footwear, hearing protection, high visibility shirt or vest, hard hat and sun protection, if required. (Sun screen, tinted safety glasses, etc.) A safety inspection should be conducted before using a Bobcat.

Falling behind: Don't ignore the role of technology in construction

Industrial organizations, particularly in the construction industry, have historically been slow to adopt technology. The consequences of this have been noticeable. McKinsey's Reinventing Construction report explains construction is considered the biggest industry in the world, representing 13% of the global GDP. Yet it's only seen a 1% increase in productivity growth in the last two decades. This costs the global economy \$1.3 trillion annually.

While many industries have been streamlined and improved by technological revolution, the construction space is characterized as more of an evolutionary industry where change typically happens gradually over time. The COVID-19 crisis, however, has forced many construction companies to dramatically increase technology adoption and think innovatively about how their work is done.

To shift through a technological revolution, companies need to do more than manage the gaps of remote work. They need to build innovation into their leadership—and that starts with hiring the right leaders in IT, digital innovation and information security to guide them.

Before we dive into hiring, let's look at the importance of tech in construction and just how much there is to gain by innovating.

Importance of Tech in Construction

In addition to productivity, one of the greatest benefits of innovation in construction is risk management and risk aversion. A recent Dodge Data and Analytics report found that nearly all contractors surveyed would like to digitally collect and analyze data on risk and safety, but more than one third don't currently do so. One reason for this is that only 19% of contractors actually have a budget available for data analytics.

Communication is another area that stands to benefit in a technological revolution. As Clearpath Solutions explains, *"Cloud computing has a strong appeal in the construction industry, with many benefits due to the constant change of workers and setup of new job site locations. Often, construction workers require access to company data to provide timely decision-making and reporting ability while working in the field."*

Labor shortages can also be addressed with the use of technology and digital solutions in construction. Tools like drones, robots and autonomous heavy equipment can all be used to support on-site staff and finish projects with fewer people involved, suggests ConstructionConnect. What's more, integrating more tech can improve safety training, recruitment and turnover.

The question is: How do you implement the tech needed to reap these benefits? It starts with a goals-based technology vision, which 90% of the top 20% most innovative construction firms have developed, according to the Global Construction Survey of 2019. On the other hand, just 24% of the companies that fall into the lowest 20% for innovation have a technology vision.

Construction companies need experienced technology leaders to cast that vision, whether they come from within the industry or not.

Different Roles to Consider

When looking to hire someone to jump-start innovation in your organization, it's important to consider what your company needs, and which person can best fill that gap. As such, there are a few key roles to consider.

Chief Security Officer (CSO): Oversees the building and management of secure infrastructure, needed to manage the private company and customer data in our newly remote and continually evolving digital world.

Chief Technology Officer (CTO): Oversees the business and development end of technology implementation and management.

Construction Technologist (CT): Oversees various aspects of tech implementation and management, specializing in tech implementation in the construction industry.

Chief Digital & Innovation Officer (CDIO): Oversees the digital innovation and transformation of the company's products and services and the adoption of digital technologies across the business.

Capitol Connection Q&A for Contractors

First, a nod to knowing with an expert solution to share with all contractors. When it comes to fingerprinting once is not enough for some...

Q: If I am an RME for a company in CA, can I also be a Responsible Managing Employee (RME) for a different company in AZ? I know California only allows RME's to be one license at a time. Does Arizona have the same requirement?

A: Arizona has the same rule regarding common ownership being a pre-requisite for qualifying multiple companies at the same time. However, each State only has jurisdiction over their own State, and they don't have the authority to tell you what licenses you can be on in another State. Therefore, you can be the RME for one company in CA, and at the same time be the qualifying party for a different company in AZ (AZ doesn't use the term "RME").

Q: We currently have a "C-10" (Electrical) license. We install EV charging stations. Our attorney has raised some concern when he was reviewing our contracts about the concrete part of our jobs. We subcontract the work for the trenching but then fill in the holes with concrete and install the charging system. Do we need a concrete license in addition to our "C-10" license?

A: The "C-10" is proper/sufficient for installing EV charging systems. The trenching, backfilling, and surfacing is all incidental and supplemental to the overall EV charger installation. With the Electrical, all of the work involved in the EV charger installation can be self-performed or sub-contracted to properly licensed contractors.

Q: We need to add a couple of Officers to our license to give them signing authority. Both of the Officers reside in Illinois. Do they have to get fingerprinted with hard copy cards locally, or will they have the option to come to CA and do live scan? Additionally, one of our Officers has been fingerprinted before through the DOJ I believe for other licenses. To confirm, will he need to complete another fingerprint for CSLB or are the prints

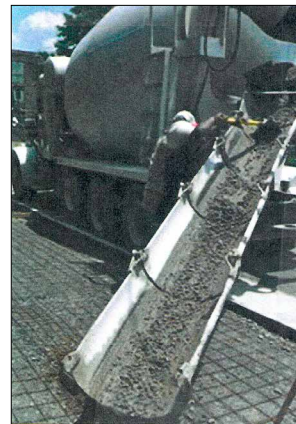
reciprocating through the FBI/DOJ?

A: The first step to getting fingerprinted is getting the applications to add them to the license submitted to the CSLB. The Officers cannot fingerprint ahead of time, they have to wait for the forms from the CSLB once the applications have been approved. When the CSLB sends them the fingerprint packet, they will include both options for live scan in CA or hard copy cards locally. Unless the individuals have specifically been fingerprinted for the CSLB, they will need to be printed again. Fingerprint results are not transferable from one requesting agency to another.
