



Cal/OSHA Proposes Indoor Heat Illness Prevention Standard

Cal/OSHA recently published the official draft version of an indoor heat illness prevention standard.

There are already heat illness regulations applicable to outdoor places of employment, and the new proposed regulation would apply to indoor places of employment when the temperature reaches at least 82 degrees Fahrenheit when employees are present.

The regulation will apply to indoor workplaces where the temperature is at least 82°F.

Employers subject to the standard will be required to establish, implement and maintain an effective heat illness prevention plan, including the provision of water, shade, acclimation for newly assigned employees, emergency response procedures, and control measures to minimize the risk of heat illness.

Market uncertainty splits construction into ‘haves and have-nots’

Dodge’s Richard Branch talks with Construction Dive about recent banking turmoil, industry bifurcation and standout sectors in 2023.

Construction starts continue to boom across the country, but economic headwinds soon could put a damper on the industry, according to Richard Branch, chief economist at Dodge Construction Network. In fact, Branch said starts are “likely to erode” as the year progresses due to heightened lending standards caused by banking uncertainty. But while this recent uncertainty among lenders could make projects fail to pencil, construction start data has yet to show a pullback.

Instead, total construction starts jumped 19% in March, according to Dodge. The reading has now posted two consecutive months of growth, predominantly due to a boom in manufacturing construction.

Here, Branch talks with Construction Dive about the effects of banking uncertainty on construction, the bifurcation of the market and specific standout sectors in 2023.

CONSTRUCTION DIVE: Signs point to decreased construction activity as financing costs become too high even though starts still show growth. Do you share concern that banking uncertainty can eat into construction’s momentum?

RICHARD BRANCH: I think it’s far too early to see. Over time, tighter lending standards are going to eat away at momentum seen in the construction industry. I think though it’s too early to see it in the starts data.

We are, though, seeing it in our leading indicator of construction, the Dodge Momentum Index. That tracks nonresidential building projects when they first enter the planning queue. That’s been down the past couple of months.

Part of why that is down is owners and developers are realizing that financing projects is going to be much tougher as the year progresses. So, they’re just putting fewer and fewer projects into the planning queue. The translation there for starts is there’s a lag. So, over time as the year progresses, that’s just going to be another weight pushing construction starts lower throughout the year.

It’s a tough nut to crack because overall the U.S. financial system is in very solid shape. But lending standards are getting tighter as the economy starts to slow down and the Fed raises interest rates. But this is exactly what the Fed wants to happen. They want lending standards to get tightened. That will slow down the economy. That will start to eat into inflation. So from the Fed’s perspective, that’s exactly what they want.

What sectors do you think will grow despite economic concerns?

The impact on construction is not going to be felt everywhere. It’s easily and quickly splitting into a market of haves and have-nots. I don’t think there’s going to be a lot of flat markets in 2023.

Where I think the offset happens to make the total market flat is in manufacturing, infrastructure, healthcare, life science buildings and data centers. That's the positive side of the market offsetting the declines that we're expecting to see in commercial and residential.

We're not going to see an impact on manufacturing and infrastructure just because there's so many public dollars sitting in the queue from the CHIPS Act, the Inflation Reduction Act and the Infrastructure Investment and Jobs Act. That should keep that momentum very positive in those verticals.

You mention that construction activity in certain real estate sectors such as retail, warehouses, offices and hotels, is set to decrease. What are some specific verticals there you're keeping an eye on?

The first one would be traditional office buildings. They were already at risk of a downturn because of increased work-from-home and hybrid relationships. Now you add increased lending standards, that's just going to weigh more and more on traditional office construction.

Warehouse construction is also headed lower, although I would view that more as a structural decline as opposed to a cyclical decline. What I mean with a structural decline is because one major player is getting out of the industry — that's Amazon saying that we're not building warehouses anymore. They're a significant chunk of that sector. So when they step away, warehouse construction will move quite a bit lower.

Third would be multifamily construction. The multifamily sector will feel a bit of pain this year, mostly because of a weakening employment picture, then we add in tightening financial standards for potentially less investment into the multifamily market. That should weigh heavily on multifamily starts this year.

Those are the most at risk, those are going to be down. There's no doubt about it.

Goldman Sachs and J.P. Morgan recently asked their employees to return to the office for a full five days a week. A panel discussion during the 2023 New York Build Conference indicated the office sector is beginning to show signs of life. Is that recovery in the office sector something you're expecting?

I think office construction is going to continue to struggle.

If you look at data sources like Kastle Systems, they do those keycard access readings, in the top 10 markets, they're reporting that only 50% of workers are back in the office. That hasn't moved up or down. It's been flatlined.

A fire needs three elements: fuel, oxygen, and an ignition source. Therefore, if you can control one of the elements, you can prevent an unwanted fire from starting in your workplace.

HOW TO IDENTIFY IGNITION SOURCES

An ignition source is any process or event capable of causing a fire or explosion. To prevent a fire or explosion, identify ignition sources in your workplace so you can be aware of them and control them. Look for:

- Radiant bar or open flame fires/heaters
- Heat sources (i.e. lamps) near combustible materials
- Multi-point adaptors or trailing socket extension leads used in conjunction with electrical sockets and appliances
- Known faults in electrical circuits
- Evidence of smoking
- Open flames (including candles)
- Evidence of “Near Misses” on the walls or electrical sockets
 - o Burns
 - o Discolorations
 - o Scorch Marks

COMMON IGNITION SOURCES

Some common ignition sources include, but are not limited to:

- Electrical equipment
- Internal combustion engines
- Metal tools striking metal surfaces
- Spark-producing equipment
- Static Electricity
- Friction from machinery bearings and drive belts
- Chemical reactions
 - o Be especially aware of the auto-ignite temperature of flammable and combustible materials
- Hot surfaces and the obstruction of equipment ventilation (i.e. copy machines)
- Hot processes (i.e. welding, cutting, or grinding)
- Faulty electrical installations
- Temporary or permanent cooking facilities



CONTROLLING IGNITION SOURCES

Once you have identified the ignition sources in your workplace, you need to take steps to be sure they do not combine with fuel and start a fire:

- Keep ignition sources as far away from fuel as you can
 - Eliminate all nonessential ignition sources where flammable liquids are used or stored
- Keep flammable and combustible materials stored below their auto-ignite temperatures
- Use non-sparking tools when opening containers of flammable and combustible liquid
- Bond and ground your equipment to prevent static electricity discharge
- Do not use any ignition sources in areas with a flammable atmosphere
 - If an ignition source goes off in flammable atmosphere, an explosion is likely to result
- Only use equipment for the purpose it was intended
- Do NOT smoke in non-smoking areas

Working in the same place every day makes it easy to miss some hazards, but if you are aware of the types of ignition sources in your workplace and know to look for them, you will be able to

Work Schedules Look Different to Younger Workers

Figuring out strategies to accommodate younger workers entails being open to ways of working that are taking new directions.

One recent direction involves when employees want to work. While working at home has somewhat altered the exact working hours, work is still generally done around a 9-5. schedule.

Well according to a survey from Adobe which interviewed over 5,500 workers globally, the youngest generation of workers are three times more like to prefer logging into their laptops to work well into the night as compared to older generations, as reported on Yahoo Finance.

Only 6% of Boomers work from 6 p.m. to 3 a.m., while 26% of Gen Z likes working during these hours. Looking at millennials, 18% prefer after-hour working as does 13% of Gen X.

How important are these preferences? Well, 70% of the younger workers said they would quit their job in favor of one with more control over their schedule, according to the article.

Research from the study showed that currently, more than 50% of Gen Z workers plan to leave their companies because of time and productivity issues. Conversely for those who stay at companies schedule and location flexibility are at the top of the list.

As is the case with other preferences for younger workers, managers need to adjust the philosophy that it's not the hours that are important, as long as the work gets done. In an article on Fast, a couple of years ago, Robert Pozen, a senior lecturer at MIT Sloan School of Management and senior fellow at the Brookings Institution said that "People should spend real time figuring out what their goals, priorities, and objectives are, and agree on success metrics on how you can tell after a week or a month whether you have achieved those."

Collaboration on this is an excellent way to feed into the overall desire of younger workers to work in a collaborative environment. In a recent article from the Harvard Business Review, the authors note that helping Gen Z workers includes giving them room for autonomy. They say: "Gen Z seeks to make informed decisions on their own. They need room for experimentation to prove themselves. Thus, in order to keep them motivated, flex your management style and give them greater room and autonomy to explore and figure out improvements in work processes. They might surprise you with a better outcome."

Evacuation Drills

In an emergency situation, evacuating employees out of a building poses unique challenges. Appropriate exits, emergency lighting, communication systems, alarms and sprinkler systems are critical for employee safety. Emergency routes need to be developed, posted, and properly maintained to ensure easy accessibility in an emergency situation. Drills are a critical component of all emergency actions plans to ensure that emergency procedures are understood and followed by all occupants.

Evacuation Drills

- o Ensure your emergency action plan addresses all emergency situations. Know when to evacuate, and when not to... such as during weather-related emergencies or earthquakes.
- o Identify and train Floor Emergency Evacuation Coordinators who will be responsible for sounding the alarms and organizing the evacuation drills.
- o Perform regularly scheduled evacuation drills, make needed improvements to the plan, and document these events.
- o All employees shall follow evacuation drill procedures professionally and evaluate for improvement.
- o Exit workstations in a calm and orderly manner. Use the evacuation map to determine the closest and safest route out of the building. Do not stay behind.
- o Determine a primary and secondary means of evacuation from the building so that, in the event of a real evacuation, you will know another way out if the first choice is blocked.

- o Identify the locations of workstations and equipment/furniture on the floor to make low visibility escape easier.
- o Recognize the sounds and signals of the emergency alarms. Report any malfunctioning alarms or emergency equipment immediately.
- o Perform a head count at the designated meeting location and ensure all personnel have safely exited the building.
- o Only re-enter when it is reported by the person in command that is safe to do so.

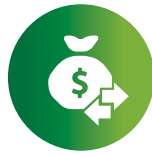

5 California ports pledge to build data-sharing system for cargo fluidity

Construction Dive

Dive Brief:

- Five of California’s largest ports have agreed to advance a data-sharing partnership to better coordinate freight movement and improve resilience.
- The ports of Los Angeles, Long Beach, Oakland, San Diego and Hueneme signed a Memorandum of Understanding on Wednesday to launch the California Port Data Partnership. Ports will now work to advance a cloud-based system aimed at standardizing data and boosting cargo fluidity.
- The data system will be funded through a \$27 million state grant. California earmarked \$1.2 billion for one-time freight and infrastructure projects as part of its state budget finalized last year.

Dive Insight:

The state partnership aims to break down data silos between ports and address the lack of visibility into cargo movement, one of the key drivers of supply chain chaos at West Coast ports in 2021.

“During this pandemic, we saw what happened when we did not prioritize this industry and the catastrophic effects that it has had on the supply chain,” Mike Gipson, a state representative for areas around the ports of Los Angeles and Long Beach, said at a press conference Wednesday.

The MOU outlines the framework for how a collaborative data system will be built. It includes 11 areas of cooperation, “ranging from developing data definitions to ensuring equitable access to data for users,” Dee Dee Myers, director of California’s business development agency GO-Biz, said in a release.

The \$27 million in funding will be split between the five ports as grants. Half of the grant funding was contingent on ports reaching an MOU defining how they will work to help achieve real-time interoperability, according to the state funding law.

The eventual system cannot track or monitor labor on metrics such as productivity, the law says. It also cannot be used to infringe on labor’s ability to collectively bargain with ports.

“Data was essential to navigating supply chain disruption,” Port of Los Angeles Executive Director Gene Seroka said in the release. “Analytics from that data allows us to see around corners, which is not just a competitive advantage, it’s now a public necessity.”

Construction starts ‘likely to erode,’ economist says

Construction Dive

Dive Brief:

• Total construction starts jumped 19% in March to a seasonally adjusted annual rate of \$1.09 trillion, according to Dodge Construction Network. The reading has now posted two consecutive months of gains, largely due to strong activity in the manufacturing sector, after a massive dropoff to start the year in January.

• For the first three months of the year, residential starts dropped 29%, while starts in nonresidential — such as commercial, institutional and manufacturing — and nonbuilding — such as highways, dams and power plants — increased 6% and 12%, respectively. During March, nonresidential starts rose 33%, nonbuilding starts increased 17% and residential starts climbed 5%.

• “Several large manufacturing projects are breaking ground, pushing nonresidential buildings higher, while a nascent recovery in single-family starts has been supporting residential growth,” said Richard Branch, Dodge chief economist. Nevertheless, starts are likely to erode as the year progresses, he said, as seen by the declining trend

in the Dodge Momentum Index, which tracks projects entering the earliest stages of planning.

Meanwhile, nonresidential building starts increased 33% in March to a seasonally adjusted rate of \$492 billion, predominantly led by manufacturing projects. Without these projects, total nonresidential starts would have inched up about 3%, according to the report.

Commercial starts, such as retail, warehouse, office, garage and hotel, rose 28%, while institutional starts improved 11% due to strong activity in the healthcare sector. The largest nonresidential building projects to break ground in March included:

- The \$5.5 billion Hyundai EV plant in Ellabell, Georgia.
- The \$3 billion Panasonic Energy North America Battery manufacturing plant in De Soto, Kansas.
- The \$780 million third phase of the BASF MDI chemical plant in Geismar, Louisiana.

Residential building starts increased 5% in March to a seasonally adjusted rate of \$335 billion. Single-family starts inched up 4%, while multifamily starts rose 8%, according to the report. The largest multifamily structures to break ground in March include:

- The \$268 million Knox mixed-use development in Dallas, Texas.
- The \$225 million Chestnut Commons Affordable Housing project in Cypress Hills, New York.

Shaky indicators linger

Starts are likely to lose momentum as the year goes on, especially since construction activity has yet to feel the impact of tightening financial conditions in the wake of the failure of Silicon Valley Bank and Signature Bank, said Branch.

The Dodge Momentum Index, a benchmark that measures nonresidential building planning, dropped 8.6% in March due to banking insecurity. The index typically leads actual construction activity spending by 12 months.

Overall commercial planning, such as office, warehouse, retail, office and hotel, dropped 6.6% in March. Institutional planning weakened too, as healthcare and education planning dropped 17% and 6%, re-

Additional Resources for Contractors Managing Treated Wood Waste

Smith Policy Group

Sacramento, CA – The Contractors State License Board has been advised of additional resources for contractors working with treated wood.

On behalf of the treated wood industry, the Western Wood Preservers Institute (WWPI) has geared outreach efforts toward California residents, businesses, contractors, landfills, transfer stations and waste haulers who are involved in treated wood waste (TWW) disposal. AB 332, which passed in 2021, required the wood preserving industry to work with state regulators to conduct educational outreach efforts on the handling and disposal requirements.

In spring 2022, WWPI launched the TWWDIsposal.org website to provide key information on disposal, including links to landfills authorized to accept treated wood waste. Thousands have accessed the site to learn how to identify treated wood waste and understand the requirements for handling, storage, labeling and transportation of treated wood waste. To enhance understanding of the regulations, the website is available in both English and Spanish-language versions. The website also includes guidance for contractors who may be generating or disposing treated wood waste.

Since last year, the City of Sacramento now offers treated wood waste disposal through its Household Junk Pickup Program, becoming the first city in the state to do so. Additionally, the re:source website serving Alameda County, Contra Costa County, and the City of Palo Alto now provide disposal locations that accept treated wood waste.

AB 1000 - A De Facto Ban on New Warehouses - Dies in Local Government Committee

Assembly Bill 1000 (Reyes; D-Colton), a de facto ban on warehouses, was heard by the Assembly Local Government Committee yesterday, where it failed to receive the required votes to pass through the committee. The bill ultimately received two aye votes and one no vote, with five committee members abstaining from the vote. Without sufficient votes to pass through committee, AB 1000 failed. The Committee Chair granted reconsideration making AB 1000 a two year bill, so while it has been defeated for the time-being, it's likely to resurface. AB 1748, authored by Assemblymember James Ramos (D-San Bernardino), passed through the Local Government Committee unanimously. This bill would establish a 300-foot setback requirement on warehouse developments or expansions with more than 400,000 sq. ft. of building space that are adjacent to sensitive receptors unless the local agency adopts alternative policies relating to industrial land use. AB 1748 only applies to Riverside and San Bernardino counties.

Construction Safety Week kicks off Monday

Construction Safety Week, the annual, weeklong campaign to raise awareness of the industry's commitment to a safe workplace, begins May 1 across jobsites in the U.S. and Canada. This year's theme — "Strong Voices, Safe Choices" — advocates for everyone in the workplace to feel empowered and confident in speaking up when they see potential safety hazards. 2023 Safety Week members include Hensel Phelps, Mortenson, Gilbane, Granite, Suffolk and Fluor, among various other construction firms. Consumer confidence drops to lowest point in 9 months

The Conference Board's consumer confidence index declined for the third time in four months and reached a nine-month low in April. Concerns about the economy's future appear to be growing, as the share of survey respondents planning to purchase vehicles and vacations fell to their lowest levels in months, and plans for household appliance purchases hit their lowest level since September 2011. Consumer outlook on present conditions improved slightly from March, but the six-

Labor Market remains Strong Despite Cuts Across Tech, Financial Industries

The Washington Post reported the US job market "has remained remarkably resilient" despite continued layoffs, with Meta, Whole Foods, Lyft, and Deloitte announcing job cuts this week. The losses "have been relatively contained within tech, financial services and housing," which "all saw ballooning growth during the pandemic and are now struggling to readjust." The rest of the market is "extremely tight, with the unemployment rate holding strong at 3.5 percent in March, and many employers desperate to hire."

Federal Reserve Expected To Again Raise Rates Next Month But "Signal A Potential Pause"

Bloomberg reported the Federal Reserve is "on track to raise interest rates a quarter percentage point next month and signal a potential pause from the steepest hiking campaign in decades." Bloomberg reported that while "policymakers across the hawkish and dovish ends of the spectrum stress that inflation is still too high and the US central bank has more work to do," they are "also concern[ed] that fallout from recent bank failures will slow the economy."



Capitol Connection Q&A for Contractors

Righting wrongs like a superhero for contractors! Seriously, I also share important information that impacts contractors and consumers alike direct from the Board...

Q: I have over 35 years of plumbing experience, much of which was gained by working for the Union. I have been told that I will qualify for my own Contractors License (“C-36”) and I will not have to take the trade exam based on my many years of experience, but I may still be required to take the law exam. Is there any way to get the law exam waived?

A: I have some bad news for you, it sounds like you’ve received some incorrect information. You are not able to waive the CSLB exams based on experience alone. It certainly sounds like you have well over the required amount of work experience, but unfortunately, you’ll need to take both the law and trade exams.

Q: Does the CSLB allow for a Trust to be listed on a license if the Trust is the actual owner of the LLC?

A: Yes, that is permissible. If you list a Trust as the “Member” on the license, that also needs to be reflected on the Statement of Information filed with the CA Secretary of State (SOS) for the LLC. In addition, you will be required to provide documentation showing who the Trustee is and that individual will need to sign the license application paperwork.

A fast and loose false interpretation of law is being used in advertisements for solar to fool consumers and harm legitimate contractors according to the CSLB.

The Board is warning consumers around the state about misleading and possibly illegal advertisements being distributed by way of door flyers, door-to-door salespersons, and direct mail. The scams often resulting from these types of advertisements can be financially devastating to homeowners. ‘high-pressure sales tactics to convince homeowners to sign contracts for work they

may not be able to afford, or under the pretext there will be no cost to them.

The ads falsely imply that Senate Bill (SB) 100 requires the federal government and PG&E provide solar for consumers “with no out of pocket expense.”

SB 100 does not provide consumers with free solar.

Homeowners may lose thousands of dollars by entering into a contract for a solar system that is significantly overpriced, they cannot afford, or obtain a loan that pays the contractor directly for work that may not be performed or completed.

In response to this issue, CSLB recommends that consumers take the time to carefully research any contractor they consider hiring. They should check the contractor’s license status on the CSLB website and also get multiple bids for any work they are considering, ask contractors for references, and never agree to contractual or lending terms that are not in writing or they do not understand.

“Consumers need to be careful when considering any home improvement project, including solar installations,” said CSLB Registrar David Fogt.

Eyes open contractors as these scams also take work away from the good folks like my readers! You be the hero when you see it, share with CSLB, and win one for the community.
