CALIFORNIA ROOFING: FALL PROTECTION

Note: Fall protection requirements for Cal/OSHA may differ from those that are required by other State and Federal regulations.

INTRODUCTION

When roofing, there is the potential of falling from the roof either from the height or angle of the pitch of the roof. To help minimize the chances of a fall occurring while performing roofing tasks, you should use appropriate fall protection methods for the task being performed. In this lesson we will cover heights where fall protection should be used, definitions covering roofing construction, the different methods of fall protection, and what some methods of protection entail.

DEFINITIONS

Under Cal/OSHA, the following terms are defined as:

Eaves - The lowest edge of a sloped roof.

Grade - The lowest point of elevation of the finished surface of the ground, paving or sidewalk, within the area between the building and the property line, or when the property line is more than 5 feet from the building, between the building and a line 5 feet from the building.

Leading Edge - The edge of a floor, roof, or formwork for a floor or other walking/working surface (such as the deck) which changes location as additional floor, roof, decking, or formwork sections are placed, formed, or constructed. A leading edge is considered to be an “unprotected side and edge” during periods when it is not actively and continuously under construction.

Lower Levels - Those areas or surfaces to which an employee can fall. Such areas or surfaces include, but are not limited to, ground levels, floors, platforms, ramps, runways, excavations, pits, tanks, material, water, equipment, structures, or portions thereof.

Multiple-Unit Roof Coverings - Asphalt shingles, asbestos-cement shingles, standing-seam metal panels, shingle metal roofing, wood shakes and shingles, clay tile, concrete tile, slate or like materials.

Roof - The exterior surface on the top of a building. This does not include floors or formwork which, because a building has not been completed, temporarily become the top surface of a building.

Roof Slope - The incline angle of a roof surface, given as a ratio of the vertical rise to the horizontal run. For example, a 4:12 roof has 4 feet of vertical rise for 12 feet of horizontal run.

Roof Work - The loading and installation of roofing materials, including related insulation, sheet metal that is integral to the roofing system, and vapor barrier work, but not including the construction of the roof deck.

Single-Unit (Monolithic) Roof Coverings - Built-up roofing of asphalt or coal-tar pitch or like materials, and flat-seam metal roofing or like materials.

HEIGHTS

Under Cal/OSHA regulations, different sloped roofs have different heights at which fall protection should be used. These include:

- Slopes 0:12 to 4:12 (Single- Unit (Monolithic) Roof Coverings)
 - o Fall protection should be used when the height of the roof is more than 20 feet.
- Slopes greater than 4:12 (Single- Unit (Monolithic) Roof Coverings)
 - o Fall protection should be used when the height of the roof is more than 20 feet.

- Slopes 3:12 through 7:12 (New Production-Type Residential Construction)

- o Fall protection should be used when the eave height on a roof exceeds 15 feet above the grade or level below. Note: Under the personal fall protection regulation, Cal/OSHA says that personal fall arrest systems, personal fall restraint systems, or positioning devices should be used when working at 7 ½ feet or higher from the perimeter of a structure, unprotected sides and edges, leading edges, through shaftways and openings, sloped roof surfaces steeper than 7:12, or other sloped surfaces steeper than 40 degrees not otherwise adequately protected.

DIFFERENT METHODS OF FALL PROTECTION

Due to the work tasks that may be performed while roofing, there are many different methods of fall protection that can be used to help minimize the chances of a fall occurring. These methods include, but are not limited to:

- Warning lines
- Parapets
- Personal fall protection
- Catch Platforms
- Scaffolds Platforms
- Eave Barriers
- Standard railings and toeboards
- Roof Jack Systems

Please note that the above-mentioned methods can be used alone or in combination with each other depending on the factors of the jobsite.

FALL PROTECTION METHODS

Warning Lines

When using warning lines, they should consist of the following:

- Rope, wire, or similar material.
- Be Flagged with highly visible material that hangs from the warning lines.
- Flagging material should be hung on the warning lines at approximately 6-foot intervals.

- Warning lines should be installed 34 to 45 inches above the roof surface to warn people that they are approaching the edge of the roof.
- The line should have a minimum tensile strength of 500 pounds.
- Stanchions (portable or fixed) supporting the warning lines should be designed and installed to minimize tip over or displacement under normal working conditions.
- The line should be attached at each stanchion in such a way that pulling on one section of the line between stanchions will not result in slack being taken up in adjacent sections before the stanchion tips over.

Unless work must be performed at the roof edge, you should stay inside the warning line. Application of materials outside the warning lines should be supervised by a qualified person.

Personal Fall Protection

Personal fall arrest systems are one of the most common methods of fall protection used in the construction industry, including the roofing trade. This involves using a fall harness to tie yourself off to an anchorage point to either keep you from reaching the edge of the roof or arresting (i.e. stopping) your fall if you fall from the edge of the roof.

Personal fall arrest systems should be inspected prior to each use. Damaged or worn components of the system should be reported to your supervisor. You should NEVER wear a damaged harness or lanyard, or tie-off on a damaged anchorage point.

Roof Jack Systems

When a roof jack system is used, it should consist of the following:

- Constructed to fit the slop of the roof and be designed, fabricated, and installed in such a manner that it will sustain all expected loads.
- The supported plan should be positioned at some angle from perpendicular to the roof to horizontal.
- Spans between roof jacks should not exceed 10 feet.
- Wooden supporting members that span between jacks should be selected lumber or equivalent and be of at least 2-inch by 6-inch.
- Non-wood supporting members should be at least equivalent strength.

To conclude, while working on a roof could expose you to fall hazards, there are many different ways the potential for falling can be minimized. Depending on the roof and other factors, one or more methods of fall protection may be used. Fall protection can range from warning lines to roof jacking systems. If you have questions about your company's fall protection systems, please speak with your supervisor.

BOX CUTTER SAFETY

Box cutters are a simple, common tool used by employees in many industries, but they can also be dangerous. Employees who use box cutters at work need to stay focused and follow the safe work practices, no matter how many times they have used a box cutter before.

TYPES

There are many different types of box cutters, or utility knives, including:

- Fixed blade – blade is secured in one position.
- Retractable blade – blade can be withdrawn into the handle of the knife.
- Snap blade – blade sections snap off without having to open the tool to change blades.

SAFE WORK PRACTICES

Roughly 30 percent of all workplace injuries involve cuts or lacerations, and of those, about 70 percent are injuries to the hands or fingers. To avoid this, employees need to follow the appropriate safe work practices:

- Always wear cut-resistant gloves when using utility knives.
- Always use even pressure to cut in a direction away from your body.
- Use caution when opening since some utility knives can store extra blades in the handle.
- Never try to catch a cutting tool if you drop it.
- Replace dull blades as needed because sharp blades will reduce the

amount of tugging and pulling which could cause your hand to slip.

- o Always dispose of used blades in a puncture resistant container.

- Avoid distractions and keep your eyes on your work while using a box cutter.

- o If you are interrupted while using a box cutter, retract the blade (if possible) and set it down on a safe place.

- Always retract the blade or place your box cutter in the proper storage place when not in use.
- Pass box cutters handle-first with the blade retracted.
- o Never throw a box cutter to a coworker.

- Only use utility knives or box cutters for their intended purpose.
 - Make sure the object you are cutting is secured in place to prevent movement while cutting.
- When cutting, only extend the blade to the thickness needed to cut the material. This not only prevents damage to items inside the box, but also improves cutting leverage.
- Wear cut resistant gloves. Cut resistant gloves will not prevent all cuts from occurring, but will minimize the potential for injury when used properly.

Box cutters are extremely common and can be used perfectly safely if all of the safe work practices are followed. Make sure to pass it correctly, cut away from your body, and retract the blade before storing in order to protect yourself and others from lacerations.

BACKS AND LIFTING

Back injuries that result from lifting materials are one of the most common injuries that happen in the workplace. While completely eliminating the risk of back injuries from the workplace is nearly impossible, there are ways employees can minimize their chances of suffering a work-related back injury. In this lesson are some guidelines that employees can use to help minimize their chances of a back injury occurring when lifting materials.

COMMON BACK INJURIES ASSOCIATED WITH LIFTING

Common back injuries associated with lifting include:

- Sprains and strains
- Herniated disks
- Fractured vertebrae

COMMON CAUSES OF BACK INJURIES

Some of the common causes of back injuries include:

- Lifting materials that are too heavy or unstable.
- Lifting objects to or from places that are awkward to reach.
- Repetitive motions such as twisting, bending, reaching overhead or lifting.
- Working for long periods in a bent over or strained position.
- Falling.
- Tripping over debris.
- Wearing tool belts that are too heavy.
- Lifting or doing any physical labor when you haven't warmed up your muscles.

PROTECTING YOUR BACK

To aid in the protection of the back, employees should do the following when performing lifting tasks:

- Avoid lifting and bending whenever possible.
- Place objects where they are easy to access.
- Avoid placing objects on the floor when possible.
- When possible, use a dolly or forklift to lift objects instead of manual methods.
- If a manual lift must be performed, keep objects between your shoulder and waist.

- When possible, push an object rather than pull. Pulling puts more strain on the back muscles than pushing.
- Don't lift heavy loads. If you're straining under the weight of an object, then it is too heavy for you to lift alone.
- Make sure that you have enough room to lift safely before picking up an object.
- Know the destination of your load before picking it up.
- Avoid walking on slippery and uneven surfaces while carry objects.

PREVENTING BACK INJURIES

Employees should do the following to help prevent back injuries:

- Plan your move
 - o Ensure that the path you are going to take is clear of wet surfaces, obstacles and obstructions, and that there are no slopes.
- Size up the load
 - o Look at the location of the object. If the object is

overhead or on the ground, think about how you can safely reach it or how to get into a comfortable position to reach it.

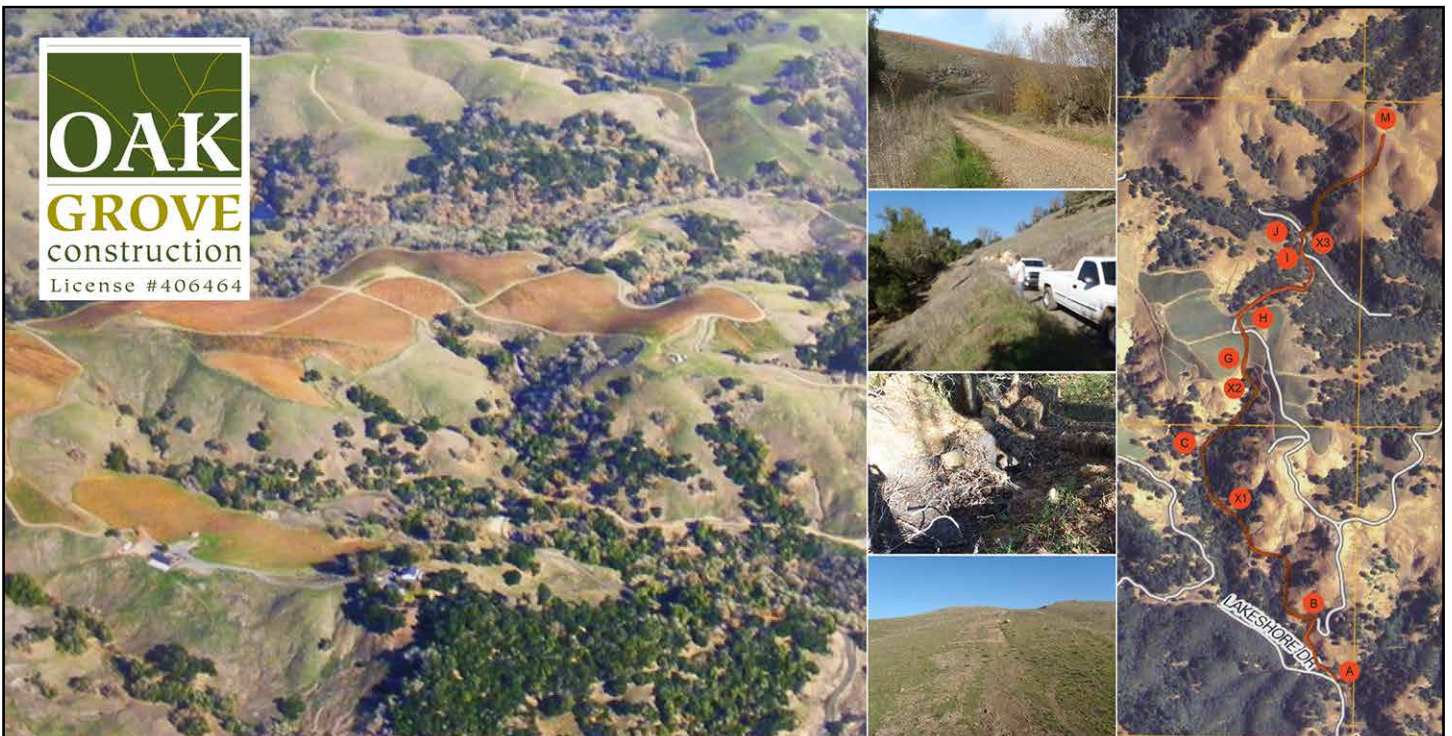
- o Test the weight of the object that you will pick up.
- o Test the object for shifting contents. Shifting contents can affect how the object will behave when lifted.

• Get help as needed

o Perform a team lift if the size or weight of the object is too much for you handle. Lifting awkwardly-shaped or sized objects can be just as dangerous as lifting heavy objects when you do it alone.

- If you have the option, use a dolly or other piece of material handling equipment over manual lifting methods.

LIFTING TECHNIQUE

When a manual lift must be performed, employees should use the following technique to minimize or eliminate the strain on the back:

- Get as close to the object as possible.
- Use a wide, balanced stance with one foot slightly ahead of the other with your heels on the floor.
- Bend your knees when lifting or lowering objects. This will help you keep the natural curve of your spine.
- Use your palms, not just your fingers, to grasp the load. It is recommended that you place your palms on opposite corners of the object.
- Keep your head up while lifting.
- Lift with a smooth, steady motion. Keep the object between your shoulders and waist area.

- Pivot to turn in the direction that you want to go. Do NOT twist.
- Slowly lower the load. Slow lowering will help maintain the curve of your lower back.
- When you have to get an object from above shoulder height, employees should lower the front portion so that it is below the shoulder.

Back injuries are one of the most common types of injuries in the workplace. By following the guidelines presented in this lesson, employees can help minimize their chances of a back injury from occurring while lifting or lowering objects. Employees should remember to use team lifts or mechanical methods of lifting whenever possible over manual methods.



ASPHALT LOADER AND SHOULDER MACHINE SAFETY

Asphalt loaders (also known as an asphalt miller) and shoulder machines are used to pave small trenches and road shoulders. Employees who operate or work near these machines must apply all of the safe work practices to avoid serious accidents or injury.

HAZARDS

By following the appropriate safety guidelines, employees can prevent:

- Respiratory irritation from inhaling asphalt vapors.
- Serious burns and eye damage from contact.
- Possible cancer from carcinogenic and suspected carcinogenic compounds in asphalt and asphalt vapors.

PERSONAL PROTECTIVE EQUIPMENT

Employees who work closely with hot asphalt must wear the following personal protective equipment, plus a respirator if asphalt fumes exceed the maximum permissible exposure limit of 5 mg/m³:

- Goggles or safety glasses
- Thermally insulated gloves
- Thick protective boots
- High visibility vests and hardhats
- Loose clothing with collars closed and cuffs buttoned at the wrist

SAFE WORK PRACTICES

The following safety guidelines must be followed at all times by employees who work with asphalt loaders and shoulder machines:

- Make sure all metal parts that carry or transport asphalt are clean, smooth, and free of holes.
- Before being loaded, asphalt loaders and shoulder machines must be cleaned of hardened asphalt and coated with a release agent to prevent asphalt from sticking to the Surfaces.
- Make sure the work area is clear of ditches, debris, overhead lines, or other obstacles that could affect operation before use.
- Asphalt loaders and shoulder machines should never be operated by one person alone.
 - Additional employees should be present to continually watch for obstacles as the machines move along.
- Asphalt loaders and shoulder machines should never be left unattended while they are on.
- Keep all ignition sources, sparks, and open flames away from hot asphalt.
- All employees who work with or near asphalt trucks must know where the nearest fire extinguisher is located.
- Employees must stay clear of all moving parts and wheels while working.
- When finished, make sure the asphalt loader and shoulder machines are emptied of all asphalt, turned off, and parked in their proper storage areas.

Asphalt loaders and shoulder machines make quick work of tedious tasks, but can be very dangerous if not operated properly. Employees must know the hazards involved, wear the appropriate personal protective equipment, and follow all safe work practices to protect

TREE WORK: CHAINSAW SAFETY

Operating a chainsaw can be hazardous. Each year approximately 36,000 people are treated in hospital emergency rooms for injuries from using chainsaws. Potential injuries can be minimized by using proper personal protective equipment and safe operating procedures.

PROTECTIVE MEASURES

Before starting a chainsaw:

- Check controls, chain tension, and all bolts and handles to ensure that they are functioning properly and that they are adjusted according to the manufacturer’s instructions.
- Make sure that the chain is always sharp and the oil tank is full.
- Use chainsaws that are equipped with a constant pressure control that will return the saw to idling speed when released.
- Chainsaws shall be equipped with a quick shutoff switch readily accessible to the operator.

Fueling a chainsaw:

- Never attempt to fuel a running or HOT chainsaw.
- Do not smoke while fueling a chainsaw.

Operating the chainsaw:

- Start the saw on the ground or on another firm support with the brake engaged.
- Keep your hands on the handles. Never operate a chainsaw with only one hand.
- Always cut at waist level or below to ensure that you maintain secure control over the chainsaw.
- The saw shall be stopped for all cleaning, refueling, adjustments, and repairs to the saw or engine.
- Tree workers shall use a second point of attachment such as a work-positioning lanyard or double-crotched rope when operating a chainsaw in a tree, unless the employer demonstrates that a greater hazard is posed by using a second point of attachment while operating chainsaws in that particular situation.

HAZARDS

Perform a hazard assessment of the work area before starting work.

TREE WORK: CHAINSAW SAFETY

- Look for nails, spikes or other metal in the tree before cutting.
- Avoid power lines (Adhere to CCR Section 3423 Tree Work: Electrical Hazards).
- Watch for branches under tension, they may spring out when cut.
- Kickback is a common cause of injury associated with chainsaws. Kickback occurs when the chain around the end of the bar contacts a hard object (such as a knothole) or when the teeth of the saw are pinched in the wood. This kicks the saw backward and upward, rapidly, where it can strike you.
- Never work alone. Make sure someone is close by for help in case of an emergency.
- Always be alert. Chainsaw work is strenuous and fatiguing.

PERSONAL PROTECTIVE EQUIPMENT

- Close-fitting, long-sleeved clothing that will not get hung up on tree limbs.
- Safety helmet
- Face shield
- Leather gloves
- Protective boots with slip-resistant soles.
- Leg protection. The material should be cut-resistant and cover the entire thigh to the top of each boot.
- Safety glasses must be worn at all times to protect your eyes from foreign objects.
- Hearing protection. Over time, you will lose your hearing if you are exposed to loud noises without protection.

FIRST AID

Treating Cuts

- Clean the area thoroughly and remove any debris that may be in the wound.
- Apply direct pressure to the wound using gauze or a clean, absorbent cloth until the bleeding stops. If blood seeps through the cloth, do not remove it; continue adding more gauze or cloth over the previous one. Seek medical care.
- If a limb has been amputated, elevate while applying direct pressure and call 911. Apply direct pressure over site(s) of heavy bleeding; this act may save lives!

CONCLUSION

Working with a chainsaw can be dangerous but the risks and possibilities of serious accidents may be minimized by following all appropriate safety measures and adhering to CCR Section 3425, Tree Work: Portable Power Hand Tools.

Capitol Connection Q&A for Contractors

Who's on first? As an expert I can tell you it depends on which states your working in. Another contractor's business is also 'moving' on. An 'explosive' inquiry, and for another contractor 'time' is of the essence. No matter where or when I can help ...

Q: We need to apply for a General Contractor's License in CA and AZ. Is it better to apply for one before the other, or at the same time, or what would you recommend?

A: I would recommend obtaining the CA license first and then apply for the AZ license second. Arizona allows the Qualifying Individual to Waive the trade portion of the exam if he/she has passed the equivalent exam in a "reciprocal" State and that individual has been actively licensed for just one day. You can certainly get the paperwork going for both at the same time, and just have the AZ documents on the back burner ready for submittal as soon as the CA license is issued. Let me know if you would like our assistance!

Q: Our LLC is currently a CA Limited Liability Company. We are considering changing domicile from CA to another State – rather than a CA LLC, it'll be a Delaware LLC or some other State. Obviously, it will still be registered to do business with the California's Secretary of State's office. Does changing domicile of our entity require any paperwork to be filed with the CSLB?

A: No. New paperwork would only be required if the change/conversion results in a new LLC Registration number with the Secretary of State, which it shouldn't.

Q: We will be changing our business name in our Home State, and therefore need to file an Amended Registration with the CA Secretary of State and also change the business name on our license. I know the Secretary of State filing must occur first, so I'm wondering how long a name-change application takes to be processed by the CSLB? We have a target date of 1-1-22 for the official new business name in each State we operate in.

A: The CSLB takes about three weeks to process name changes.

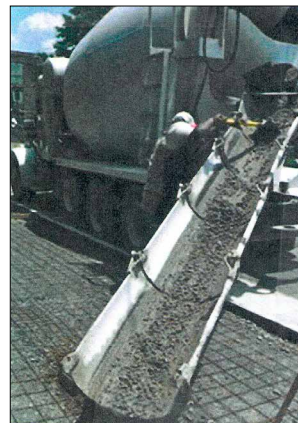
Q: Our company does highly specialized work and we are being asked to come into California and do the work for a large telecommunications company. I need to know what type of license we need as we are not familiar with the Contractor Licensing requirements in California. We drill large "holes" in the sides of mountains to run cables and such. Sometimes we use explosives. Would that be an "A" General Engineering Contractor's License?

A: The most appropriate license classification for the installation of electrical conduit would either be a "C-7" Low Voltage or a "C-10" Electrical license depending on the type of cabling or wire you are installing in the conduit. The method you use, such as explosives, would be considered incidental to the overall project. Let me know if you would like our assistance with the process.
