



Construction Workers at Increased Risk for Life-Threatening Lung Disease, Study Finds By Synclaire Cruel, Duke University

Construction trade workers are at significantly increased risk of developing occupational lung disease that involves a restrictive spirometry pattern (RSP) due to exposure from hazardous materials, according to a recently published study in the American Journal of Industrial Medicine. Restriction happens when the lungs become stiff after inhaling dust over time, which causes scarring that reduces the person's ability to breathe in.

The study and others like it could change the medical approach to these types of diseases and point to the need for more preventive measures for workers, said John Dement, PhD, professor emeritus in Duke's Occupational & Environmental Medicine Division in the Department of Family Medicine and Community Health, who led the study.

The researchers discovered that 28.6% of 18,145 participating construction workers developed RSP. Results showed those with RSP were at an increased risk of all-cause death, and death from cardiovascular disease, respiratory disease, and lung cancer.

"This is not just a disease of the lung that causes adverse effects. People are actually at increased risk of mortality because of this lung disease," Dement said.

Dement said the most surprising finding of the study was the high prevalence of RSP in this population and how strongly it's tied to construction jobs. Workers were classified into 16 different construction trade groups. Asbestos workers had the highest prevalence of RSP at 35.3%, followed by teamsters, which are truck drivers, at 32.9%, and boilermakers ranked third with a prevalence of 31.2%. Plumbers, steamfitters, and pipefitters ranked fifth at 29.0%, and electricians ranked seventh at 28.4%.

During this study, Dement and his team performed several cross-sectional analyses aimed at determining risk factors for RSP including how frequently construction trade workers performed tasks that exposed them to hazardous material. Construction workers experience frequent exposures to asbestos, silica (found in concrete), and welding fumes. Those are all substances known to cause interstitial lung diseases. "A lot of exposure that construction trade workers get, comes from the work that they're doing, but they're also in the vicinity of all this work being done, so they're also getting exposure from jobs they're not doing themselves," Dement said.

Dement has served as a member of the Department of Energy's Building Trade Program (BTMed) since 1997. The program provides services and occupational medical exams to construction workers who've worked at government-owned, contractor-led sites to detect health problems related to work. In his role, Dement primarily focused on providing the epidemiology, the statistical data analysis, and the industrial hygiene components of this program.

Dement said that one of the biggest risks for construction trade workers developing RSP is inhalation hazards, so the respiratory system is a major focal point of the exam. BTMed has conducted about 44,000 medical exams since its inception. They are performed by occupational medical nurses who gather a detailed work history, and demographic information like race, age, and gender.

A spirometry test is also conducted. It's a standard breathing test approved by the American Thoracic Society to determine whether there are any abnormalities. Nurses have a person breathe into a machine as deep as they can, then have them blow out as fast as they can to test for two things. First, the machine measures how much air is blown out in one second (FEV1). Dement said most people should be able to blow out 80% of their total lung capacity in that amount of time. Then the machine measures the total amount that's blown out, which is called the forced vital capacity (FVC).

Results are then compared to data from NHANES, the National Health and Examination Survey. That group is part of the CDC's National Center for Health Statistics that compiles data on the US population. That data is maintained by BTMed and is used for studies. Dement said they look at the data from a population-based perspective, rather than individually. "The important thing is the worker themselves during the exam, but when you back up and use that information to learn, 'okay this worker had an asbestos-related disease, and then we can ask well, do all these types of workers generally have an increased risk of asbestos-related disease by looking at the data in total," Dement said

The results from the spirometry test are then divided up into three different categories: obstruction, restriction, or a mix of obstruction and restriction. Workers with obstruction have blocked airways, similar to what happens in people with chronic obstructive pulmonary disease (COPD). Dement said this causes their FEV1 numbers to be lower during the test. While the lung volume is big enough for people in this category, they can't breathe out the air fast enough.

Restriction, which was the primary focus of this study, reduces lung volume, Dement said, which means a person can't take in as much air. "Some types of exposure, like asbestos, can also cause disease of the pleural space, which is the lining of the lung," he said. In workers exposed to asbestos, that can cause two things: the lining can thicken, which is called diffuse pleural thickening, or calcified plaque can develop, which is called pleural plaque. "The presence of this sort of encasing of the lung prevents the lung from expanding all the way," Dement said.

During the spirometry test, workers in the restrictive category display a very low FVC. "The lungs just can't expand to that volume in the prediction that's based on their age and other factors," Dement said. But, study authors found many of these workers actually have a combination of obstruction and restriction due to the different types of exposure.

Dement said the magnitude of the increased risk of death from RSP is surprising, especially for those in this mixed category. "Those people are really at increased risk of premature mortality due to all of the causes we looked at," Dement said.

The most common symptoms of RSP reported in workers were cough, phlegm, dyspnea, which is difficulty breathing, and wheezing. Majority of the study population worked in construction trades for an average of 21.5 years. The highest occurrence of RSP was found in those aged 60-69. The highest prevalence was found in former smokers at 29.9%, followed by current smokers at 26.8%. An increase in body mass index (BMI) was also observed in those with RSP.

Dement and the other authors are pushing for RSP to be added to the list of health effects documented among US nuclear weapons workers. He said that would make it easier for workers with RSP to receive compensation from the government. Currently, workers in the national occupational compensation program are given funds once it's been proven that a job caused an illness, effectively shortening the process. Restrictive impairment is not currently listed as a presumed illness but Dement said the additional classification would simplify the payout process.

Dement believes this study and others like it could change the medical approach to these types of illnesses. "As this body of information is gathered, and the relationships are established, then it translates more into prevention as opposed to trying to treat diseases," he said. Dement said eliminating exposures by substituting chemicals with less hazardous ones, and providing personal protective gear is a good way to start. "RSP is related to work, and construction workers are at least one group where we have established that increased risk, and there are more," he added.

Driving Forces Behind Employee Engagement & Retention Part One of a Two-part Series

Leap Solutions

Employee engagement and retention conversations often revolve around such topics as company culture, strong leadership, recognition, training and development, and perks. However, it is important to realize that first impressions are everything. Employee engagement and retention start before you hire an employee with the job description and the job posting and then move over into the application, interview, and onboarding processes. These steps are often overlooked; however, they are part of the foundation for employee engagement and retention. In this part one of a two-part series, we'll discuss the importance well-crafted job descriptions and job postings.

Job Description/Job Posting

A job description serves many purposes from outlining essential functions (to clarify expectations) to providing information on physical demands when someone is injured. Many managers utilize it after the hire as a compliance tool, when it can be used to increase the employees' experience of meaning and engagement in their work. This approach answers the question, "What's in it for me?" When written well, outcome-based job descriptions can help employees see greater meaning in their work, help them understand how they contribute value, help them feel empowered, and will highlight opportunities for career advancement.

A job description is typically the basis for a job posting. Externally posted job postings are important for attracting top talent. The first rule of thumb is to keep the job posting to a reasonable length. You do not want anything too long as many applicants are viewing and applying to the job posting on a mobile device. Make your posting engaging, easy to read, and share your organization's culture and values to stand out from the crowd. One way to make the role more descriptive is to speak to those who are in the role and have them describe what it is like to actually be in the role. Do not list only the technical specifications of the position; list what a day-in-the-life looks like so the candidate can imagine working for you.



Is Work Stress Affecting Our Home Lives?

EHS Today Staff

The answer to that question is yes, according to research from the Society for Human Resource Management (SHRM) 2023 State of Mental Health & Wellbeing in the Workplace Study.

Talking with over 1,000 workers between March 15 and March 28, many workers are "experiencing low energy and exhaustion at the end of the workday, affecting their capacity to participate in activities outside of work." Looking at the specific activities the survey found:

- One-third of the workers sampled in this study said it was difficult for them to unwind after work.
- 2 in 5 U.S. workers in the study said they avoid tasks that require high focus or concentration after work.
- Over 1 in 3 U.S. workers (38%) said they miss out on nonwork activities due to exhaustion from work.

And the numbers are somewhat surprising in that 47% say that they have little energy to participate in

nonwork activities.

These findings are a call to action for employers according to Wendi Safstrom SHRM Foundation president. "Employers have the opportunity to provide mental health resources and inclusive environments that support and encourage their employees in their work lives and beyond. This discussion is critical to understanding the existing gaps and how workplaces can be a change agent."

Treasury issues further guidance for clean energy manufacturing tax credit Diana DiGangi

Dive Brief:

- The Treasury Department and Department of Ener gy announced new guidance Wednesday for a 30% tax credit available under the Internal Revenue Code's section 48C for the construction of facilities that focus on clean energy manufacturing and recycling, industrial decarbonization and critical minerals processing.
- The 48C credit and related credit 45X are "very substantial," Moss Adams partner and certified public accountant Peter Henderson said in an interview, but "a lot of companies just aren't aware" of the two incentives.
- While 48C is a competitive investment tax credit that can only be claimed once, with total payouts capped at \$10 billion, the 45X manufacturing pro duction tax credit is not capped and can be claimed per each unit for instance, a \$3 credit per kilogram of solar-grade polysilicon produced in the U.S.

Dive Insight:

Under 45X, a mid-sized solar module manufacturing facility operating at a "fairly modest" production level of two gigawatts per year could generate an annual tax credit of \$140 million, Henderson said.

"A lot of companies just aren't specifically aware of these two incentives that, for manufacturing, are very substantial," he said. "One of the things that is kind of unique is that these incentives are technically complex, both from an accounting perspective, but also from an engineering perspective."

As a result, guidance is "absolutely needed here," Henderson said. "Anything related to tax, there are always situations that arise where it's not clear."

New guidance from the IRS clarifies and modifies the agency's Notice 2023-18 that established the 48C tax credit, while DOE's guidance advises companies on the submission of concept papers for facilities that might qualify for the credit. The department will open a 48C eXCHANGE portal for submissions no later than June 30, and submissions will be accepted through July 31.

Industry has been eager to see thorough guidance on the incentives included in the Inflation Reduction Act, which are a "gold mine of opportunity" and companies are "still digging" into the requirements for, Norton Rose Fulbright partner Keith Martin said during a February conference.

"One of the things about these incentives is that they really seem to be working for their intended purpose," Henderson said. "There's been a ton of press releases of companies that did not have operations onshore previously, or were previously building their products offshore, that are now establishing manufacturing operations here in the U.S. just to get a piece of these."

\$4 billion of the \$10 billion in 48C funding is "reserved for projects in communities with closed coal mines or retired coal-fired power plants," Treasury said. The first round of applicants will receive \$4 billion, with around \$1.6 billion reserved for projects in those communities.

The 45X credit can't be claimed for goods produced at a facility that received the 48C credit, requiring companies to choose between credits. For the most part, 45X is the "higher-dollar" credit, said Henderson.

"If eligible for both, the decision depends on the comparative significance of capital cost versus operating cost for the facility," DOE wrote in guidance about the two credits.

The 45X credit is a new one established by the IRA, while 48C was established previously "but has long since been depleted" and now has a "totally different process" for qualifying, Henderson said.

As 48C requires potential recipients to submit a concept paper and application for the proposed project to DOE, and will only pay out from a finite pool of \$10 billion, he said it's "more of a DOE grant that is effectively monetized in the form of a tax credit."

After companies submit their concept papers, they will receive a letter either "encouraging or discouraging" the submission of an application, the department's guidance says. Regardless of DOE's response, the decision of whether to apply is up to the company, and anyone who has submitted a concept paper will be eligible to submit an application.

Single-family rental construction more active than ever

Dive Brief:

- Over 14,500 new single-family rental homes were constructed across the country in 2022. This marks an all-time high, up 47% from 2021 and more than double the peak yearly construction rate before the COVID-19 pandemic, according to a new study from RentCafe.
- The trend shows no sign of slowing. Nearly 44,700 new build-to-rent homes defined in the study as horizontal apartment-style units in neighborhoods of 50 or more are underway across the country. Phoenix has the busiest pipeline with 5,500 build-to-rent homes under construction, followed by Dallas at 4,400 and Houston at 2,600.
- RentCafe attributes the surging growth of the BTR sector to the lifestyle changes brought on by the COVID-19 pandemic, including social distancing and working from home, as well as high housing prices and interest rates that make purchasing a difficult prospect.

Dive Insight:

The totals for new single-family build-to-rent homes delivered and under construction by the end of 2022 surged far ahead of the mid-year numbers that Yardi Matrix, RentCafe's parent company, recorded last August.

Eleven of the nation's major metros saw surges in new BTR home construction in the past five years, ranging from 100% to 700%. Charlotte, North Carolina, and Atlanta saw the steepest jumps, up from a few hundred five years ago to more than 1,300 and 1,800, respectively.

Phoenix has the largest build-to-rent housing inventory at 8,239, more than triple its count in 2018. The single-family home ownership market was hard hit by the housing crisis of 2008, after which institutional investors bought two-thirds of the homes that were no longer owner-occupied, about 20,000 units total, according to RentCafe. Now recovered, the region's population growth has created a high demand for rentals — both in build-to-rent communities and in formerly owner-occupied homes.

One byproduct of the work-from-home trend is the need or desire for more space. The average size of a BTR home rose by 2.6% in 2022, up to 1,361 square feet, or an estimated four bedrooms. Projects have also become larger and denser, according to RentCafe, averaging 130 units per property.





Occupancy for BTR units has risen slightly since the middle of last year, up to 97% — higher than the standard apartment occupancy rate at 95%. According to RentCafe, this speaks to the popularity of and demand for build-to-rent units among renters.

Many of the nation's largest single-family for-sale home builders are also getting in on the trend, dedicating a growing share of their yearly completions to single-family BTR projects. Twelve of the top 50 home builders in the country reported single-family rental homes in their closing numbers last year, led by No. 2 builder Lennar with 2,418 rental homes closed in 2022. They are:


While single-family rentals have proven an attractive investment option over the past several years, interest rate hikes have buffeted some of the transaction activity and rent growth in the space. However, because investors see safety in build-to-rent, the space should remain active, according to Adam Wolfson, CEO of Miami-based BTR developer Wolfson Development Co.

"Right now, I'm seeing both on the lending side and the equity side, the capital markets with respect to BTR are coming back," he said.





Capitol Connection Q&A for Contractors

Contractor license regulation can seem like a slippery slope. But don't expect they let anything 'slide'. A General finds themselves out 'classed', while another contractor discovers how deep the hole they've 'dug' is. Like the 'lifeguard' of complex rules, don't worry, I will throw them a 'lifesaver'...

Q: We have an employee that had a "C-33" license in California with his previous employer his disassociation date was 4/6/2018. If we apply for an exemption, would they let the 3 months slide you think?

A: Definitely not. The CSLB does not even let one day slide when it comes to the five-year rule. He will be required to take the law and trade exams again.

Q: Does a "B" (General Building) license allow you to self-perform certain trades without the actual classification or just allow you to be a prime and sub out trades you're not holding the classification for? More specifically, I'm wondering about the application of air and moisture barrier. We currently have a "B" and I'm wondering if we need to add the "C-33" or some other waterproofing specialty classification?

A: The "B" allows you to take a prime contract or a subcontract for a framing or carpentry project. However, a General Building contractor cannot take a prime contract for any project trades other than framing or carpentry unless the prime contract requires at least two unrelated building trades other than framing/carpentry. Therefore, if you are wanting to take projects for air and moisture barrier application with no additional unrelated trades included, you would most definitely need to add the specialty classification to your license.

Q: I am a licensed "B" and "C-53" (Swimming Pool) contractor. I just received my bond renewal, and it is tripled in cost. When I called the bonding company, they said that it was because I am a pool contractor.

Have you ever heard of this? I don't remember the cost of my bond ever being based on the type of contractor I am! And if that's true, how do I go about removing the "C-53" from my license? I obtained that years ago when pool construction was a large part of my general building, but I don't really do pool construction anymore.

A: Yes, I have heard that the bond premium for pool contractors and roofing contractors is higher than that of other classifications. You can complete an application to remove that classification from your license if you no longer use it.





