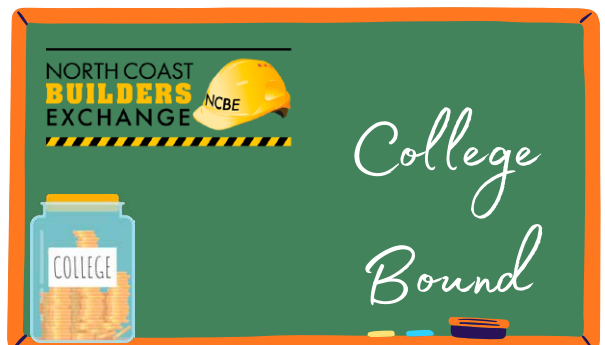

Mitigating Slips, Trips and Falls in the Workplace EHS Today

According to the Bureau of Labor Statistics (BLS), workplace slips, trips and falls were among the top three causes of work-related injuries and lost time and productivity in 2020, along with exposure to harmful substances and overexertion. BLS data showed 22,410 non-fatal occupational slip, trip and fall-related injuries involving days away from work in the manufacturing sector alone. So, it's no surprise that safety professionals feel pressure to improve on-site and on-the-job safety to prevent workplace accidents and protect their crews.

On average, occurrences of slips, trips and falls result in 14 days of lost work time. That's a significant loss of productivity and a driver of other significant expenses, such as workers' compensation claims and training for a temporary replacement to handle absentee workers' responsibilities. A report from the National Safety Council (NSC) shows the staggering cost of workers' compensation: Between 2019 and 2020, slips and falls were the third most costly workers' comp claims, with an average individual claim of nearly \$49,000.

For employers looking to show employees they care about their safety while also aiming to mitigate the increasing costs associated with workers' compensation claims, individuals in safety management roles must identify potential factors that can contribute to an unsafe working environment and lead to injury. Success is not a by-product of profit alone; it relies on employee satisfaction and engagement, which companies cannot achieve if workers feel unsafe.

Take Preventative Measures

Many of us have walked into an establishment—such as fast casual dining, restaurants, food service facilities and other hospitality settings—and at some point noticed that the floor was wet. In some cases, the floor may have been so wet that simply walking to the bathroom could pose a hazard to safety. Now consider behind the scenes, where the daily demands and hustle and bustle mean consistent cleaning might fall down the list of priorities as employees focus on other tasks. There is a need to protect employees, as well as visitors, from slipping and falling on these slick surfaces.

Looking beyond hospitality toward industrial sectors—such as food processing, non-food manufacturing, automotive, transportation, warehousing and distribution, and janitorial—the hazards of slipping and falling are significantly higher. In these environments, a slip-and-fall incident could be a life-or-death scenario with employees operating heavy machinery, working at great heights, driving forklifts and other vehicles, handling hazardous chemicals, and more.

To prevent the aforementioned cases of dangerous slips, trips and falls, employers should take the following preventative steps in addition to practicing good cleaning habits:

- Place slip-resistant floor mats in areas that consistently get wet.
- Clear high-traffic areas of clutter, such as electrical cords, wires, hoses, boxes and more.
- Minimize elevation changes and ensure ramps, steps and other uneven floor surfaces are clearly marked.
- Ensure stairs are well lit with proper handrails and ladders have proper railings and guards.
- Build a culture that promotes safety and consider strategic safety partnerships.

Build a Strong Safety Culture

One of the recommended components of the creation of a strong safety culture is the encouragement of safety managers to purchase and ensure proper footwear is worn in the workplace. Providing product solutions for varying environments isn't just good for the bottom line; it's also good for individual employees' health and safety—and for the overall well-being of those who rely on a wage earner, especially in these challenging economic times.

Why are slip resistance and traction such essential factors to consider? Looking at an X-ray of the foot, one can see that the bony structure is shaped like a tripod. This structure must provide support for all of one's weight-bearing activities, a degree of shock absorption and balance. Slips are, by definition, a temporary loss of that balance, and even slips that do not result in falls can result in subsequent injury. Of the 22,410 non-fatal slip-related injuries cited by the BLS, 3,670 did not result in a fall. However, those reported injuries still had a significant impact on employers and employees affected by the loss of production time as well as family income.

Consider a Strategic Partnership

A corporate safety shoe program, where businesses enter into an agreement with a safety shoe provider, can offer numerous benefits. Such a program is one way for safety managers to ensure individuals get the proper footwear. It's a sustainable way to reduce workers' compensation costs and save hundreds of thousands, or even millions, of dollars annually. A lack of protective footwear can lead to serious accidents and incur significant claims. Employers offering partial subsidies could see both increases in participation levels and significant slip and fall reductions.

A safe workplace boosts morale for the entire company because safer employees are more engaged, efficient and productive. Beyond that, when companies are willing to foot the bill for safety footwear, it tells employees that leadership cares about their safety needs. Companies that invest in employee well-being programs can use it as a competitive differentiator to decrease turnover and attract top talent.

Recognize Different Working Conditions


Slip-resistant footwear must be able to perform under a wide range of conditions, there's no one-size-fits-all approach to slip resistance.

Traditionally, slip resistance has been addressed with footwear outsoles that feature multiple, tiny lugs with hard leading edges, which create a high coefficient of friction (CoF)—a measurement of the friction or resistance to motion between two surfaces, and resistance on typical test surfaces in dry and wet conditions. While that works well in many environments, it is not optimal for workplaces with "contaminants" on the flooring surface, such as dairy production environments with cheese fines on the walking surface, bakeries or machine tool shops.

Floor surfaces can vary significantly, so outsole compounds and tread patterns must adapt and demonstrate the ability to expel liquids and debris in the workplace. Safety managers should consider the variety of product options provided when considering a strategic partner for a corporate shoe program.

Plan for Success

- Safety and risk managers continue to face myriad responsibilities in the workplace, including:
- Educating employees on safe practices.
- Conducting environmental audits that assess the potential for risky slips, trips and falls.

Appealing OSHA Violations Can Be Cost-Effective

Choosing to appeal an Occupational Safety and Health Administration (OSHA) violation can kick off a costly legal process but it may turn out to be cost-effective if that means you can avoid repeat violation penalties in the future, according to attorneys Melanie L. Paul and Kristina Vaquera of the Jackson Lewis law firm.

“It is more important than ever that employers understand the serious long-term, non-monetary consequences of settling or accepting OSHA citations,” they point out. “One danger of settling OSHA citations is later being cited for repeat, willful, or failure to abate violations and put on the road to significant additional costs and enforcement activity.”

They recommend that employers should dedicate their resources to ensure any violations that are upheld are correct (for example, a serious, instead of willful, violation). A potential repeat or willful violation carries a maximum penalty of \$156,259 per violation and can trigger greater enforcement activity, such as inclusion in OSHA’s Severe Violator Enforcement Program.

Paul and Vaquera cite examples of how employers can successfully challenge citations, illustrated by OSHA administrative law judge (ALJ) post-trial orders. These vacated citations were issued as final orders of the Occupational Safety and Health Review Commission (OSHRC), which is the quasi-judicial body established to oversee enforcement actions by OSHA.

In one case, a company was contracted to paint a rolling gate in front of a loading dock of a casino. The gate was installed by a different company. Although it was not fully functional, no one at the original contractor was aware of this. When the company’s employees went to move the gate, it fell and one of the employees was fatally crushed by its weight.

OSHA cited the original contractor. The crux of the issue was whether the company was sufficiently and reasonably diligent in evaluating safety hazards associated with work on the gate. The relevant OSHA standard requires “frequent and regular inspections of the job sites, materials and equipment to be made by competent persons.”

However, the OSHRC judge rejected OSHA’s argument that there was non-compliance under the standard, because the company had a policy requiring daily inspections and completion of forms that identified any hazards and how to address them. Specifically, the ALJ rejected the argument that the company should have known of the violation, because employees rea-

sonably reviewed the area diligently and, based on their experiences, there were no apparent safety issues.

Doing a similar analysis of non-compliance and employer knowledge, the ALJ also rejected OSHA’s claim that the company did not instruct employees about the hazard associated with the gate, under the standard because the specific hazard was not known or reasonably known to it.

“This is significant because these are often OSHA’s go-to regulations for construction standards when there are no other applicable standards to cite, but they are often harder to prove than OSHA believes,” Paul and Vaquera observe. Other decisions can revolve around assessments about whether the employer can be found to have pursued a reasonable course of conduct under the law.

The ALJ rejected OSHA's argument that the company violated the standard for continuing inspections during a demolition, stating there was "little guidance on how the term 'continuing inspections' is to be interpreted" and, without that specificity, what the company had done previously—pre-project inspections and daily inspections by a supervisor—could be considered reasonable conduct under the regulation.

According to the standard as it was written, an employer did not need to exercise constant supervision to show it exercised reasonable diligence to discover safety violations, the OSHRC ALJ held.

In another case, OSHA accused an employer of not properly documenting training before an incident where three employees were killed in an explosion. Although the surviving employees said they had been properly trained, OSHA disagreed and because of poor recordkeeping by the employer imposed a penalty of \$129,336.

On appeal, while the OSHRC judge upheld the training violation, the violation was found not to have been willful and the ALJ downgraded it to being defined as a serious one, which reduced the penalty tenfold—to \$12,934.

This case shows how difficult it can actually be for OSHA to prove a training violation, particularly when the training actually took place. In that case, OSHA has the responsibility of identifying specific deficiencies in the training, Paul and Vaquera explain.

"It also demonstrates the challenges of proving a heightened level of knowledge by an employer to justify a willful violation and correspondingly high penalty. In this case, it was worth it for the employer to litigate the case to avoid a willful violation in its OSHA history and lower the penalty significantl

WORKING ALONE SAFELY

INTRODUCTION

Working alone is sometimes more hazardous than doing the same job with other people. If an accident occurs, a "lone worker" must worry about getting themselves to safety and calling for help at the same time. If you perform all or parts of your job by yourself, you are required to follow the basic safety guidelines involved.

SAFETY CONCERNS

- Single persons working in public are more vulnerable to assault than a group of people are.
- Single persons working in the wilderness are more vulnerable to animal predators.
- A single worker may be less likely to see impending hazards.
- A single worker will have greater difficulty getting help if an injury or entrapment occurs.

SAFE WORK PRACTICES


The risk of working alone is dependent on the location, whether the work is risky or not, and whether or not there is involvement with the public. Lone workers who work with electricity, dangerous substances, or powerful equipment must be especially careful. Possible safety precautions could include the following:

- Never work alone in confined spaces unless there is an entry supervisor.
- Do not work alone with dangerous equipment or tools unless you have been properly trained.
- Talk to your boss and coworkers about where you will be working
- Make sure you have a method of communication with your boss or coworkers with either a
- cellphone or other effective communication system.
 - o Always keep your cell phone charged and have important numbers stored.

- If you will be working outside, you must remember to take all the required shade and water breaks to avoid heat illness.
- If possible, work in areas that are visible to others from a distance.
- Before starting your tasks, and throughout the task, pay attention to your surroundings to assess any potential hazards.
- If you will be driving, have a clear travel plan and make sure others are aware of this plan.
 - o Vehicles should be well-maintained and complete with an emergency kit.
- Employees who work alone in public may not carry weapons with them and should leave or call for help immediately if they feel threatened in any way.

CONCLUSION

Lone workers should keep in mind that their jobs may be made more dangerous simply because they are by themselves. Do not work alone unless you understand the risks relating to your specific job and the safety procedures you can do to reduce those risks.

SCA 7 (Umberg) Employment: workers' rights - Constitutional Amendment

Introduced 6/6/23 and in print now, Senate Constitutional Amendment (SCA) 7 is sponsored by the California Labor Federation and targets approval in time to appear on the November 2024 General Election ballot for voter consideration.

Digest: This measure, the Right to Organize and Negotiate Act, would ensure that all Californians have the right to join a union and to negotiate with their employers, through their legally chosen representative, and the right to protect their economic well-being and safety at work. This measure would also prohibit, after January 1, 2023, the passing of any statute or ordinance that interferes with, negates, or diminishes the right of employees to organize and bargain collectively over their wages, hours, and other terms and conditions of employment and workplace safety.

SCA 7 would add three new substantive provisions to the California Constitution:

1. A right for all "Californians" to join a union and collectively negotiate with employers;
2. A right for all "Californians" to protect their economic well-being and safety at work; and,
3. A prohibition against any state statute or local ordinance that interferes with, negates, or diminishes the right of employees to organize and bargain collectively over wages, hours, and employment terms and conditions.

Synopsis of Potential Effects:

- Extends the right to unionize and collectively bargain to positions currently excluded under the National Labor Relations Act.
- Likely prohibits or, at a minimum, negatively affects state and local budget acts that reduce public employment.
- Likely creates a basis to challenge tenure denial at California colleges and universities.
- Prohibits adoption of state or local laws that reduce private sector employment, affecting new environmental protection laws which result in employment disruption.
- Eliminates charter city home rule authority over local wages and employment terms.

- Likely creates a basis to challenge virtually any state or local government infrastructure, energy, or housing project or procurement proposal.

Sacramento lawmaker proposes constitutional right to housing

Is having a roof over your head an inherent right? In California, yes, if voters agree on a proposed constitutional amendment.

Assemblyman Matt Haney, D-San Francisco, has proposed an amendment that guarantees a “fundamental human right to adequate housing for everyone in California,” the Orange County Register reported.

The ballot measure holds state and local governments responsible for fulfilling a right to housing.

That right could include boosting housing production, tenant protections, repurposing vacant properties and housing subsidies.

“California is at the epicenter of the housing crisis,” Haney told the Register. “We have more Californians living on the street than anywhere else in the nation.”

The state has the highest rate of homelessness in the nation, and contains 30 percent of the nation’s homeless population. The state hasn’t kept pace with its housing demands, which has led to high rents.

It’s unclear exactly how the state would define “adequate housing” and the legislature may need to provide a definition, lobbyist Chris Micheli said.

“Some might view ‘adequate’ as merely having a roof over their head,” Micheli said. “It could be just a gymnasium or a large building, almost like when we have emergencies. What does adequate mean? Is it a standalone single-family dwelling? Is it an apartment?”

The Assembly Committee on Housing and Community Development voted 6-2 to refer the ballot measure to a Senate committee. Republican Assemblymembers Kate Sanchez, R-Rancho Santa Margarita, and Joe Patterson, R-Rocklin, voted against it.

A constitutional amendment requires a two-thirds vote in both the Assembly and Senate to be placed on the ballot.

Some lawmakers voiced concerns that the proposal puts the responsibility of determining the standard of what constitutes adequate or inadequate housing to the courts.

“I think the state and local governments haven’t done a good job on housing which I think has contributed to homelessness, but I’m concerned about the hundreds of judges we have in California having different ideas about what this means,” Patterson said.

10 Areas Where Diversity Improves Safety

EHS Today

Take a look at your employees or co-workers and their varying backgrounds. How diverse is it? Are some from different countries? Do some have accessibility and mobility issues due to an injury or disability? Do some have different native languages, learning preferences and educational experiences?

No matter what industry you work in, chances are high that you work with a team that brings a range of varied backgrounds (cultural and otherwise) as well as valuable—and—unique skill sets to the organization.

In their study, *Safety & the Diverse Workforce*, the National Institute for Occupational Safety & Health (NIOSH) found that “to remain effective, competitive and safe, organizations must ensure that they have the internal capacity to successfully integrate employees from an increasingly diverse workforce.”

Likewise, in Amy Edmondson’s book, *The Fearless Organization: Creating Psychological Safety in the Workplace*, she talks about how imperative psychological safety is in a diverse workplace that is engaged and productive. In fact, she says that how safe a work environment is can “make or break achievement of team performance.”

Over the past few years, workplaces have experienced a number of dramatic changes. Most surprisingly, COVID-19 revealed the challenges of accommodating to different backgrounds. But perhaps more importantly, it showed us the many benefits of a diverse workplace—and how we can become stronger by learning from each other.

In a 2022 report from the International Labor Organization (ILO), researchers found that “high levels of equality, diversity and inclusion are associated with greater innovation, productivity and performance, talent recruitment and retention, and workforce well-being.”

Furthermore, a 2021 study in the *Academy of Management Journal* found that “organizations with high levels of racial diversity in both upper and lower management (i.e., high–high racial diversity congruence) realized superior productivity compared to organizations with low levels of racial diversity in both upper and lower management.”

Public projects surge, private starts falter

Construction Dive

Dive Brief:

- Total construction starts continued their 2023 roller coaster ride, jumping 8% in May to a seasonally adjusted annual rate of \$1.11 trillion due to strong gains in manufacturing and infrastructure, according to Dodge Construction Network.
- After an unexpected 68% drop in manufacturing project kickoffs in April dragged down all starts, manufacturing starts more than doubled in May. Growth in the manufacturing and infrastructure sectors, however, was largely offset by contractions in commercial and residential construction — think office, retail and housing — marking an overall bifurcation of building activity.
- “May’s data is another sign that the construction sector is slowly splitting into two,” said Richard Branch, chief economist for Dodge Construction Network. “Public dollars are flooding into the manufacturing and infrastructure sectors, leading to significant growth over the last year. Meanwhile, the mostly private sectors of the building market like offices, multifamily and retail are struggling.”

Dive Insight:

While construction in manufacturing and infrastructure report strong activity, the private sectors of the building market are posting worrying signs, as they struggle under the weight of higher interest rates, tightening lending standards and declining demand, said Branch.

Commercial starts dropped 20% in May due to a sharp pullback in office and retail commencements, according to the report, while institutional starts, such as schools and hospitals, ticked down 1% in May.

“The second half of the year is shaping up to be a challenging one,” said Branch. “But, the insulation provided by manufacturing and infrastructure starts will stabilize the industry and lead to modest overall growth.”

Due to manufacturing’s strength, activity in the broader nonresidential sector also jumped 8%, mirroring the boost for all construction starts. But on a year-to-date basis through May, total new project launches were down 6% compared to 2022.

The largest nonresidential building projects to break ground in May included:

- The \$1.9 billion Steel Dynamics aluminum plant in Columbus, Mississippi.
- The \$1.9 billion Eli Lilly & Co. facility in Indianapolis, Indiana.
- The \$1.5 billion Ford Ohio EV plant in Sheffield, Ohio.

Slow residential construction activity

Activity in the residential sector continues to post slow activity, down 25% in 2023, according to Dodge.

Building starts in the sector fell 4% in May, led by an 8% drop in multifamily starts. For the 12 months ending in May 2023, residential starts posted a 15% decline to the prior year.

Nonbuilding construction growth surges again

Nonbuilding activity, such as gas plants, streets and bridges, increased 24% in May, and remains 25% higher on a year-to-date basis, according to Dodge.



Capitol Connection Q&A for Contractors

Is the 'grass' greener with another class? Let's cross this off your list when it comes to renewals, and I 'sign off' on another idea before helping a business go 'down the drain' in a good way...

Q: We have had a "C-27" license for over 30 years. We've done thousands of synthetic turf jobs, but recently we've had several HOA's require the "D-12" to do turf installation. Have you heard of that and how difficult is it to add it to our license?

A: I have heard that a lot lately, which is strange since you can do turf installation with a "C-27" (Landscaping) license. Ultimately, it's up to the project owner what type of license they want you to have. It sounds like you certainly meet the experience requirement to add it your license, and there's no trade exam so it should be a no brainer!

Q: We received our license renewal in the (snail) mail, and it lists Officers who are no longer with our company. Can I just cross out their names and have the remaining Officers and the RMO sign?

A: No! Please don't alter the CSLB renewal form or it will be rejected. You can submit Disassociation notices for the individuals who are no longer with the company. They need to be signed by a current Officer listed on the license. As far as who signs your renewal application, since your Qualifier is an RMO (Responsible Managing Officer), it only needs to be signed by him. He meets the signature requirement for both the Qualifier and an Officer.

Q: I am familiar with the requirement for an RME (Responsible Managing Employee) in California to work a certain number of hours for the company. We are interested in hiring a licensed Qualifier to help obtain a Nevada license. Does Nevada have those same hour requirements for the Qualifying employee?

A: No, they do not. Nevada requires the Qualifying Party to be a bona fide employee of the licensee

and to be responsible for overseeing and making technical and administrative decisions for the company. Additionally, they are required to devote themselves solely to the employer's/licensee's business and not take any other employment which conflicts with his/her duties. But no hour requirement!

Q: My husband and I want to open a business doing Hydro jetting in California. We would not be doing any repairing or modifications of any kind, only Hydro jetting. Is there any specific license that is needed other than the city license?

A: The hydro jetting and camera inspections of sewer/drain lines does not require a contractor's license, as long as there are no repairs or alterations done to the system.

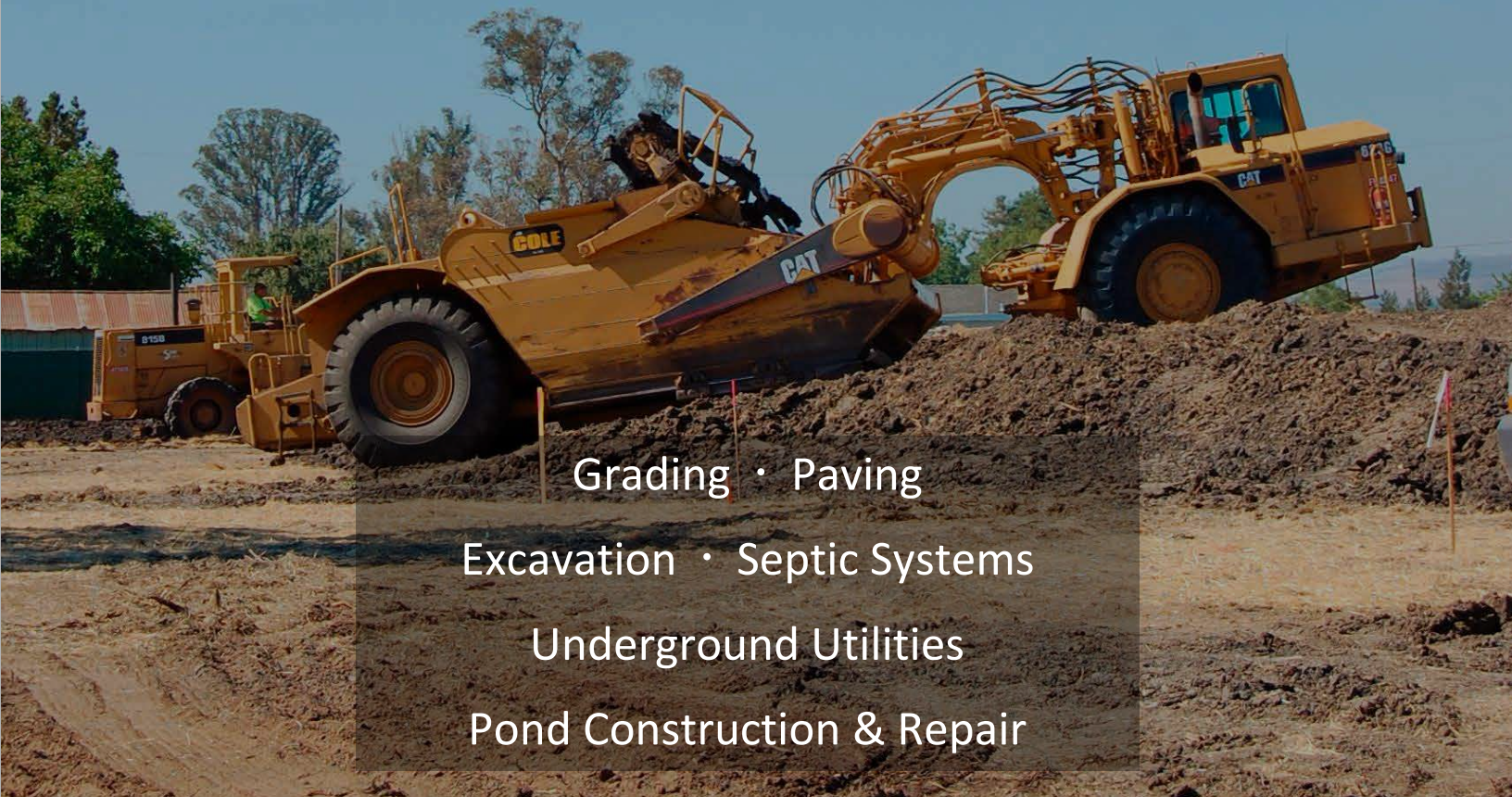
