'No reason not to have it': Why contractors equip jobsites with Narcan

As of June 1, legislation in Ontario, Canada, required every construction site there to have a naloxone kit. The medication, often known by the brand name Narcan, can temporarily reverse the effects of opioid overdose, and provide a bridge until an affected person can receive medical help.

Opioid use disorder has hit the construction industry hard: It has higher rates of overdose death than most other sectors. Providing life-saving medication on jobsites, and educating about opioid use in the industry is now becoming more standard in the U.S. as well as Canada.

"It's an amazing medication that reverses imminent death. There's no reason not to have it," said Chris Trahan Cain, executive director of Silver Spring, Maryland-based CPWR — the Center for Construction and Research Training.

Opioid use disorder has affected Americans in every walk of life, but it's especially prevalent in construction. According to the Centers for Disease Control and Prevention, 107,622 people died of drug overdoses in the U.S. in 2021, up nearly 15% from 2020. The CDC also found that overdose deaths involving opioids increased from an estimated 70,029 in 2020 to 80,816 in 2021.

Construction workers are at a greater risk. Studies in both Massachusetts and Ohio show that they are seven times more likely to die of opioid-related overdoses than the average worker.

"There are a lot of things about construction that don't necessarily lead to a balanced lifestyle," said Cain, including lack of paid sick leave, non-traditional work schedules and a high number of soft tissue injuries.

"We continuously see doctors prescribe opioids for pain in construction workers when it's probably not the best pain medicine," she said. Even though legally prescribed, these prescriptions can lead to addiction, as someone can "become dependent on prescribed opioids in a few days."

Part of the jobsite's first aid kit

Although no U.S. state has mandated naloxone kits on jobsites, many general contractors have enacted the practice anyway, with help from public health

resources.

In 2017, based on findings of high opioid overdoses in the construction industry, the Delaware Division of Public Health started putting together a construction-specific plan to tackle opioid use disorder and overdose within the industry.

Employer tool kits from the division can help people spot signs of opioid use disorder, give information about the epidemic and also provide training and access to naloxone, said Candace Brady, Delaware's naloxone program coordinator at the Office of Health Crisis Response.

Her team also holds trainings on how to use the medication, presents their tool kit at jobsite safety meetings and sets up tables on jobsites with Dunkin' Donuts, so they can "interact with some of the construction workers," she said. "The willingness to be part of this program is there."

So far, they've distributed 354 kits. Employers don't have to report back, so she doesn't have statistics on if kits have been used, but she knows the partner restaurant program has utilized the kits.

Brady hopes that how to use naloxone will be seen as just another thing that someone would learn to save a life.

Adding naloxone kits to a hard hat order

In 2018, Shawmut Design and Construction started their own education about opioid use disorder when they invited a speaker from Grayken Center for Addiction at the Boston Medical Center to give a keynote address to the company.

"It really opened our eyes," said Shaun Carvalho, chief safety officer at Shawmut. Workers responded by saying "that was a great talk, but what can we now do about it?" he recalled.

That led the company to start a pilot program to see how to obtain an adequate supply of naloxone for their jobsites and train workers on how to use it. It was so successful that now managers can order naloxone in the same way that they'd also order hardhats, safety signage and Automated External Defibrillators (AED) machines. It's not mandatory on every jobsite, Carvalho added. They leave that up to the discretion of project teams.

Shawmut has also trained all frontline people on their jobsites on how to deploy naloxone, and provides training throughout the year as part of general safety training.

"The more that we can talk about these things as though they're just as much of a hazard as falling or electricity, they become part of the normal conversation," Carvalho said. A worker may not overdose on a

jobsite, but they may realize they're on a slippery slope and need to reach out to someone for help, which can help the worker and prevent an overdose in the first place, he said.

Carvalho said no jobsite has had to use the naloxone yet, but they haven't had to use AED machines either. That doesn't mean they're not necessary. Even if not used, they increase workers' feelings of safety on the job.

Having a Green Badge May Be Key to Future Jobs

With sustainability gradually becoming a key area for business and regulatory reasons, having green skills will be necessary for a variety of jobs.

To earn these skills, micro-credentialing will be a core strategy for companies looking to train employees on the job. According to a recent report from Indeed, while job postings requiring green skills grew by 8% annually since 2017, the share of green talent has only grown by 6% in the same period.

MH&L posed some questions to Danny, King, CEO of digital credentialing company Accredible.

MH&L: Are most logistic and manufacturing companies aware of digital credentials?

DK: Digital credentials are more trustworthy and secure due to the fact that they are conferred to learners with strong security protocols in place. With a combination of bank-level security measures and strong metadata within each credential to help convey a learner's specific skills or competencies, businesses can quickly and easily verify skills of current and prospective employees.

In short, advancements in digital credentialing technology have helped remove the burden from employers and businesses themselves and allow for easier, faster assessment of workers' skills.

MH&L: Why do you think the growth of those that have these green skills is slow?

DK: The world only began to see a serious commitment to sustainability in the past few years, with governments from the US to China and the EU making net-zero pledges. The same was also true in the business world; however, I believe we are now at the point where governments and organizations will further accelerate their efforts to achieve sustainability. This, of course, is also why the growth in job roles that require green skills will progressively grow in the coming years.

As governments and businesses increase their focus on sustainability, there is a growing need for employees with green skills, not just in roles related to climate change like environmental management. This includes positions such as facilities managers, compliance managers, risk advisers, and safety technicians, as sustainability becomes the new norm for reporting and standards.

While growth in the supply of workers having green skills has been slow over the last few years, as organizations begin to realize their commitment to net zero over the next decade, it would inevitably result in the need for workers to acquire additional sustainability-related skills to remain competitive in the job market.

To address this, micro-credentialing is expected to become a key strategy for companies to train their employees while allowing them to continue their current workload. This is especially important in an economy that is becoming more aware of its impact on the environment.

MH&L: Have you seen an increase in the need for your services as companies understand how this process can fill the talent gap they are experiencing?

DK: The short answer is yes - during the first half of 2022, for example, more than 1,700 of our partner organizations issued 1.7 million digital credentials on average to learners and students looking to grow their personal skill sets.

This marks an increase from the first half of 2021, where 1.2 million credentials were issued across 1,200 partners and customers.

One of the main reasons that we've seen this increase is the return on investment for businesses. The verifiable nature of digital credentials makes what is otherwise a time-consuming and cumbersome verification process into an easy and automated one.

DOJ Urges Employers to Protect Outdoor Workers Poor Air Quality

To help employers deal with the fallout from the Canadian wildfires as they continue to produce unhealthy air pollution in parts of the country, OSAH on July 9 is letting employers know of various resources. The agency has a comprehensive website with safety tips and resources to help workers reduce their exposure to smoke during wildfires.

The National Institute for Occupational Safety and Health also offers resources for outdoor workers exposed to wildfire smoke.

“Wildfire smoke exposure can create major health hazards for outdoor workers. These hazards can be reduced with knowledge, safe work practices and appropriate personal protective equipment,” said Assistant Secretary for Occupational Safety and Health Doug Parker, in a statement. “I urge all employers to have plans and preparations in place to protect workers by preventing or minimizing exposure to hazardous air quality.”

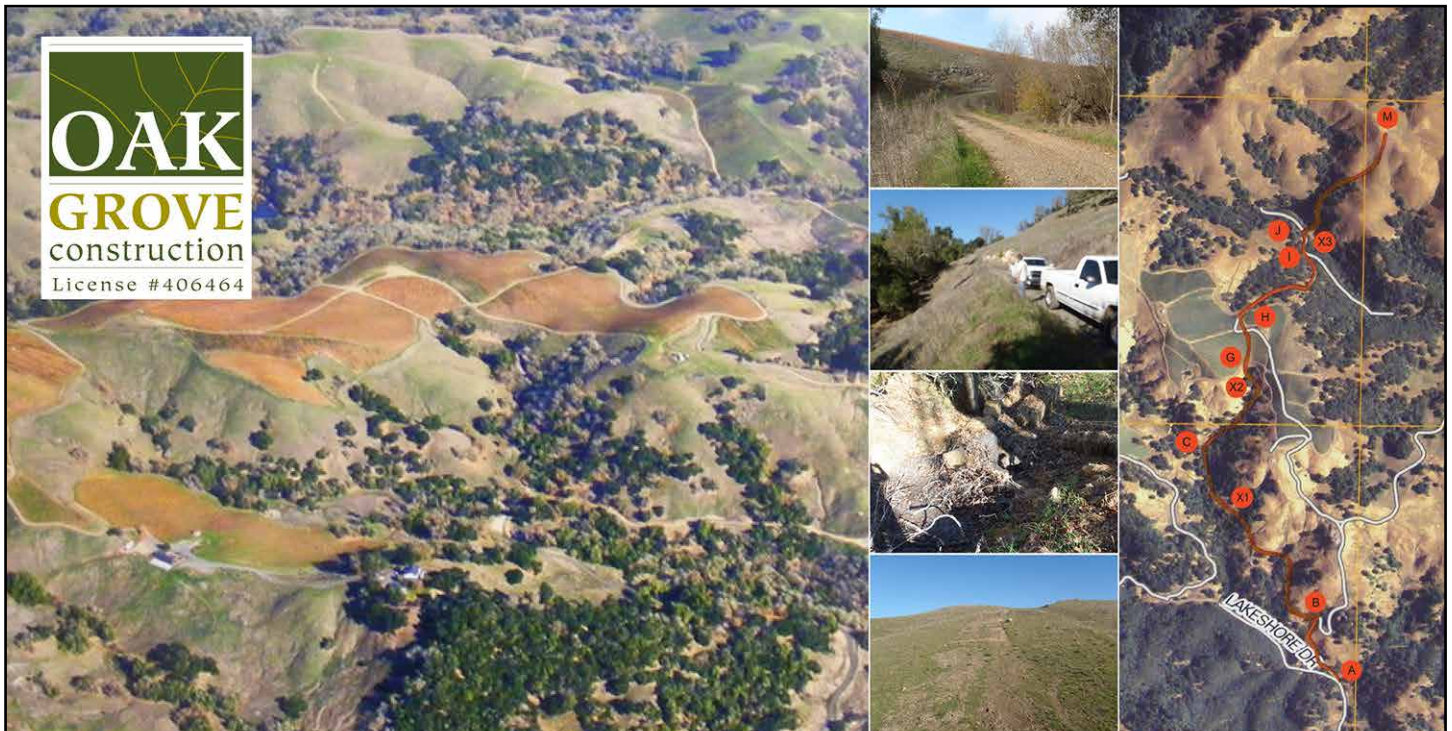
The most significant hazard from wildfire smoke is exposure to particulate matter, tiny particles of partially burned material less than 2.5 micrometers in diameter, that can enter the lungs and even the bloodstream and is linked to serious

health problems, including lung, heart and kidney disease.

Workers exposed to smoke-polluted air may experience heat stress, eye and respiratory tract irritation, and suffer from exposure to other respiratory hazards caused by hazardous substances such as heavy metals entering the atmosphere. Employers should prepare for and plan to implement procedures to reduce exposure to smoke when necessary.

Protective measures to reduce smoke exposure for outdoor workers can include:

- Frequent monitoring of air quality conditions using a source such as the EPA's AirNow.
- Relocating or rescheduling work tasks to smoke-free areas.
- Reducing levels of physical activity, especially strenuous and heavy work.
- Requiring and encouraging workers to take breaks in smoke-free places when possible.
- When possible, making accommodations for employees to work inside with proper HVAC systems and high efficiency air filters.

Regulatory Update: Keep Rude Music Out of the Workplace

A federal appeals court decision recently found an employer can be found liable for condoning sexual harassment by allowing the playing sexually explicit rap music in the workplace, even when it offends both men and women.

The employees who brought the suit – seven women and one man – said that the employer, S&S Activewear, had created a sexually hostile work environment by allowing supervisors to routinely play “sexually graphic, violently misogynistic music” at the company’s 700,000 square foot warehouse in Reno, NV. The songs contained lyrics glorifying prostitution, using expletives crudely describing sexual acts, and advocating violence against women.

They claimed that these songs were continuously blasted from commercial-strength speakers throughout the warehouse. Some employees complained “almost daily” for nearly two years before they brought suit. Despite these repeated complaints about the music, management defended it as a “motivational tool,” according to attorney Frank Shuster of the law firm of Constangy Brooks Smith & Prophete.

In addition, employees who brought the suit charged that some of the male employees shared sexually pornographic

videos, and made sexual hand gestures, body movements and made sexual comments. The suit was filed in federal court in Nevada, and also alleged hostile environment discrimination, retaliation and constructive discharge.

Although the judge allowed most of the case to go forward, she dismissed the claim that the music created a sexually hostile work environment. The judge held that the plaintiffs could not prove discrimination based on sex because the music was played warehouse-wide, all employees were subjected to it, both men and women found it offensive, and there were no allegations that it was targeted at any particular group of employees.

Hearing an appeal to this ruling, the judges of the U.S. Ninth Circuit Court of Appeals reversed the dismissal and allowed the case to go forward in the lower court. In their view, the issue that should be addressed really was whether “music with sexually derogatory and violent content, played constantly and publicly throughout the workplace, can foster a hostile or abusive environment and thus constitute discrimination because of sex.”

In finding that it did, the court first recognized that harassing conduct need not be targeted at a person or group to be discriminatory, Shuster points out. The court recognized that, although Title VII of the federal civil rights law is not a “civility code” outlawing the use of any sexual language, context matters – especially in this case.

As for the context alleged by complaining employees, the appeals court concluded that “repeated and prolonged exposure to sexually foul and abusive music falls within a broader category of actionable auditory harassment that can pollute a workplace and violate Title VII” of the federal civil rights law.

Offending Everyone Equally

The appeals court judges also did not cotton to the district court’s dismissal of the music-based claims because that judge had taken note of the fact that there were men equally offended by the lyrics. And Shuster emphasizes that the Ninth Circuit characterized this argument as being based on an “equal opportunity harasser defense.”

Shuster notes that the Appeals Court judges made the explicit point that to permit “an employer to escape liability because it equally harassed whites and blacks, or men and women, would give new meaning to equal opportunity. Rather than embrace such an absurd interpretation, we resolve that the music’s alleged offensiveness to both male and female employees is no obstacle to [the] suit.”

Attorneys Caroline Burnett, Zachary Reeves and Autumn Sharp of the Baker McKenzie law firm further explain the appeals court judges also determined that harassment, whether aural or visual, does not need to be directly targeted at a particular plaintiff in order to pollute a workplace and give rise to a Title VII claim, explain

In the end, the federal judges also held that “music with sexually derogatory and violent content, played constantly and publicly throughout the workplace, can foster a hostile or abusive environment and thus constitute discrimination because of sex.”

Or, as Shuster put it quite succinctly, “The lessons to be learned are that the content of such media can be offensive to some, it does not matter whether the content is targeted at anyone, and the fact that it may offend men and women alike is not a defense.”

Burnett, Reeves and Sharp stress that employers from now on, in order to remain compliant with federal civil rights law, must be careful to ensure that any music being played at worksites is appropriate and inoffensive, or they will risk legitimate claims of sexual harassment.

“Furthermore, while this ruling only addresses harassment based on sex, it is reasonable to believe that its logic could extend to other protected classes (e.g., race, color, religion, national origin, disability, or age),” they add.

In addition, this case also underscores the importance of employers maintaining appropriate mechanisms to receive and investigate employee complaints of harassment that violates state and federal civil rights protections, the Baker McKenzie attorneys warn.

“Two years of near daily complaints should not fall on deaf ears. Instead, it is a strong signal to reassess what’s happening in the workplace. And, that something or someone is an equal opportunity offender does not excuse it – “it was offensive to everyone” is not be a sufficient defense.”

They suggest that a good litmus test for employers to apply is: “If the music in the workplace is leading some employees to make sexually graphic and violent gestures, it’s time to the change that tune.”

Nonresidential construction spending shrinks for first time in 11 months

Dive Brief:

- National nonresidential construction spending inched down 0.2% in May to a seasonally adjusted annualized basis of \$1.06 trillion, according to new Associated Builders and Contractors analysis.
- The slight drop this month follows an 11-month streak of nonresidential spending increases, largely driven by strong activity in manufacturing construction.
- “While spending is up more than 17% over that [11-month] span, manufacturing-related construction accounted for the majority of that increase,” said Anirban Basu, ABC chief economist. “Excluding the manufacturing segment, nonresidential construction spending is barely outpacing inflation, up just 6% over the past year.”

Dive Insight:

Spending in the manufacturing sector ticked up 1% in May, and remains up more than 76% year over year. Meanwhile, office construction, which includes the booming data center sector, inched up close to 1% in May and remains up 6.7% year over year.

But despite the increases in these two types of private nonresidential spending, most other categories lag behind, said Ken Simonson, Associated General Contractors of America chief economist.

Capitol Connection Q&A for Contractors

Can a licensed contractor be ‘on-the-job’ with an Inactive status? Yes, but it has more to do with how ‘qualified’ you might be, in CA or other states...

Q: My company has asked me to get a contractor’s license and they suggested that I place it on Inactive status. I’m trying to figure out what the point of getting an Inactive license is. Doesn’t that mean I cannot use it and they cannot either?

A: Usually when a company requests that an individual get their own license, it’s for the purpose of a “back-up” license for the company. It’s basically a way to get you through testing and fingerprinting and such so that if the Qualifier on the company leaves unexpectedly, they have a back-up person to jump on the company license right away. Once a Qualifier leaves a company, the license has 90 days to replace him/her so having a back-up ensures they don’t have any lapse in licensure.

Q: I have a Sole Owner license that I have kept Inactive for the last several years. I want to advertise to be an RMO (Responsible Managing Officer) for someone else’s company. Do I need activate my license first? What is the fee to re-activate?

A: No, it is not necessary to reactivate your license prior to applying to act as the RMO for another license, and yes, there is a fee to reactivate a license.

Q: We need to obtain a new license for a new entity we are forming in California. We will be using one of our employees to act as the RME (Responsible Managing Employee). I know there are rules about an RME only Qualifying one license at a time. Does this apply from State to State as well? In other words, can we use the same person to Qualify our licenses for Arizona and Nevada?

A: Yes, you can use the same Qualifying Individual for Arizona and Nevada. While you are required to list your licenses in other States on the applications, they do not have a rule as to how many licenses you can Qualify outside of Nevada and Arizona.

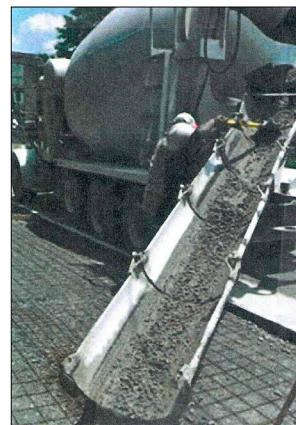
Q: Our Qualifying Individual is going to be leaving the company soon. I understand that the license belongs to the company, not the Qualifier. Does that mean we automatically retain the license when the Responsible Managing Employee (RME) leaves? If we do need to put someone in his place, does that person have to take the exam, or does the fact that the company has the license waive that requirement?

A: You are correct, the license does belong to the company, so yes, the license does stay with the company if your RME leaves. However, you have 90 days to replace the Qualifier on the license. If the individual replacing your current Qualifier has never been licensed before, then yes, he/she would be required to take the exams. In certain circumstances, a Waiver of the exams may be an option. Please contact me if you’d like further information on this option.
