OSHA electronic recordkeeping rule to take effect in 2024

The rule will require employers with 100 or more employees to submit information from Forms 300 and 301 once per year.

Dive Brief:

- The Occupational Safety and Health Administration published Friday its final electronic recordkeeping rule requiring employers with 100 or more employees in certain industries to submit information from the agency’s Forms 300 and 301 once per year.
- OSHA’s rule also updates its system for determining which industries are subject to the information submission requirement. In a departure from the proposed rule, OSHA has retained the requirement for employers with 250 or more employees to electronically submit information from Form 300A once per year. Additionally, employers with 20 to 249 employees in certain designated industries will continue to be required to electronically submit information from Form 300A once per year.
- Per the rule, the agency will post data gathered via these submissions on a public website, with identifying information — such as employees’ names and contact information — removed. The final rule is effective Jan. 1, 2024.

Dive Insight:

The announcement represents OSHA’s second attempt at enhancing electronic record requirements, the first of which was proposed by President Barack Obama’s administration in 2016 but later rolled back by President Donald Trump’s administration.

Under the rule, covered employers will be required to make electronic data submissions to OSHA on March 2 of the year after the calendar year covered by each form. Employers submitting 2023 calendar year information would therefore need to do so by March 2, 2024, OSHA said.

In its April proposed rule, OSHA included a list of industries used to determine which employers with 100 or more employees must submit Form 300 and Form 301 information. The final rule expands that list, adding six more industries: logging; hunting and trapping; other furniture related product manufacturing; miscellaneous durable goods merchant wholesalers; taxi and limousine services; and other support activities for transportation.

In public comments written in response to the agency’s proposed rule, several employer advocates voiced concerns about the information collection. The U.S. Chamber of Commerce, for example, said the inclusion of data on the number of employees and hours worked on Form 300A annual summaries could be used by competitors to gain insight on employers’ “efficiencies and productivity rates.”

“Furthermore, the establishment-specific nature of the data from the 300 and 301 forms will mean that adversaries and parties wishing to mischaracterize an employer’s safety record will have no trouble doing so with great specificity,” the Chamber wrote. “Merely because an injury or illness is recorded does not mean that employer has a weak safety program, or any OSHA violations.”

Similarly, public comments from the Motor & Equipment Manufacturers Association said employers would need to expend “significant time and resources” to ensure that personally identifiable information is stripped from data submitted to OSHA. MEMA also said the expanded data collection would be unlikely to reduce workplace injuries and illnesses, adding that this data “would become stale by the time it is made public, and in any event, many workplace injuries occur due to circumstances entirely outside of an employer’s control.”

OSHA stated in the final rule that online availability of the data would allow the public to “determine which workplaces in a particular industry are the safest, and identify emerging injury and illness trends in particular industries” as well as make decisions about which companies and industries to support and work for.

In a media briefing Monday, Assistant Secretary of Labor for Occupational Safety and Health Doug Parker said covered employers should not include personally identifiable information in their submissions to OSHA, and that the agency crafted the reporting process to address such concerns. OSHA, Parker said, will also take steps to ensure sensitive information is not made public.

“Congress intended for the Occupational Safety and Health Act to include reporting procedures that would provide the agency and the public with an understanding of the safety and health problems workers face, and this rule is a big step in finally realizing that objective,” Parker said in a press release. “The safety and health community will benefit from the insights this information will provide at the industry level, while workers and employers will be able to make more informed decisions about their workplace’s safety and health.”

OSHA rule proposal would require construction PPE to fit properly

Dive Brief:

- OSHA is proposing a new rule in order to clarify its personal protective equipment requirements for construction. The revision, published Thursday, explicitly requires that PPE fit workers properly.
- The agency said it proposed the rule to increase clarity. Currently, it requires construction employers to provide and maintain PPE and ensure employee-owned equipment is adequate, but does not explicitly state that safety gear must properly fit each employee. This rule proposal would add that to the existing rule, which is more in line with general industry and maritime standards.
- OSHA said that the rule could better protect women, who are often frustrated with and ill protected by oversized gear. Even something as ubiquitous as a safety vest can become an irritant in a low-hazard environment like the office by snagging on door handles.

Dive Insight:

OSHA said the rule clarification will fortify the existing rule to make it more understandable and to ensure that workers of all sizes have the right fit.

Amy Roosa, founder of The Safety Rack, a media network that reviews PPE for women in the trades, praised the rule change.

"My initial reaction is that this is very positive," Roosa said of the rule proposal. "That's the biggest struggle we're seeing is [PPE] properly fitting women in the construction industry, and this rule proposal has the potential to change that for us."

But the rule will also benefit men who don't fall into typical height and weight parameters, said Michelle Gray, national environmental health and safety leader at Redwood City, California-based DPR Construction

"I hope that the construction industry doesn't focus on this being something just for the women in the industry," Gray said. "This update will help improve the safety and effectiveness of PPE for everyone—short/tall, large/small."

She also noted manufacturers and leading contractors are ahead of the regulations, shirking the one-size-fits-all method.

"They are doing a better job of recognizing that PPE works better when it fits right. We are more likely to get people to use it and wear it when it's made for their size," Gray said.

North America's Building Trades Union president Sean McGarvey also praised the rule proposal.

"This minor regulation clarification means that construction workers will be afforded PPE that fits their various sizes and will improve safety for all workers in our industry," McGarvey said in an email. "This is a huge positive change for tradeswomen and other trade professionals workers who wear different sizes." Rulemaking process

The idea of updating this rule is nothing new.

The agency's Advisory Committee on Construction Safety and Health recommended OSHA propose the new PPE rule as part of its Standards Improvement Project IV, the agency said. When the agency proposed SIP-IV in 2016, comments the agency received supported the PPE rule proposal, but some associations pushed back, citing costs and enforcement concerns.

As a result, OSHA tabled the portion of SIP-IV about the PPE rule change. Because the rule would clarify existing language, the agency says it believes there are no real costs associated with the proposal. However, because OSHA estimates about 10% of workers currently wear ill-fitting PPE, a one-time, transitional expense for the entire industry could cost as much as \$545,000, the proposal said.

For most equipment, the cost difference in PPE of varying sizes is minimal, Roosa said. "The variation in price is not that great anymore," she said. "It's not that much more or less to fit a woman in properly-fitted PPE."

Once published, OSHA will accept public comments on the rule until Sept. 18.

Regulatory Update: Emphasis Program To Prevent Warehouse Workplace Hazards

DOL on July 13, launched a national emphasis program to prevent workplace hazards in warehouses, processing facilities distribution centers, and high-risk retail establishments.

In the past 10 years, warehousing and distribution centers have experienced tremendous growth with more than 1.9 million people employed in the industry. The Bureau of Labor Statistics data shows injury and illness rates for these establishments are higher than in private industry overall and, in some sectors, more than twice the rate of private industry.

“Our enforcement efforts are designed to do one thing: lead to permanent change in workplace safety,” said Assistant Secretary for Occupational Safety and Health Doug Parker, in a statement. “This emphasis program allows OSHA to direct resources to establishments where evidence shows employers must be more intentional in addressing the root causes of worker injuries and align their business practices with the goal to ensure worker health and safety.”

Under this three-year emphasis program, OSHA will conduct comprehensive safety inspections focused on hazards related to powered industrial vehicle operations, material handling and storage, walking and working surfaces, means of egress and fire protection. The program will also include inspections of retail establishments with high injury rates with a focus on storage and loading areas; however, OSHA may expand an inspection’s scope when evidence shows that violations may exist in other areas of the establishment.

In addition, OSHA will assess heat and ergonomic hazards under the emphasis program, and health inspections may be conducted if OSHA determines these hazards are present.

Inspected establishments will be chosen from two lists. One includes establishments with industry codes covered under this emphasis program. The second consists of a limited number of retail establishments with the highest rates of injuries and illnesses resulting in days away, restricted duty or job transfer.

State plans are required to adopt this emphasis program or establish a different program at least as effective as the federal model.

Zero Waste Sonoma C&D Model Ordinance

Zero Waste Sonoma (ZWS) has proposed a Model Construction, Demolition and Deconstruction Ordinance to potentially be adopted by the county and each city within Sonoma county by 2023. We are seeking your anonymous feedback as a member of the construction community.

The ordinance will require all projects to be compliant with CalGreen, requiring contractors to:

1. Submit waste management plans before receiving a permit.
2. Upload mixed load, recycling and reuse receipts to GreenHalo
3. Contractors will be required to reach 65% diversion rate
4. Stand alone demolition permits will be replaced by deconstruction permits. Properties with Deconstruction Permits will have Construction Permits fast tracked. Contractors must use a licensed contractor with deconstruction experience. Demolition may be performed with issued construction permits only.
5. Demolition of Pre-1945 and Historical buildings will be prohibited - must acquire Deconstruction permit (includes some exceptions).

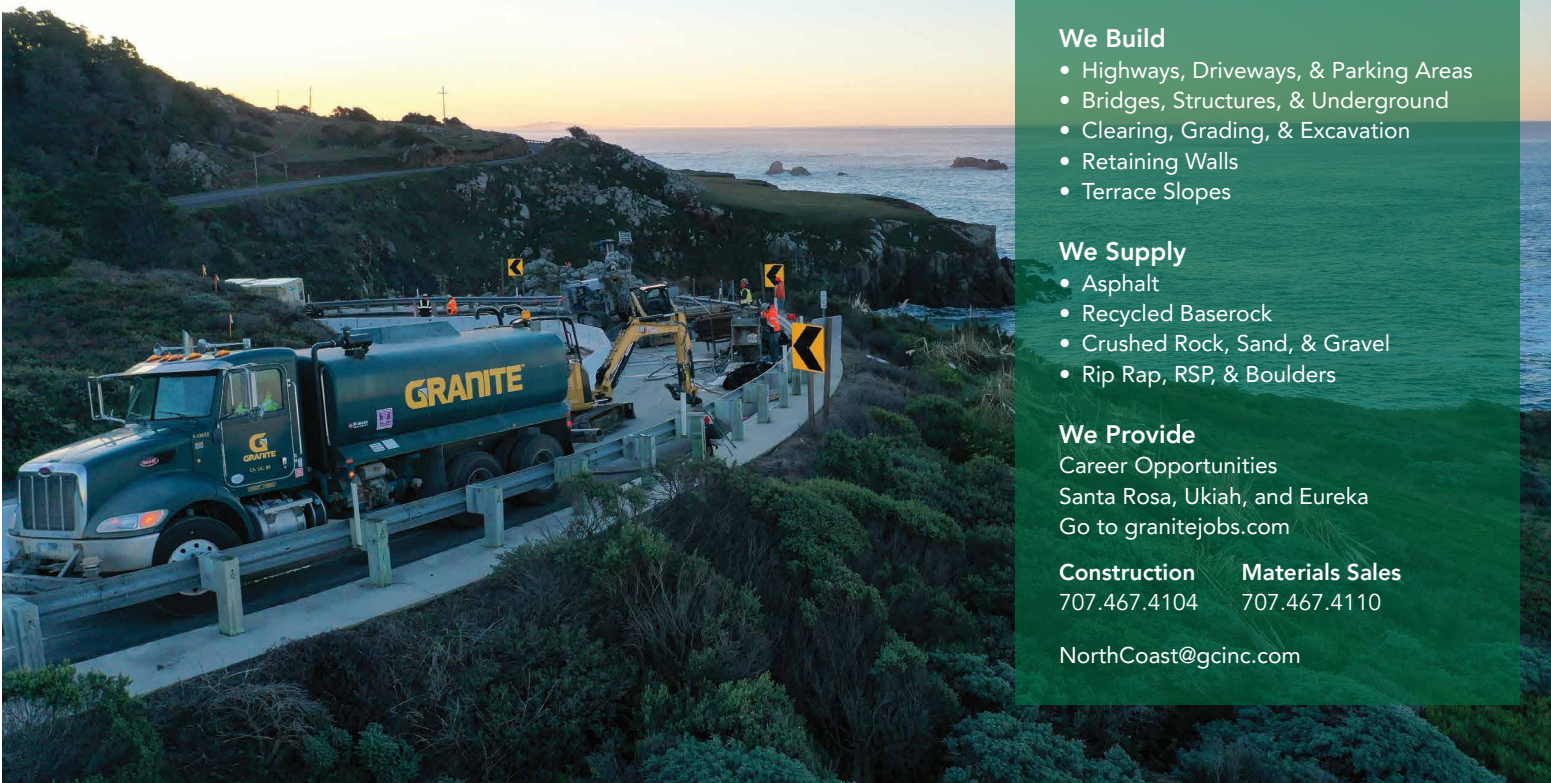



Protecting Construction Workers Against Extreme Temperatures

Between 2011 and 2019, there were 344 work-related deaths caused by environmental heat exposure, according to the Bureau of Labor Statistics. It's widely thought, however, that this number is an under-representation, not inclusive of worker deaths due to conditions like heart attack, which can be brought on or exacerbated by unsafe heat conditions.

In the three years since this data was recorded, we've seen record-shattering temperatures around the globe. Over the past year, for instance, 67 all-time high-temperature records have been broken across the U.S.; globally, 230 such records have been broken over that same time period. As temperatures continue to rise, it's reasonable to expect the number of heat-related worker deaths, injuries and illnesses to rise as well.

While these extreme temperatures continue to impact the health and safety of workers across geographies and industries, the global construction industry is particularly vulnerable to the effects of unprecedented heat. Construction workers are required to engage in hard, physical labor outdoors and often work longer hours during the year's hottest months due to the increased hours of daylight. The combination of record-breaking heat, physical labor and long hours puts construction workers in significant danger.

In addition to having a negative impact on worker health and safety, rising temperatures can harm construction businesses in the form of lost or less efficient labor. Construction employees must work slower and take more breaks in high-heat environments, and they must take time away from the jobsite to recover in the wake of a heat-related illness or injury. Though heat-related death, illness and injury are the most severe outcomes of working in a too-hot environment, the negative effect of lost labor is a notable consideration for businesses in the construction industry.

Thankfully, there is much that can be done to help construction workers stay safe and healthy through the hottest days of the year—and to ensure the continuation of effective, efficient and safe labor on the jobsite.

One such measure is to equip workers with the right protective gear for the environment in which they'll be working. Many forms of PPE can actually increase a worker's temperature by minimizing airflow, reducing the body's natural ability to cool itself by sweating, and through the added weight of the equipment that the wearer must carry while working. However, there are specific PPE features and types that can help

do the opposite, allowing workers to maintain healthy and safe body temperatures while minimizing the risk of heat-related illness or injury.

Choose the Right Hard Hat for the Job

One of the easiest places for construction site managers and employers to begin when looking for ways to protect their workers against high temperatures is with the hard hat, a mainstay of the construction site. It's essential that construction workers are equipped with the best hard hat for the conditions under which they'll be working—and some hard hats are simply better suited for high temperatures than others.

Certain hard hat features can help minimize heat retention and keep workers safe from heat-related illness or injury. For example, all hard hats will retain some of the heat put off by the sun's rays, but studies have shown that lighter colored hats retain less heat than darker hats, making lighter hats a better option for outdoor construction work.

Additionally, a wide brim can offer necessary shade when working under the direct sunlight, and integrated vents—suitable for jobsites without electrical hazards—help improve air flow around the head.

Accessories Offer Increased Protection

Choosing a hard hat with heat-minimizing features is important for heat safety, but the benefits of these integrated features can be enhanced even further by the addition of heat-reducing hard hat accessories.

Sweat-wicking helmet liners and brow pads can be affixed to the inside of a hard hat to help prevent added moisture, and the associated humidity, from building up inside a worker's hat. Anti-glare decals can minimize the impact of the sun's glare, and sunshades and sunshields can be used to increase the shade offered around the hard hat wearer's head, neck and face.

Other Heat-Protective Gear

In addition to choosing the best hard hat and accessories for high temperatures, workers can utilize other protective gear that has been specifically designed to minimize heat and maintain the wearer's body temperature at a safe and healthy level.

A number of PPE manufacturers offer a range of protective gear designed uniquely for high-heat work environments. Items like cooling vests utilize phase change material technology to maintain a set temperature for an extended period of time, thereby offering continuous cooling benefits to workers.

Separately, workers should, when possible, opt to wear clothes made of breathable fabrics underneath their PPE, and consider accessories like UV-protective goggles or sunglasses for added protection from the sun.

What other steps can those in the construction industry take to protect workers in high-heat scenarios?

The right protective gear can make a significant difference in the health and safety of workers laboring in high-heat environments, but those in the construction industry can—and should—take other precautionary steps to ensure worker well-being.

The Occupational Safety and Health Administration (OSHA) and the National Institute for Occupational Safety and Health (NIOSH) offer a Heat Safety Tool, which gives users access to the heat index for their specific worksite. Based on that heat index, the OSHA-NIOSH Heat Safety Tool provides a risk level to outdoor workers. Workers and employers can use this information—and other, similar tools—to plan and prepare appropriately for their work conditions.

Construction employers must also provide workers with an adequate number of breaks to rest in the shade and drink water. Plan the most physically taxing labor for the coolest times of day—early in the morning or towards the evening hours. Educate workers on the causes and symptoms of heat-related illness, and have an emergency plan in place to help those on the jobsite handle a dangerous situation properly.

As temperatures continue to rise, the construction industry—and the companies that produce protective gear for construction workers—will have to keep innovating and identifying new and improved ways to make sure all workers get home safely at the end of the day.

Aging Petaluma Veterans Building To Get New Roof, Other Improvements

The Veterans Memorial Building in Petaluma will get a new roof, seismic upgrades and other improvements under a \$1.9 million construction contract approved Tuesday by the Sonoma County Board of Supervisors. The 64-year-old building at 1094 Petaluma Blvd. South serves as a key community meeting space in Petaluma as well as an emergency evacuation center.

"I am thrilled that we are finally able to tackle a major maintenance project on this vital community asset," said Supervisor David Rabbitt, who represents Petaluma. "The veterans building serves as an important space for veterans, community events and also provides a lifeline for evacuees in times of crisis."

The building has been owned or operated by several organizations, including the City of Petaluma and Sonoma County Regional Parks. In the mid-1990s, the county's General Services department took over building maintenance responsibilities for all veterans buildings in the county, and in 2012, the county also assumed responsibility for the buildings' operations.

The contract is with Adams Commercial General Contracting and includes contingencies up to 10 percent

of the project cost for a total of \$2.1 million. The Eureka-based company submitted the lowest of three bids opened on May 18. Adams bid \$1.92 million, Martinez Construction Services bid \$2.87 million, and Kirby Construction bid \$4.44 million.

The 23,800-square-foot veterans' building was constructed in 1959 and its current roof is more than 25 years old. The roof replacement will feature a "cool roof" design, which includes special roofing materials that help reduce heat absorption during hot days and alleviate the heat load on the roof, according to Johannes Hovertsz, director of public infrastructure for Sonoma County.

The facility continues to serve as a key hub for community events, arts programs and veterans service organization meetings and acts as an important emergency shelter and charging center during disasters.

"The roof and seismic upgrades must be performed simultaneously as many of the components of the seismic reinforcement are accessible only through the roof diaphragm," Hovertsz wrote in a report for the board of supervisors.

Attic Safety Guidelines

Ordinary attics (and even crawl spaces) are considered confined spaces, and they present certain risks every time you enter them. However, permit required and non-permit required confined spaces present different risks, and most attics are typically classified as "non-permit required".

DEFINITIONS

Attics are, by definition, a confined space. However, attic spaces generally fall into the category of "non-permit required" confined spaces because they usually have either natural or mechanical ventilation to prevent an accumulation of a hazardous atmosphere and because other hazards are not normally present; for example: most attics do not have agitators, rotating shafts or blades, etc.

SAFETY GUIDELINES

Employees who work in non-permit required attics must observe the following safe work practices:

- When climbing up into the attic, three points of contact are required on ladders at all times.
- You must wear protective clothing and equipment to prevent irritation or injury in attics:
 - o A long sleeved shirt, gloves, and pants;
 - o A hard hat to protect your head from protruding nails;
 - o Respirators to help protect you from airborne fibers.
 - o Safety glasses or goggles.
- Temporary platforms complete with rails must be installed if possible prior to working in attics in order to discourage employees from stepping on any surface besides a truss or a joist.
- Air monitoring or additional ventilation methods may be required in some attics.
- Visually check for wood rot before placing weight on any wooden parts.
- Attics should be well-lit to ensure visibility during any length period of work.
- If possible, employees should avoid disturbing the insulation to reduce the amount dust, mold, or fibers that may be released into the air.

- Attics may get very hot in warm weather, so it is important to drink plenty of water and take frequent breaks to avoid heat illness.
- Consider placing a drop cloth under the hatch to catch any dust or fibers that fall out of the attic for easier clean up.
- When finished working in the attic, avoid spreading the fibers on your clothes to the rest of the house, garage, or facility by:
 - o Not going into uncontaminated areas;
 - o Not shaking off your clothes or tools;

US Consumer Inflation Continued To Slow Sharply In June

Reuters reports that US consumer prices “rose modestly in June and registered their smallest annual increase in more than two years as inflation subsided further, but probably not fast enough to dissuade the Federal Reserve from resuming raising interest rates this month.”

According to data released by the Department of Labor, the Consumer Price Index in June was up 3.0% over the previous year, “the smallest year-on-year increase since March 2021 and followed a 4.0% rise in May.” CNBC reports the CPI was up 0.2% over May. However, the core CPI, which excludes volatile food and energy prices, was up 4.8% from a year ago and 0.2% over May. The AP reports, “Over the past two months, inflation has slowed rapidly – from nearly 5% in April to just 3% now. Much of that progress reflects the fading of big spikes in food and energy prices that followed Russia’s invasion of Ukraine last spring.

Other major drivers of higher prices, though, are also beginning to fade,” such as used car and rental prices. Bloomberg calls the new numbers “a major step toward ending the cost-of-living emergency – and possibly the Federal Reserve’s historic monetary tightening, too.” The Washington Post reports, “The latest data reflects a drastically different economic picture than June 2022, when inflation soared to 9.1 percent, just months after Russia’s invasion of Ukraine sent energy prices soaring. Part of the reason that this June’s inflation figure dropped so much is that the yearly data compares against last year’s peak. The energy index, for example, which drove inflation for much of last summer, is now down 16.7 percent for the 12 months ending June.”



Capitol Connection Q&A for Contractors

People come and go, business goes on 24/7, 365. So, how and when can a licensed contractor cover his 'qualified bases' before his 'qualified time' runs out when someone leaves? A complex question preceding a 'regular' one, with a 'pass or fail' finale...

Q: As you are aware, our Qualifying Individual's last day of employment is 7/31. He currently qualifies all three of our classifications – "A", "B" and "C-10". We plan to have another of our employees take the exams and take over as the Qualifier for all classifications, but you had mentioned we must do them one at a time. You also mentioned that we can submit a one-time request for a 90-day extension of time to replace. We will need to do so here. Is a separate request made for each of the three classifications, or is it one request? Will we have enough time to complete this before the 180 days is up? What happens to the license if we don't complete all three within the 180 days?

A: The one-time request for a 90-day extension is one request. As long as you have an application to replace in process, you can request the one-time extension, but it would be an additional 90 days to complete the replacement for all three. Six months is enough time to complete the process, but obviously you'll want to submit the second/third applications immediately after the previous one is complete. If for some reason you don't get the process completed for all three within the six months, as long as you complete at least one, the license should remain Active and in Good Standing. If all three are not complete within the six months, the classification(s) which have not been done will be removed from the license.

Q: In California, does every corporate Officer need to be on the license and need to be fingerprinted? Even if they are just a "regular" Officer and do not hold a President or Secretary title? What's the requirement for AZ and NV?

A: In all three states, all Officers which are listed with that state's Secretary of State (SOS) records need to be listed on the license and have a background check completed. I'm not sure what you mean by "regular" Officer title, but Officers such as VP's, Assistant or Co-Officer, etc. do not need to be listed on licensing board records or SOS records.
