# **3 Ways to Modernize Your Wildfire Preparedness Plan**

Climate change is making it more difficult for organizations to keep workers safe and maintain operations. It's more important than ever that businesses keep updating their wildfire preparedness plans.

Wildfire "season" no longer exists. In years past, most U.S. wildfires occurred between June and August. Now, blazes are breaking out in early spring and lasting well into November. Rising temperatures and dry vegetation have created the need for yearlong wildfire vigilance.

In 2022 alone, nearly eight million acres of land burned in North America—well above the 10-year average. Today, one in six Americans are exposed to significant wildfire risk, and climate change is expected to exacerbate that over the next 30 years.

In recent years, the U.S. has experienced staggering losses because of wildfires especially in the wildland urban interface (WUI), the area between undeveloped and developed land that is home to nearly a third of the country's population. Additionally, recent population growth and decades of growing housing development in the WUI leave our nation vulnerable to further loss. We are already seeing evidence of this with The York Fire in southeastern California and Nevada, which has already burned more than 94,000 acres.

Experts have sounded the alarm on more severe wildfire seasons, both now and in the future; however, many organizations have not adjusted risk mitigation strategies to ensure the safety of their people and assets. Organizations of all sizes and industries should modernize their wildfire preparedness plans to minimize losses for both the business and employees—and they should go well beyond traditional evacuation routes.

Here are three areas of focus to consider as you revamp your wildfire readiness plan.

## **1. Location Audits**

Wildfire preparedness plans are not one-size-fits-all. For a plan to be effective, it's essential to conduct a thorough risk assessment of each location and record anything unique to that facility.

Location-specific policies and procedures can include guidance on tasks such as propane tank removals, directions on handling important documents and providing multiple evacuation routes. Although the details will vary by location, using a standard format

will create consistency across plans so that safety leaders can quickly provide direction on where to find information and checklists during stressful moments, even if they're not on-site.

In addition to auditing each location, it's key to plan for how to transfer processes, supplies and tools from one facility to another in the event of wildfire evacuation or fire damage. This will also help you maintain safe operations if wildfires result in temporary staffing changes, such as if employees are injured or displaced.

## **2. Refreshed Trainings**

Updated and frequent training is crucial to ensure plans are actionable and new procedures stay top-of-mind for all employees. Regularly hosting tailored tabletop exercises and in-person simulations at each individual location can aid memory retention and uncover areas for improvement.

And research shows that as risks for severe weather and natural disasters increase, employees want updated and consistent training. In a recent study from AlertMedia, 84% of employees surveyed said their employer could do more to make them feel prepared to handle emergencies at work. The research shows a strong correlation between the frequency of safety training and employees' ability to navigate a crisis.

Frequent safety training helps employees feel more adequately equipped to handle emergencies and execute official emergency response plans. This ensures employee safety—and it increases an organization's resiliency.

Wildfire preparedness training should include remote employees, too. Make sure they determine the proper evacuation routes for their home offices, have access to wildfire information resources and understand wildfire evacuation order stages to keep themselves—and their families—safe.

## **3. Communication**

Effective communication assures safety and business continuity are maintained despite wildfire dangers. Modernized emergency communication tools enable safety leaders to reach the right people at the right time with relevant information, quickly.

Leveraging wildfire communication templates for the most common scenarios can also accelerate access to information when sharing time-sensitive updates.

Wildfires can also cause significant operational downtime. Efficient communication can mean the difference between a resilient organization and heavy revenue loss. 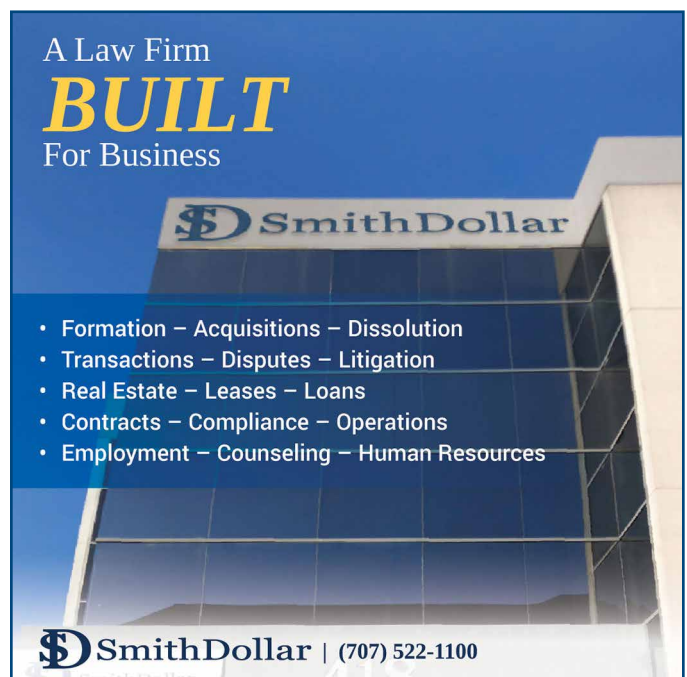

## **OSHA Announces Heat Hazard Alert**

On July 27, OSHA issued a heat hazard alert to remind employers of their obligation to protect workers against heat illness or injury in outdoor and indoor workplaces.

The department also announced that OSHA will intensify its enforcement where workers are exposed to heat hazards, with increased inspections in high-risk industries like construction and agriculture. These actions will fully implement the agency's National Emphasis Program on heat, announced in April 2022, to focus enforcement efforts in geographic areas and industries with the most vulnerable workers.

The action comes as President Biden announced new actions to protect workers from extreme heat and new investments to protect communities, as historically high temperatures break records and expose millions of people to the serious dangers of heat in the workplace.

"Historically high temperatures impact everyone and put our nation's workers at high risk," said Acting Secretary of Labor Julie Su, in a statement. "A workplace heat standard has long been a top priority for the Department of Labor, but rulemaking takes time and working people need help now. This action, combined with OSHA's increased heat-safety enforcement efforts, shows that we are determined to protect the safety and health of millions of people whose jobs become more hazardous in harsh weather."

Since 2011, the Bureau of Labor Statistics reports 436 people have died due to workplace heat exposure, with an annual average of 38 deaths between 2011 to 2019.

In addition, an average of 2,700 cases involving heat illnesses lead to days lost at work, putting an additional economic burden on workers and employers. Statistics show that people who work in conditions without adequate climate control face higher risks of hazardous heat exposure and that these situations disproportionately expose people of color to hazardous heat.

In October 2021, OSHA began the rulemaking process to consider a heat-specific workplace standard by publishing an Advance Notice of Proposed Rulemaking for Heat Injury and Illness Prevention in Outdoor and Indoor Work Settings in the Federal Register.

"As the Occupational Safety and Health Administration works toward proposing a rule to protect workers from heat illness, we are taking several measures today to better protect workers in extreme heat," said

Assistant Secretary for Occupational Safety and Health Doug Parker., in a statement "Employers have a duty to protect workers by reducing and eliminating hazards that expose workers to heat illness or injury."

OSHA uses hazard alerts to provide specific information on safety and health hazards to employers, workers and other stakeholders. An alert describes the hazard and offers recommendations on how hazardous exposures can be eliminated or reduced and what actions employers should take to protect employees. The alert issued today does the following:

- Highlights what employers can and should be doing now to protect employees.
- Ensures employees are aware of their rights, including protections against retaliation.
- Highlights steps OSHA is currently taking to protect workers.
- Directs employers, employees and the public to crucial OSHA resources, including guidance and fact sheets on heat.

"State laws that attempt to limit workers' access to basic heat-illness prevention measures send a dangerous message that employers are not responsible for providing employees with a safe work environment. In fact, that is simply not the case. Regardless of their job or where in the nation they work, workers have the right to a safe and healthy workplace. OSHA will use every tool and mechanism at our disposal to enforce those rights and make sure that every employee ends their workday safe and healthy," Parker added.

As the rulemaking process for a proposed heat-specific workplace standard continues, OSHA has moved to protect workers from excess heat in the workplace by taking the following actions:

- Developing an enforcement initiative on heat-related hazards.
- Launching of a National Emphasis Program on heat inspections.
- Creating the National Advisory Committee on Occupational Safety and Health's Heat Injury and Illness Prevention Work Group to understand challenges and share best practices to protect workers.
- Launching a Heat Illness Prevention campaign to educate employers and workers on the dangers of working in the heat.

# The good news is also the bad news: Job openings are stagnant

### Dive Brief:

- The U.S. construction industry had 374,000 job openings in June, down 5,000 from May, a drop of about 0.1%, according to data from the Bureau of Labor Statistics released Tuesday.
- About 4.5% of construction jobs went unfilled in June. The monthly report from BLS counts unfilled positions employers currently seek to staff. That number dropped 9,000 from June 2022.
- The number of quits dropped nationwide in June, and construction saw the third largest drop of all industries: 51,000 fewer workers quit in June than in May.

### Dive Insight:

Despite the slight drop in open jobs and a reduction in quits, contractors' labor woes are far from over, according to Anirban Basu, chief economist for Associated Builders and Contractors.

"Some will focus on the fact that construction job openings declined in June," Basu wrote in the press release. "But the real story is that, despite massive interest rate increases and tighter credit conditions facing developers and others that purchase construction services, the number of unfilled jobs remains so elevated by historical standards."

Last month, Basu wrote that workers wield more power in labor negotiations, and that trend will continue in the coming months. That doesn't show signs of stopping.

As contractors continue to indicate they intend to increase staffing over the next six months, many will continue to struggle to recruit and retain the skilled craftspeople they need to deliver projects, Basu said.

# ASSISTING COWORKERS WITH MEDICAL EMERGENCIES

In all workplaces, there are going to be employees who will have a medical emergency at some point in their career. Medical emergencies could result from an injury, from a health condition that an employee has, or exposure to chemicals or fumes. When such emergencies occur, coworkers can offer assistance to help those victims.

## MEDICAL EMERGENCIES

Medical emergencies could happen at any time and place. Medical emergencies may include:

- Injuries (broken bones, spinal injuries, back injuries, deep cuts or wounds, etc.)
- Concussions
- Electrical shock
- Shock (can be caused by severe bleeding, diabetes, allergic reactions, spine or necks injuries)
- Seizures (any seizures that last more than a few minutes)
- Heart attack
- Cardiac arrest (when the heart immediately stops)

- Severe allergic reactions

## KNOWING THE LOCATION OF THE VICTIM

When assisting a coworker who is experiencing a medical emergency, it is important to know the location of the room, building, or work site. The location information should be as specific as possible due to the amount of time that could be lost if the emergency medical services team has to go area to area to find you and the victim.

## WHAT TO DO IN A MEDICAL EMERGENCY

Employees should read and understand their company's Emergency Action Plan for specific details on how to handle medical emergencies. Employees should speak with their supervisor if they have questions on the emergency action plan.

Medical emergencies can be scary events. Knowing what to do in such situations will make them easier to handle when they arise.

## ASSISTING COWORKERS WITH MEDICAL EMERGENCIES

When dealing with a medical emergency, employees should use the check-call-care method to offer aid to victims. This method involves the following:

- Stay calm.
- Keep the victim calm.
- Visually inspect the area around the victim for signs of what could have caused their injury or condition. Do NOT step in to help the victim until you have verified that it is safe to do so. Do NOT become a second victim.
- Either call or have someone else call 911 or other emergency services. When talking with 911, employees should provide the following information:
  - o The nature of the emergency
  - o Their name
  - o The location of the victim (give as many specifics about the location as possible)
- Remain on the phone with the dispatcher. Do NOT hang up until the dispatcher has hung up.
- Follow any instructions given by the dispatcher.
- Send someone to go greet the emergency services team. The greeter can help lead the team to the victim.
- Either fetch or have someone else fetch the first aid kit.
- Check the person for injuries. If the victim is conscious and is able to communicate, ask them if they are feeling any pain, discomfort, or numbness in any areas of their body.
- Render first aid if you have been trained or feel comfortable doing so.
  - o CPR should only be done by qualified and trained employees.
- Stay with the victim until emergency services arrive and start to give aid to the victim.
- Reassure the victim that everything will be alright.
- When the emergency services team arrives, give them as much information about the victim and circumstances as possible.

### CONCLUSION

# Safety Group Says Government Heat Protection Efforts for Workers Isn't Enough

On July 28, leaders of the National Council for Occupational Safety and Health (National COSH), an advocacy group whose aims include establishing and strengthening unions, said that the steps announced by the White House to protect workers from extreme heat are insufficient.

“Tragically, workers are getting sick and dying every day from the extreme heat driven by climate change,” said Jessica E. Martinez, co-executive director of National COSH, in a blog post on the organization’s website. “This is no time for modest steps. The President, Congress, federal OSHA and state and local officials must take bold action now, to reduce risk and save lives.”

“We are not helpless in the face of the triple-digit temperatures that are breaking thermometers all over the globe,” said Marcy Goldstein-Gelb, also a co-executive director of National COSH, in a statement. “Heat stroke and heat illness, like other occupational hazards, are preventable.”

Practical, evidence-based measures including adequate rest breaks, plentiful fresh water, access to shade, reduced work schedules, moving work to cooler parts of the day, and a buddy system so no worker is left alone can and must be implemented now in every indoor and outdoor setting where extreme heat is present.

In addition to the stepped up enforcement and inspections for heat safety violations ordered by President Biden which are authorized by the ‘general duty’ clause of the U.S. Occupational Safety and Health Act, the president, Congress and state officials must all take action to create specific standards on heat stress which will offer more and better protection for workers.

“There is no reason for employers to await the result of a regulatory process,” said Martinez. “There is definitely a reason not to wait: Absent preventive measures, more workers will become sick and die from exposure to extreme heat.”

The National COSH leaders urged several specific steps, including:

- President Biden should order federal OSHA immediately to issue an Emergency Temporary Standard (ETS) to protect workers from heat stress.
- Congress should put into law a requirement that federal OSHA issue an interim standard on heat stress. This can complement and strengthen any emergency standard issued by the agency.
- Federal OSHA has already begun the lengthy process of creating a permanent safety standard on heat stress,

and this must be completed as rapidly as possible.

- Currently only five out of 50 states have workplace safety rules to protect against exposure to extreme heat; Oregon is the only state which protects both indoor and outdoor workers.
- Officials in 45 other states should take immediate steps to issue state-level standards, which can frequently be completed more quickly than federal rulemaking. Under the OSH Act, state standards must be least as strong – and can be stronger – than federal standards.

“Millions of workers who build our homes, bring food to our tables, and provide other essential goods and services... [are] at risk right now,” said Martinez. “Our government, at all levels, must respond – right now.”

# Ways to Improve Employee Mental Health

The importance of ensuring good mental health has been a topic front and center for most companies over the past few years. Even the government has stepped up with its announcement this week about putting mental health on par with physical health. The White House said that it “wants to ensure that people seeking coverage for mental health can access treatment as easily as people seeking coverage for medical treatment.”

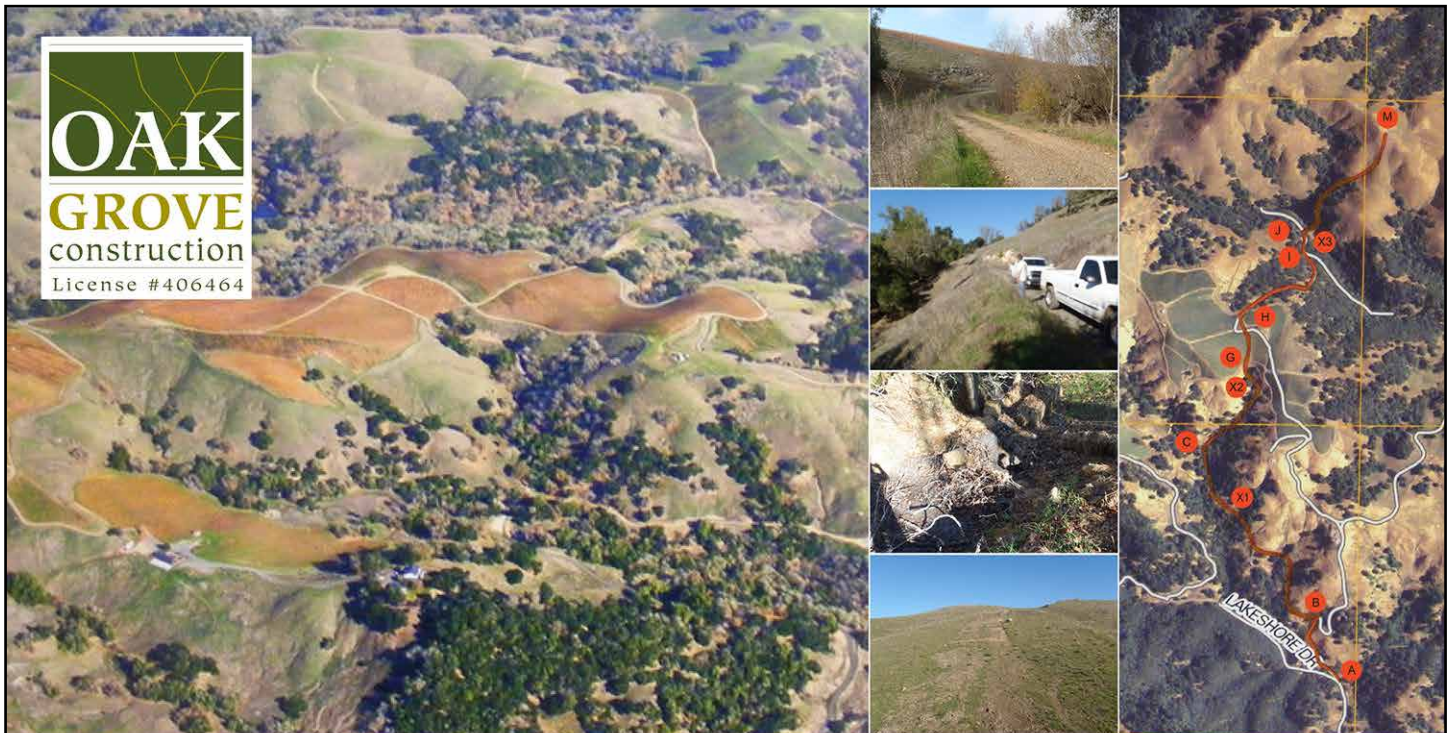
According to Julie Su, Acting Secretary of Labor, “Mental health care is as important to the well-being of America’s workers as medical care, and we must eliminate barriers to getting people the lifesaving care that they often need.”

To help employers create policies and programs to assist with this, a recent whitepaper, Business Case for Focusing on Employee Mental Health, used an unusual survey method. Using Brandwatch’s Consumer Research tool, they analyzed 1,304,110 Twitter posts discussing topics related to mental health and wellness in the workplace. The content was from the United States during the period of January 1-October 31, 2022.

Here are their key findings:

- Organizations on Twitter who back their claims of supporting mental health are lauded on social media. On the other hand, organizations that showcased their mental health program but were accused of not doing so in practice were attacked.
- Discussions surrounding mental health were driven by spikes of coverage focused on burnout with some polarizing opinions on the factors affecting it and coping mechanisms. Later in the year, “quiet quitting” was one of the most significant contributors of conversation after a TikTok post went viral.
- Some employers are testing out the four-day workweek with mixed results, but most reactions are positive from both the employer and employee perspectives.
- Gen Z and Millennials were the most frequent contributors to conversations about mental health
- Employees said employee resource groups (ERGs) and peers in the workplace were critical support programs for mental health.

The report notes that “simply posting statements about mental health on social media will not be sufficient, evidenced by the discrepancy between companies’ and employees’ perspectives on the issue and disgruntled employee posts on Twitter. “ So they offered recommendations companies should consider as they address workplace mental health:

### Provide Benefits Such as “Mental Health Days”

Offering benefits such as mental health days or granted days off that are “specifically geared toward mental health and burnout prevention” (Forbes, 2022) is one concept that employees rallied for on social media.

### Support Management to Better Understand Well-Being and Belonging

Managers should also be trained to promote well-being at work.

### Invest Financially in Employee Wellness

Employers can invest in their workforce’s mental health through the healthcare plans they already offer, much like PwC did in their \$2.4 billion investment in employee well-being.

There are several ways employers can take action since financial resources will vary from company to company. Some suggestions include offering free visits with a mental health professional, reimbursing the cost of out-of-network mental health support, or offering free, comprehensive wellness programs to help employees improve their mental and emotional well-being.

### Provide Opportunities for Social Support

Employee resource groups (ERGs) have been lauded by employees as an effective way for companies to support employee mental health.

Creating trusted communities for peers to share with one another is a benefit that employers can provide with little financial cost.

## **Tight vs. Loose Personalities: Implications for Safety Leadership**

E. Scott Geller

In her 2018 book *Rule Makers, Rule Breakers: How tight and loose cultures wire our world*, Gelfand distinguishes between a tight and a loose mindset, which is largely determined by the culture in which a person is raised, and “is like the program we use to make decisions.”

Those with a tight mindset appreciate discipline, adhere to routines, conform to social norms, control their impulses, show strong preferences for structure and order, and focus on avoiding failure. In contrast, individuals with a loose mindset are generally more impulsive, risky, less attentive to social norms, and relatively comfortable with ambiguity and disorder.

It is interesting and instructive to consider the consistency between the tight/loose mindset introduced by Gelfand and the Big Five taxonomy of personality traits that personality psychologists have recognized favorably for nearly three decades (Costa & McCrae, 1992; Goldberg, 1993). More specifically, psychological scientists (e.g., DeYoung, 2006; Digman, 1997; Olson, 2005) have discovered a replicable higher-order structure of stability (conscientiousness, agreeableness and emotional stability) and plasticity (extroversion and openness). A follow-up study demonstrated that these two higher-order factors predict relevant variation in behavior: restraint for stability or tightness, and engagement for plasticity or looseness (Hirsh, DeYoung, & Peterson, 2009).

### **The Tight/Loose Sweet Spot**

Gelfand introduced the concept of a “sweet spot between tight and loose.” Given that excessive constraints or tightness and excessive freedom or looseness contribute to lower happiness and life expectancy, as well as greater rates of depression, suicide and mortality, she proposes that “we need to balance our natural preferences for more constraints or more freedom to be at our best.” She refers to the classic Yerkes-Dodson Law of Arousal (Yerkes & Dodson, 1908) that predicts an inverted-U relation between performance effectiveness and arousal or stress. In other words, the quality or effectiveness of performance peaks with a moderate level of arousal or stress and depletes when arousal or stress is too low or too high.

Gelfand operationalized the Yerkes-Dodson Law and her sweet spot concept by referring to parenting strategies—overly protective versus overly permissive parents. She introduces the notion of a “parenting sweet spot,” whereby children have restrictions but also have the freedom to make personal decisions within specified limits.

She supports her “sweet spot theory” by referring to a longitudinal study of college students at the University of California that found the following:

1. None of the students with uninvolved parents who provided loose guidance graduated in four years, nor readily found employment.
2. Those students who received tight guidance from “helicopter parents” graduated in four years, but they had “professional and emotional dependency issues.”
3. The students with parents who were available for guidance but allowed them to make their own decisions had the best outcomes—graduating from college in four years, finding desirable employment and handling emotional challenges without excessive parental involvement.

### **Personality Trait vs. Person-State**

Most personality researchers and scholars discuss personality characteristics as traits: permanent dispositions to think and act in particular ways. For example, the two higher-order personality traits derived from the Big Five, which connect directly with the tight/loose concept—stability for tight and plasticity for loose—define immutable dispositions that influence an individual’s daily cognitions, attitudes and behaviors. Given this perspective, people with a stability trait should feel more comfortable or happy in a tight culture than in a loose culture. In contrast, those individuals with the plasticity trait should be most content in a loose culture.

Some psychologists use the term person-state rather than personality trait to reflect the malleability of various dispositions. A person-state can vary as a function of particular interpersonal and contextual factors, including education and training. With this perspective, the culture of an organization can influence one's personality, and vice versa. A tight culture supports the person-state of stability and can tighten up the looseness of a plasticity person-state. Likewise, a plasticity person-state is supported in a loose culture but might tighten up in a tight culture.

### Nature vs. Nurture

This discussion of personality trait versus person-state connects to this age-old question: To what extent are personality characteristics or dispositions determined or wired-in at birth (i.e., nature) or developed through life experiences (i.e., nurture)? The easy quick-fix answer is both, but the relative influence of nature and nurture on our personality dispositions has yet to be determined—and perhaps never will be. While we can influence the person-states of ourselves and others, the degree of such influence is determined by personality traits.

Consider, for example, the introvert/extrovert dimension of the Big Five personality traits. Personal reflection or introspection might reveal a natural inclination or desire to interact with strangers or to avoid such interactions. Extroverts are presumably energized from social interaction, whereas introverts experience fatigue from interpersonal encounters.

However, introverts can learn to interact effectively with strangers and through experience can feel quite comfortable interacting with people they do not know. Unlike extroverts, however, introverts will not seek such interpersonal exchanges without an ulterior motive (e.g., selling or promoting a product, or seeking assistance or advice). Analogous to Gelfand's "sweet spot" theory, many individuals are neither an introvert nor an extrovert. Instead, they have a personality trait that falls between the introvert/extrovert extremes.

## Capitol Connection Q&A for Contractors

I will reassure a reader who is worried about a ‘qualified’ husband. The answer is a lesson in ‘risk/reward’ everyone can learn from. Another contract only has 30 days to live unless the licensing process goes at warp speed...

**Q:** My husband was recently offered a position with his company to act as the Responsible Managing Employee (RME) for their license. I have a couple of questions while we are considering this. 1. Are there any personal liabilities by taking on this role, i.e., if something were to happen, could our personal assets be at stake, and could my husband’s personal contractor’s license be affected? Or does all liability fall completely on the corporation since the license belongs to the Company, with my husband as the RME? 2. How easy would it be for my husband to disassociate himself from the RME role should he ever decide to leave the company? And finally, 3. Is it common to negotiate a higher salary since he would be the one who holds the contractor’s license for them?

**A:** All are great questions! To answer the first question, there are definitely responsibilities which come with the role of RME such as working at least 32 hours a week and being actively involved in overseeing projects and workmanship.

However, I have never run across a situation where an RME’s personal assets are at risk due to association with a Company license. If he were to have the title of RMO (Responsible Managing Officer) my answer would be different. I have heard that many times Qualifying Individuals have the Company they are serving as the Qualifier for provide them with an indemnification though, as a layer of comfort and for “just in case” purposes.

Which leads us to question #2. It is not difficult to disassociate from a license should he decide to leave the Company, or if he feels the Company is performing unfavorable practices that may affect the license. There is a disassociation notice available on the CSLB’s website your husband can complete if necessary. If there

are any unsatisfied judgements, citations, etc. associated with the Company which cause the Company license to be suspended, it is very likely your husband’s personal license would also be suspended until he removes himself from the Company license.

And lastly, the question regarding a higher salary. I don’t get involved in that side of things, but I’ve heard that yes, that is common practice.

**Q:** We are discussing the plausibility of obtaining our California license by the time the project we need it for comes up. Is it possible to obtain a license in less than a month?

**A:** Not usually. It’s possible, at the current moment anyway, to get approved for testing in less than a month. But then test scheduling, bonding, fingerprinting, etc. usually adds a couple of weeks to the process. The CSLB has an Expedite Committee that will consider your reason for needing an application to be expedited, but those are approved only in rare instances, such as public safety concerns or the like.
