## **Injury to Recovery: How to Support Your Workers**

Workplace injuries can disrupt life—physically and emotionally. Employees injured on the job are twice as likely to experience serious psychological distress compared to those without injury. Simple tasks like caring for children, cooking, walking pets, or managing finances can feel like hurdles. It leaves workers asking: what's next?

That's why your employees need your help through every step of their recovery. Let's look at what you can do to care for your injured employees and their well-being.

### **Trust Your Employees**

After an injury, trust becomes a pillar of support. I've worked in managed care for nearly 30 years. In my experience, most workers' compensation claims are real, valid cases. Don't focus on the few that might not be.

Listen to your employees and encourage open, two-way communication. They're feeling the effects of a physical injury and the uncertainty that comes with it. Dialogue builds trust, and it can lead to information that helps you tailor your support.

### **Understand Their Behavioral Health Challenges**

Behind every injury is a person. That person has thoughts and emotions. They also have responsibilities outside of their job.

Remember, your workplace provides more than a paycheck to employees. It offers social connections, normalcy, and security. Injuries can take that away.

Here are challenges your injured employees may face:

- Anxiety and stress
- Lack of social support from family, friends, and work
- Financial uncertainty
- Fears of re-injury or job security
- Chronic pain
- Difficulty adapting to physical and emotional changes

Each of these risks can affect an employee's recovery and extend their time away from the job. The result can have serious financial implications for your business and your employee.

Just by understanding these risks, you can become a better advocate for your injured workers. When you maintain frequent communication with your employees, you can help spot these stressors early on. This enables you to offer better support, which can lead to better recoveries. An outcome that benefits your employee, their family, and your business.

### **Embrace Your Role as an Employer**

If you strain your back unloading a pallet on the job, you could miss work for a few weeks. How would you want your employer to treat you?

Most workers I've met want compassion, empathy, and support.

If you aren't communicating with your employees, you leave room for uncertainty. That can soon lead to feelings of fear, isolation, and distrust. It can disrupt their progress and damage your business's culture.

- Schedule regular check-ins and communication
- Offer support and resources
- Outline flexible work arrangements and modified duties
- Collaborate on their return-to-work goals

Now, let’s take a closer look at how to put that into practice.

### Involve the Right People

The people who support your injured employees can serve as first-line advocates. They’re the eyes and ears that can help recognize when an injured worker needs more support—or other resources. A successful program includes open communication among several parties:

The injured employee

- The employee’s supervisor
- Your human resources representatives
- Your insurance claims representative
- The employee’s treating provider, who will work closely with the insurance claims representative

Together, your support team plays a vital role in helping employees overcome physical and mental barriers.

Technology—with human service—can also aid your efforts. Don’t hesitate to explore potential services available through your insurer. Resources like telehealth and virtual reality therapy can provide greater access to care. Meanwhile, data analytics may offer insights that help identify trends and risk factors.

### Develop an Early Return-to-Work Plan

The Colorado Division of Workers’ Compensation suggests that up to 10% of all workers with injuries may experience delayed recovery.

An early return-to-work plan can help employees stay engaged and ease them back to work. By developing a formal plan with injured employees, you show them you value their contributions. That type of commitment can help them regain their confidence and a sense of normalcy.

As a result, you can help promote better outcomes and control medical costs. It's a win-win for you, and your employees.

### Here's how to start:

Assign a leader to manage your program. They should work with your business's safety and human resources teams to create consistent messages and expectations.

Develop a policy statement that emphasizes your commitment to offering flexible accommodations. Highlight your focus on supporting their holistic recovery.

Establish clear goals to monitor results. Include specific criteria for employee eligibility. Outline milestones and administrative details needed to support injured employees.

Connect with the care team and your insurer to discuss accommodations and the employee's ability to return to work. Identify potential resources that may help employees manage social, emotional, or psychological concerns.

### Outline Light Duty Tasks

Depending on an employee's medical restrictions and the needs of your business, a modified program can offer a variety of options to help them reacclimate to work. In your business, that could look like:

- Inventory management
- Data entry and documentation
- Office tasks
- Machinery and equipment maintenance
- Training other workers, including new hires, in their area of expertise
- Property and safety inspections
- Customer communication and support

Regardless of their tasks, ensure it's meaningful and engaging work. Your main objective is to make sure your employee still feels like a valuable member of the team. If they do, it can aid their recovery and help them overcome the psychological barriers that can impact their return to work.

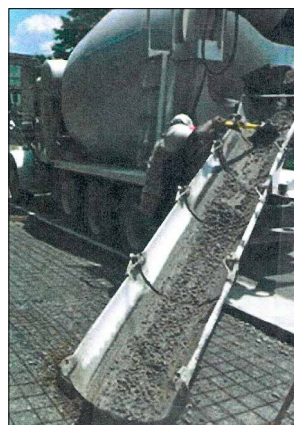

## DOL to update prevailing wage laws

### Dive Brief:

- The Department of Labor announced Tuesday that it will publish a rule updating the Davis-Bacon Act, which sets the prevailing wages contractors must pay workers on federal projects.
- The rule, first announced in March 2022, will restore the DOL's definition of prevailing wage to make it equivalent to the wage paid to at least 30% of workers, rather than 50% of workers, in a given trade in a locality, according to a White House fact sheet.
- The move is aimed at raising the hourly earnings of workers for prime contractors and subcontractors on projects that receive federal funding through legislation such as the Infrastructure Investment and Jobs Act and the CHIPS Act, but construction groups said it will raise the cost of infrastructure projects for taxpayers.

### Dive Insight:

The Davis-Bacon Act, originally passed in 1931, uses pay surveys administered by the DOL to set the prevailing wage in a federally funded project's location. The process can be complicated and cumbersome for contractors and has elicited concerns that it skews wage rates.

Under the current process, at least 51% of surveyed wages need to be within a "same or similar" margin. If they're not, the weighted average — as opposed to a simple average — of all wages is used. That means more frequent occurrences of low wages could drag down the overall rate.

To remedy that, DOL's rule returns to the system used until 1983, when the last changes to the act were made during President Ronald Reagan's first administration. At that time, the overhaul was viewed as a major blow to organized labor.

### Process changes

The new rule also makes the process of updating prevailing wage rates easier, according to the DOL, by giving the department the authority to adopt prevailing wages determined by state and local governments, issue wage determinations for labor classifications where insufficient data was received through its wage survey process and update outdated wage rates.

Lastly, it adds an anti-retaliation provision in contract clauses to protect workers who raise concerns from being fired or punished. It also strengthens DOL's ability to withhold money from a contractor in order to pay employees their lost wages.

The new rule is sure to face legal challenges, according to Roll Call.

The announcement was made Tuesday morning in Philadelphia by Vice President Kamala Harris and Acting Labor Secretary Julie Su, who also met with union construction workers and national and local union leaders.

Later, the officials were expected to receive an on-site briefing at a construction site at the I-95 interchange with the Betsy Ross Bridge, near the site of a major roadway collapse earlier this summer.

### Strong reaction

Contractor groups voiced strong opposition to the announcement. Associated Builders and Contractors, which asked the administration to withdraw the proposed rule shortly after it was announced, said it increases regulatory burdens on small businesses, new industries and public works projects. Ben Brubeck, ABC vice president of regulatory, labor and state affairs, called Davis-Bacon rules a "regulatory boondoggle" known for increasing the cost of construction, discouraging competition from small businesses and diminishing the value of taxpayer investment in government infrastructure projects, in an email to Construction Dive.

The DOL said it will mean thousands of extra dollars per year for more than 1 million workers and noted its far-reaching effects.

"These numbers will continue to grow given that nearly all of the significant construction programs contained in the IIJA, CHIPS and Science Act and Inflation Reduction Act require or strongly incentivize the use of Davis-Bacon prevailing wages," the White House statement read.

## Succession Planning for Your Contractor's License CSLB

As a licensed contractor in California, it is important to plan for the future of your license. Your license number can be reissued or reassigned to an immediate family member in several circumstances as defined in Business & Professions Code section 7075.1. CSLB Licensing staff reviews every situation on a case-by-case basis.

If you are a sole owner and wish to have your license reissued or reassigned to a family member as required to continue the family contracting business, or to a corporation or limited liability company (LLC) created by family members to continue the family contracting business, then a waiver application can be submitted to CSLB with two statements. The first statement is signed by you stating that you will become absent from the license and requesting CSLB to reissue or reassign it to the new family member (applicant). The second statement is signed by the applicant stating that they are applying to have the license reissued or reassigned to them. If the new applicant has been involved in the family business for at least 5 of the last 7 years, then they may not have to test. Otherwise, they can still complete the process by testing for the classification if they have 4 or more years of verified experience in the last 10 years.

In the event of your passing and the license is required to continue the family business, a family member should notify CSLB within 90 days and apply for a continuance that allows the license to remain active for a determined period of time. They may also apply to have the license number reissued or reassigned to them or to a corporation or an LLC they have created to continue the family business. If they do not apply for a continuance within 90 days, it is important to understand that the family business will have been working without a license between the date of your passing and the date any new license is issued after 90 days.

You may form a corporation or an LLC and request that CSLB reissue or reassign your sole owner license number to the new entity if you maintain ownership of at least 51% of its voting power. This allows for family members to seek to be added to the license personnel or to become the qualifier after 5 years of working in the business.

If your family business is already a corporation or an LLC, you can add family members to continue the business in the event the qualifier becomes absent or deceased. After the added family member(s) has been on the license for at least five years and been actively engaged in the license classification, they may apply to become the qualifier without taking the exam.

## **RECENT ENFORCEMENT EFFORTS**

### CSLB - Legal Corner

AB 336 (Cervantes, 2023) would require licensees who are not exempt from workers' compensation requirements to certify on the CSLB license renewal form the top three (by payroll) workers' compensation classification codes (WCC) endorsed on the licensee's workers' compensation policy. This bill would prohibit renewal without that certification but provides for retroactive renewal if the licensee complies within 30 days after notification by CSLB that the renewal was rejected.

AB 1204 (Holden, 2023) would prohibit specialty contractors from subcontracting with more than one subcontractor in the same classification as the specialty contractor on the same jobsite unless: 1) the subcontractor has employees who perform the work in the relevant classification or 2) the specialty contractor is signatory to a collective bargaining agreement for the work being conducted. This bill would make a violation of this section cause for disciplinary action.

SB 601 (McGuire, 2023) would increase the statute of limitations for misdemeanor violations pertaining to unlawful use of a license. It is supported by consumer complaints received from designated disaster areas where licensed contractors unlawfully allowed unlicensed contractors to use their license for disaster rebuilds. This bill would also increase the civil penalties for specified home improvement contract violations in declared disaster areas.

SB 630 (Dodd, 2023) would require CSLB applicants and licensees to provide an email address, if available, at the time of initial licensure and renewal. This bill would require licensees to update their email address within 30 days of a change and specify that licensee email addresses are not subject to disclosure under the California Public Records Act (CPRA). Additionally, this bill would authorize the Registrar to revoke a license when probationary conditions placed upon that license are not met.

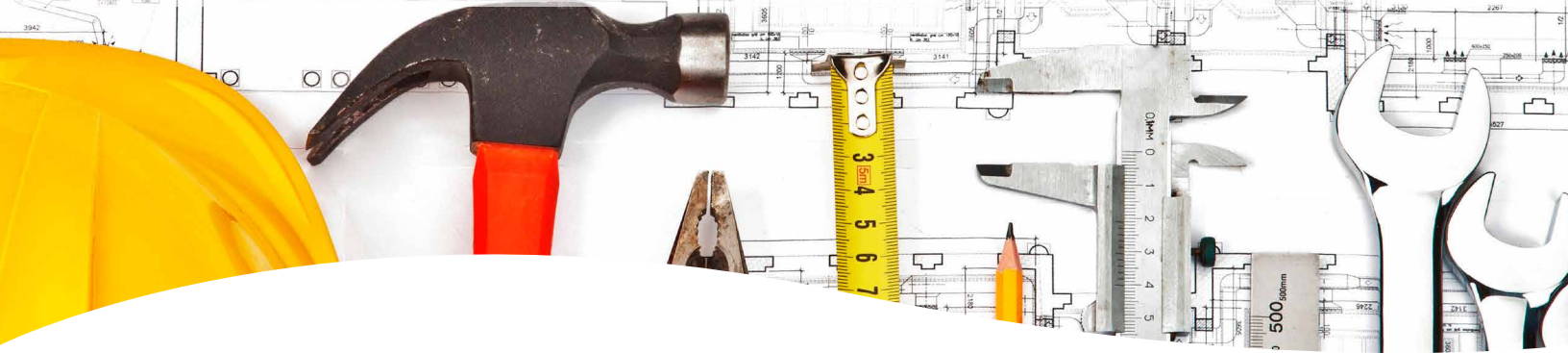

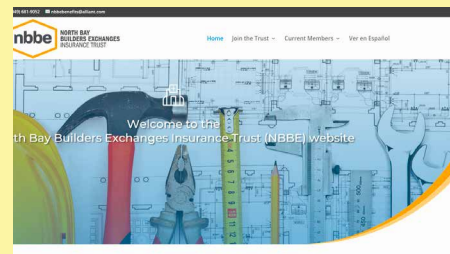

## Capitol Connection Q&A for Contractors

**Life is a challenge and every day a test, but when can you expect to sit down for your contractor license exams? I share why you cannot franchise experience in applying or borrow someone's license to bid and work...**

**Q:** Our company has the opportunity to perform some work in California. From what I've read, it can take half a year to get licensed! I was speaking with a General Contractor who told me that we could just use his license while we are in the process of obtaining our own. Is that legal?

**A:** It is never legal to use someone else's license. If your company is signing a contract for work to be performed, your company needs to have its own contractor's license. There are situations which allow for you to use an already licensed contractor's qualification in order to obtain a license more expeditiously, but you cannot outright use their license. The good news is that it absolutely should not take six months to obtain a license! Give our office a call and we would be happy to assist you with the process.

**Q:** I am an attorney and I have a client interested in buying a Contracting business. While my client has plenty of business experience, he doesn't have experience in the construction industry. The business he is interested in purchasing is a Franchise. I was reading that the CSLB gives credit for technical training and such. The Franchise offers training and support for all of it's franchisees and we are wondering if the training they receive counts towards qualifying for the license.

**A:** Unfortunately, no, that doesn't count. With regards to contractor licensing, technical training refers to vocational training, apprenticeship programs, education beyond high school/GED, and military experience (if its construction related).

**Q:** When submitting an application for a new license, approximately how long after the application is

submitted should I expect to be approved to sit for the exams? And are the exams open book? I'm trying to plan for study time.

**A:** You will likely be approved to schedule the exams about 6 weeks after the application is submitted, and no such luck on the open book though! You are not permitted to bring any material in to the exam with you.

**Q:** We need to add a couple of Officers to our license to give them signing authority. Both of the Officers reside in Illinois. Do they have to get fingerprinted with hard copy cards locally, or will they have the option to come to CA and do live scan? Additionally, one of our Officers has been fingerprinted before through the DOJ I believe for other licenses. To confirm, will he need to complete another fingerprint for CSLB or are the prints reciprocating through the FBI/DOJ?

**A:** The first step to getting fingerprinted is getting the applications to add them to the license submitted to the CSLB. The Officers cannot fingerprint ahead of time, they have to wait for the forms from the CSLB once the applications have been approved. When the CSLB sends them the fingerprint packet, they will include both options for live scan in CA or hard copy cards locally. Unless the individuals have specifically been fingerprinted for the CSLB, they will need to be printed again. Fingerprint results are not transferable from one requesting agency to another.
