## Long Covid is Showing Up in Medical Claims

A year after contracting COVID-19, 6% of workers were still receiving medical care due to the effects of long-term COVID, according to a new study from Workers Compensation Research Institute (WCRI).

This study expands prior evidence from early in the pandemic, showing persistent rates of long COVID infections through 2021.

“Our main takeaways for workers’ compensation policymakers and stakeholders are that long COVID continued to affect a meaningful share of workers with COVID-19 infections, and that was an important driver of claim costs,” said Ramona Tanabe, CEO of WCRI, in a statement. “At an average of 18 months of post-infection experience, these workers received more than 20 weeks of temporary disability benefits and received about \$29,000 in medical care.”

The study, Long COVID in the Workers’ Compensation System in 2020 and 2021, provides

insights into workers’ recoveries from COVID-19. The study addresses the following questions:

- What is the prevalence of long COVID among workers with COVID-19?
- What are the costs of long COVID claims?
- What is the duration of temporary disability benefits among workers with long COVID?
- What are the industry and worker characteristics associated with long COVID?
- How do rates of long COVID vary across states?

The analysis includes COVID-19 cases reported with a date of infection between March 2020 and September 2021. For each claim, we collected information on medical care and income benefits that were provided through the end of March 2022, across 31 states.

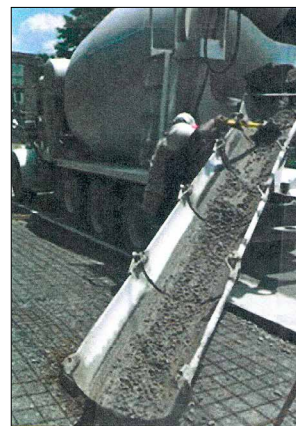

## **Sonoma County airport puts finishing touches on yearslong construction**

After more than a decade of planning and nearly three years of construction, Charles M. Schulz-Sonoma County Airport will formally unveil its completed \$40 million terminal improvement and modernization project Wednesday, airport officials announced.

The finished product brings to fruition a renovation of 7,000 square feet, along with the addition of 33,000 square feet, which ultimately increases the terminal's size to approximately 56,000 square feet. Airport administrators are now focusing their efforts on stepping up flight frequencies and adding new markets. According to Airport Manager Jon Stout, such discussions with the airport's three commercial carriers — Alaska Airlines, Avelo Airlines and American Airlines — are ongoing.

"Now, at this point, we are going to meet with Alaska at the end of September to have discussions about next year," Stout said. "We are pushing for a couple of new markets with them."

They are Ontario in Southern California, and Austin, Texas, he said.

"We don't expect an answer on that for quite a few months yet, but we are working with them to try and encourage those new routes," Stout said. "And we're still working with Avelo on other markets, Boise, (Idaho) and some others."

Earlier this year, Stout shared with the Business Journal additional markets targeted for the Santa Rosa facility. They are Provo or Salt Lake City in Utah; Chicago; Boston and New York. Denver also remains top of mind — whether with United again or another carrier.

Sun Country is also considering bringing back the seasonal service it offered to Minneapolis between 2017 and 2020.

"We provided them quite a bit of information about a month ago," Stout said.

And talks continue with American Airlines to convince the carrier to make its seasonal flights to Dallas year-round. The flights, which continue to be popular, are scheduled to pause this year on Dec. 4, and resume Feb. 15, 2024, Stout said.

Meanwhile, airport officials have released passenger numbers for July, which show 55,025 people traveled through the regional facility, down 8.5%

from a year prior. In June, 56,256 passengers traveled through the airport.

For the first seven months of the year, the airport's three commercial carriers have collectively flown 351,243 passengers, up 2.7% from a year earlier, according to the figures. For comparison, during the pandemic, in July 2021 and July 2020, the airport flew 188,593 passengers and 118,602 passengers, respectively.

Looking at the airlines' July figures individually, Alaska flew 38,061 passengers through the Sonoma County airport last month, up 10.7% from a year earlier. Its load factor — the measure of how full airplanes are on average — was 84%. The Seattle-based commercial air carrier, the largest serving the regional airport, flew 37,928 passengers through the airport in June.

Avelo Airlines, in July, flew 9,505 passengers through the regional airport, down 14.2% from a year earlier. Avelo's load factor was 90%. In June, the air carrier flew 10,107 passengers through the airport. And American flew 8,359 passengers through the regional facility last month, down 39.7% from the year prior. Its load factor was 89%. American in June flew 8,221 passengers through the facility.

## What to know about final Build America, Buy America guidelines

The White House has clarified rules around which construction materials for federal infrastructure projects must be produced in the U.S.

### **Dive Brief:**

- The White House on Monday issued final guidance on its Build America, Buy America rules, which aim to boost the amount of domestically manufactured goods, including steel, iron and other construction materials, used on federal infrastructure projects.
- BABA is part of the \$1.2 trillion Infrastructure Investment and Jobs Act passed in 2021, but applies to all federally funded infrastructure projects. The Office of Management and Budget issued proposed draft guidance in February and received nearly 2,000 public comments since then.
- The final guidance defines relevant construction materials and local manufacturing process standards for each material. Contractors have previously complained that a lack of clarity around BABA was holding up projects and delaying potential positive impacts of the influx in federal funding.

### **Dive Insight:**

The IIJA significantly expanded standards that require government-funded infrastructure projects to use more U.S.-made products. The BABA preference applies to three categories: iron and steel products, manufactured products and construction materials. OMB expanded the list of materials to include engineered wood but opted to leave out coatings, paint and bricks after reviewing feedback.

To qualify as Made in America, a product must be manufactured in the U.S., with 55% of the cost of

its components fabricated domestically.

Under the final guidance, construction materials include:

- Non-ferrous metals.
- Plastic and polymer-based products, including polyvinylchloride, composite building materials and polymers used in fiber-optic cables.
- Glass, including optic glass and optical fiber.
- Fiber-optic cable, including drop cable.
- Lumber.
- Engineered wood.
- Drywall.

Cement and cementitious materials; aggregates such as stone, sand or gravel; or aggregate binding agents or additives are not included. The rules also do not apply to tools, equipment and supplies brought to the jobsite and removed at the end of the project, according to OMB.

There are three cases in which awarding agencies can issue waivers:

- A public interest waiver, if applying BABA would be inconsistent with the public interest.
- A nonavailability waiver, when U.S. manufactured products are not sufficiently available.
- An unreasonable cost waiver, if the use of U.S. materials will increase the cost of the overall project by more than 25%.

The new guidance will take effect 60 days after publication in the Federal Register in the coming weeks.

## EEOC Updates Guidance on Hearing Disabled

The Equal Employment Opportunity Commission (EEOC) recently updated its guidance regarding Hearing Disabilities in the Workplace and the Americans with Disabilities Act (ADA), and employers should take note and refresh their policies and practices accordingly.

“While familiar principles of disability accommodation law resonate throughout the guidance, the details and examples are a helpful resource for employers that are not familiar with the challenges and range of assistive options for those who qualify as hearing disabled,” says attorney Tracey I. Levy of Levy Employment Law LLC, who noted that she has a hearing disability in a recent letter to clients.

One of the things that the EEOC stresses is that an employee doesn’t have to be deaf to be described as suffering from hearing disabilities. People with a variety of hearing conditions may be considered to have ADA disabilities if they are substantially limited in hearing or another major life activity.

“From personal experience, the ability to discern spoken language can be significantly impacted even if an audiology report does not register as deafness,” Levy points out. “Hearing loss and conditions like tinnitus (ringing in the ear) and sensitivity to noise can impede the ability to engage in conversation at networking events, social functions, or other large gatherings or in loud workplaces.”

Where a hearing condition is not obvious, the EEOC guidance makes clear that an employer can ask for medical documentation, but only to confirm that a covered disability exists and what accommodations may be needed, not to ascertain the cause or nature of the impairment.

In general, the law precludes employers from asking employees about their medical conditions. However, the EEOC guidance notes that an exception exists if an employer knows an employee’s medical condition or has observed symptoms of a condition and reasonably believes the medical condition or those observed symptoms are causing performance problems.

In these situations, employers can choose to inquire further for purposes of discerning whether this particular employee may require a reasonable accommodation.

The EEOC offers the example of an employee who wears a hearing aid and had been a consistently good performer in an administrative position prior to being promoted to a new role that involves considerably more time on the phone. If the employee’s performance has declined because she is making many mistakes with customer orders she records over the phone, the employer can ask whether she has difficulty hearing on phone calls and ask whether she would benefit from an accommodation.

The employer could not ask those questions, however, if the performance issues the employee demonstrated were typographical errors, lateness, or other issues having nothing to do with hearing, Levy stresses.

Several of the EEOC’s illustrative examples make the point that accommodations need to enable the hearing-disabled employee to participate fully in the workplace. Accommodations like providing notes or the summary of a meeting when a deaf employee has requested a sign language interpreter would not be a reasonable alternative if the deaf employee is unable to ask questions and participate in discussions at the meeting.

### Technology Advancements Help

Levy also emphasizes that technology advances have contributed substantially to improvements in the ease and capability of employees with these conditions, including services like video remote interpreting, and can facilitate participation in more cost-effective ways than was possible in years past.

There may be times when providing a sign language interpreter is a reasonable accommodation for an employee or group of employees who are hearing impaired. But not every hearing-impaired individual understands American Sign Language (ASL), particularly if the impairment developed later in life. Levy says that for some employers the cost of an interpreter may be prohibitive to the degree of presenting an undue hardship.

There are, however, a range of other, often less expensive accommodations that employers may consider for those with hearing disabilities, she adds, including:

- Bluetooth-enabled or other hearing aid or cochlear implant-compatible technology to connect to telephone headsets and sound systems.
- Non-auditory safety alerts, like strobe lighting or vibrating pagers for emergency notification systems.
- Other assistive software and technology, including video remote interpreting, automated captioning, telephone amplifiers or adapters, captioning features on virtual meeting platforms, voice carry-over/captioned or text telephones, and voice recognition or sound detection software.
- Equipment for hearing protection to block noise or protect hearing function.
- Assistive listening devices that translate voice into text and vice versa.
- Appropriate written memos and notes, especially for brief, simple or routine communications.
- Work area adjustments, such as away from a noisy area.
- Time off as needed for treatment or adaptive services.
- Altering marginal job functions.
- Reassignment to a vacant position.

Many accommodations that can be provided to a disabled employee, including those with hearing disabilities, involve little or no cost to the employer, Levy explains.

These include flexibility in seating or work location, left-sided vs. right-sided headsets for those with

single-sided deafness, permission to access the closed captioning services on software like Zoom and now available on Apple's iOS, and patience in being asked to repeat, write or text something that was not heard the first time, particularly when in a loud environment, can make an appreciable difference in enabling those with hearing disabilities to fully and successfully participate in the workplace.

“The examples offered by the EEOC reflect that sometimes presumed safety risks can be addressed with the addition of simple visual aids or by leveraging technology, such as a visual alert on a smartwatch or vibrating pager with a light signal,” Levy notes. “The solution may not be obvious to the employer, which is why consulting with the employee or a service like the Job Accommodation Network (JAN) can be helpful.”

The EEOC says that approximately 15% of American adults report some trouble hearing. “If you are not one of them or have not closely engaged with someone in that category, it can be difficult to understand the range of contexts in which hearing difficulties may be impacted, and also to know the options for addressing those difficulties,” Levy adds on a personal note. “Get advice and leverage the EEOC’s guidance and resources like JAN (which is free) for further information.”

## Why AI may not be taking over procurement just yet

Chatbots and automation can help streamline operations, but suppliers still need human interaction for negotiating and problem-solving.

Artificial intelligence is exploding and those of us in procurement will not remain untouched. On the sellers' side, proponents of AI's efficiency and scope are marginalizing the human contact-based customer-supplier relationships by employing customer service chatbots devoid of personality and decision making skills.

On the buyers' side, managers are using AI to automate transactions to streamline procurement, reduce staff and align supply and demand through complex analytics. But AI has never had to cajole a supplier to add an overtime shift, cut a price to meet a specific customer demand, override a bill of material or host an engineer to mark up a blueprint and generate an engineering change order. At least not yet.

Chatbots are AI-powered conversational agents that can interact with customers in a chat-based format, providing automated support and assistance. They pop up when we access our cell or cable accounts and are migrating over to the industrial world, where many suppliers are finding them useful. Implementing chatbots can lead to significant cost savings. Compared to hiring and training human agents, chatbots are cheaper and eliminate the need for resources like office space, equipment and benefits. Providing round-the-clock customer service is another key advantage of chatbots. They are highly scalable, handling multiple customer conversations simultaneously, and follow predefined rules and guidelines, ensuring patterned responses to similar inquiries. In some cases, that may be just enough to keep customers happy. So why don't we like them?

Chatbots lack human emotions and empathy, which are crucial for many customer interactions. In complex or emotionally charged situations, customers may require personalized attention and understanding that only a human can provide. Chatbots also heavily rely on data and algorithms, which means they can only provide information within their programmed knowledge base.

Due to limitations in understanding natural language and complex queries, chatbots struggle with ambiguous or poorly phrased questions, resulting in inaccurate or incomplete responses. Inable sourcing practices, supplier diversity initiatives and regulatory compliance. Humans are essential in evaluating and ensuring supplier integrity, advocating for social responsibility and strong ethical standards.

**Creativity:** Procurement professionals need to adapt to changing market conditions, emerging technologies, supply chain risk and evolving and emergent customer needs. They also need to think creatively to identify innovative solutions and workarounds, explore new supplier options and optimize existing procurement procedures.

**Cross functional integration:** Procurement professionals interact with various stakeholders within the organization, including finance, marketing, engineering and operations. Procurement teams require human communication and internal relationship-building skills to collaborate, align objectives and manage expectations.

Perhaps one day we'll all be working for a sentient procurement robot, but not today.

## Workplace Safety and Productivity Go Hand in Hand

A recent study from Science Direct found that physical and psychosocial conditions at work directly impact worker safety, health and well-being and “influence enterprise outcomes such as turnover, absence, productivity and healthcare costs.”

So now that you’re aware of the link between safety and productivity, how can you utilize this knowledge for the advantage of your team and organization? Every team and organization are different, but there are some general steps that can be taken in any industry to benefit all employees. While organizational change

takes time and patience, the important first step is to implement some sort of framework that supports and promotes safety in the workplace.

### Training

Safety training—even online—encourages and facilitates valuable engagement and connection amongst the team, thereby strengthening the personal and professional dynamics on multiple levels. Not every new safety protocol will require a training session or workshop. However, when you are introducing a new major practice or policy, training may be needed.

Use these opportunities to not only educate the team on these important safety measures, but also try to make them as fun as possible. After all, they are also occasions for employees to connect over safety and other issues. The engagement alone from these sessions is worth it, resulting in significant ROI and improved operations. According to a study from The Conference Board on workplace engagement in the U.S., disengaged employees cost organizations around \$450-550 billion each year.

### **Leverage Existing Communications Devices**

Worker safety has been an important issue ever since 1897 when Great Britain passed a worker's compensation act for occupational injuries. In the centuries since, countries across the globe have come a long way with laws and legislation to protect workers, including the creation of OSHA in the U.S., as well as the development of personal protective equipment (PPE) and innovative technologies.

From advanced location tracking and fall detection to automated check-ins and panic buttons, leveraging any existing and commonly used devices (such as smartphones and tablets) for these features is essential for protecting your team to the best of your organization's ability. For example, this means employing lone worker safety technology and apps that can be utilized on devices already in the field that employees are familiar and comfortable with. The growing market and options may be overwhelming, but the good news is that there is a safety platform or software for almost every type of safety need and industry.

### **Physical and Psychological Safety**

When it comes to workplace safety, the conversation tends to gravitate toward physical safety hazards and how to mitigate them. But due to the widespread isolation and loneliness of the pandemic, safety managers are talking more about how to support the mental and emotional well-being of workers, which impacts their physical safety as well as the productivity and caliber of their work." The American Psychiatric Association Foundation estimates that \$44 billion in productivity is lost each year to employees with depression.

Depression, loneliness and other mental health issues have increased over the past 18 months, but managers are not powerless. There are a number of resources that can be provided to improve mental health and stress management in the workplace. Mental health amongst the team is also stronger when they are engaged with the safety of themselves and their co-workers.

An active safety department is constantly keeping workers connected and aware of any potential hazards or risks. Whether you're looking at employee data from a safety app, you're conducting a lunch-and-learn workshop or simply checking in on a co-worker, these activities provide opportunities for connection.

Reaching out to employees on a regular basis strengthens relationships and can result in better performance because employees feel valued, which can also help increase employee retention.

### **Safety Culture**

In 2016, OSHA passed a regulation that prohibits employers from discouraging workers from reporting injuries and illnesses and also requires employers to inform their employees of their right to report any incidents. In a 2009 report, The National Employment Law Project found that 43% of low-wage workers in Los Angeles, New York and Chicago experienced illegal retaliation from their employer after filing a safety-related complaint.

But the tide seems to be turning. Partially because of the vigilance against COVID-19, employers are more aware of the safety hazards facing their team. Even though every organization's safety culture will be unique, the strong ones will create a work environment where staff feel comfortable to speak up about any potential safety hazards without fear of backlash; staff should be encouraged to raise their safety concerns and even rewarded for doing so. A strong culture of safety and well-being can benefit the productivity and quality of work in an organization. In an EHS Today article, Terry L. Mathis says that balancing safety and productivity "tends to enhance both, while letting either one triumph over the other will not only damage these efforts but also create collateral damage in other areas of the organization."

### **Moving Forward**

It's clear that a safe work environment has a number of impactful benefits, including increased work capacity and quality, in addition to improved well-being and corporate culture because workers will be more engaged with their job as well as their co-workers.

Safety and productivity are two important pieces of a bigger puzzle that encompasses a prolific and happy team who will produce better work as a result. While it might not happen overnight, by focusing on these four areas, you can empower and engage workers to constantly improve workplace safety and simultaneously increase their productivity.

## Capitol Connection Q&A for Contractors

**Yes, no, or maybe? Doubt about an important contractor license issue is a healthy sign. While law is written, how it gets interpreted over time is hard to know. That's why checking with an expert is a good idea. Keeping track of change in your entity, making sure paperwork is processed and up to date another challenge with definite consequences. And our last contractor says nobody knows his work and experience more than he does. Is that enough?...**

**Q:** I have been the Responsible Managing Officer (RMO) for a company license for the past several years. They agreed when I originally signed on with them to pay for the reactivation of my personal license upon my departure. We are getting things in line to have me replaced on the company license by year-end and reactivate my personal license. I have an LLC which is already set up. Am I able to pay to reactivate my personal license but assign it to my LLC?

**A:** The ultimate answer is yes, but while you automatically assume you'd need to submit a reactivation, you would actually need to apply for a "new" license for the LLC and request the Sole Owner license number be re-issued to the LLC. In order to be approved for the sole owner to LLC/Corporation transfer, you are required to own at least 51% of the LLC/Corporation.

**Q:** I don't know how this was missed but our license is currently Suspended for lack of Qualifier. We knew our Qualifying Person left the company but we thought we had 90 days to replace him. When I was notified by a customer the license was suspended, I went online to see his disassociation date was shown as three months ago! I'm not sure how that happened, but what do I do to fix it?



**A:** It's possible your Qualifier submitted a back-

dated Disassociation notice. I see that you have been an Officer on the license for over five years, so my suggestion would be for you to submit an application to be his replacement ASAP! You can ask for a Waiver of the exams based on B&P Code section 7065.1. Contact my office if you would like help with expediting the process.

**Q:** I am a General Contractor and I'm looking to add some specialty C-classes to my license. Am I able to sign off for my own work experience for these since I'm a GC?

**A:** No, the CSLB never allows for a Qualifier to sign off on their own work experience. You are required to have someone else with first-hand knowledge of your work background certify and sign to verify your experience.

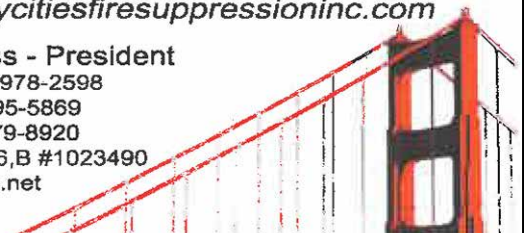
