## Secrets of the Safety Leaders

“I wish making the case for safety didn’t seem to always come down to ROI. Protecting people shouldn’t be so laser-focused on money.”

What is a workplace safety leader? Sometimes it’s one person, working alone; sometimes it’s a small group of occupational health and safety managers; sometimes it’s a large team of EHS professionals overseeing the safety of a multinational corporation. When EHS Today conducted its 2023 National Safety and Salary Survey, we set out to learn exactly what a workplace safety leader does, and what follows is our special report on those findings.

Based on responses from 744 EHS professionals, we can tell you that most of the safety leaders in the United States have direct reports (55%), probably between one and nine, although 6% are responsible for 50 or more people. But what that also means is that 45% are on their own, especially those working for small to mid-sized organizations, where the safety leader often wears a lot of different hats. And one of their biggest challenges, make no mistake, is their workload keeps increasing while the size of their support staff does not.

Through the magic of spreadsheets and cross-comparisons, we crunched the numbers from the survey responses to develop a composite portrait of what a “typical safety leader” looks like (admittedly, there’s really no such person). Based on the most frequent responses to our various demographic questions, the typical safety leader has the job title of EHS manager, is a white male in his 50s, lives in the Midwest, has more than 20 years of experience, works for a manufacturing company, manages a staff of fewer than 10 people, earns \$99,212, and received a raise of roughly 4% in the past year .

By way of comparison to last year’s demographics, the basic description of a safety leader hasn’t really changed since 2022, although the average salary did dip slightly from \$99,609. So, for all intents and purposes, while the responsibilities shouldered by safety professionals increased, the average salary didn’t change appreciably over the past year. “Safety first” looks really nice on a break room poster, but supporting the EHS department with appropriate budgets and staffing isn’t always on the corporate agenda.

### What’s in a Title?

To get a better handle on what an EHS professional is, take a look at the accompanying chart, “Average Salary by Job Responsibility.” From our survey, one-third of respondents have the title of EHS manager, EHS supervisor or an equivalent title, and they earn, on average, \$99,558. EHS professionals, who make up the second biggest bloc among our respondents at 25% of the total, earn \$83,722. EHS directors or VPs account for 12%, the third-largest group, and earn \$132,551.

This would be the appropriate time to issue our disclaimer that when it comes to your own salary situation, your mileage may vary (in fact, it almost certainly will), so just because you have a EHS director title, that doesn’t mean that you’re going to have any luck pressing for a hefty raise if you’re nowhere near making \$132,000. Numerous factors come into play when it comes to the salary ranges of safety practitioners.

Safety professionals work in a lot of different industries and professions. Based on our survey results, the largest percentage work in manufacturing, with the largest concentration being in light manufacturing industries (such as apparel or consumer electronics) or heavy manufacturing industries (such as automotive or aerospace), which combined add up to 29% of all respondents. The light manufacturing respondents earn an average of \$87,228 while heavy manufacturing averages \$103,973.

Construction is also well represented in our survey, accounting for 14% of respondents, at an average salary of \$102,580. The highest paying industry, according to the survey, and consistent with what we've seen in previous surveys, is research & technology, with an average salary of \$137,191 (but only accounting for 2% of the survey respondents). Insurance (\$114,860), chemicals (\$114,573) and consulting (\$114,108) are also among the highest-paying industry sectors.

When asked about their areas of personal responsibility, safety leaders reported back with a very long list of responses. The most common answers were safety (91%), occupational health (67%), risk management (64%), ergonomics (61%) and emergency management (60%). The wide variety of responses speak to the range of things that "safety" means to an organization, an organization's priorities, the maturity and size of the organization, and the industry it serves.

### Diversity is Still More of an Idea Than a Reality

Safety leaders tend to be seasoned professionals. In our survey, we found that 68% have more than 10 years of experience, and more than one-third (37%) of all respondents have at least 20 years of experience. As you would expect, the more experience you have, the higher your salary, as the salaries rise the longer you've been on the job. Those with less than five years of experience earn \$76,109, while those with more than 20 years earn \$116,599.

When we look at the age of the respondents, the results are similar but not quite identical to the years of experience. Those aged 65 or older are making less, not more, than some younger age groups. In all likelihood, many of those over 65 are semi-retired or are in consulting roles, which would account for why their salaries are somewhat lower than safety professionals in the 45-64 age range.

All told, more than three-quarters of the respondents (76%) are over the age of 45. And when we asked respondents to cite the biggest challenges they face in their jobs, many of them said that recruiting and training young people is a constant challenge, while others mentioned the difficulty in replacing the experience of older workers when they retire.

Safety professionals are also a well-educated group, with 70% having earned a bachelor's degree or higher. The salaries tend to reflect that, as those with a doctorate earn the most, \$135,111, followed by those with a master's degree at \$112,195. Those with a bachelor's degree, the largest group among respondents, earned \$98,822.

Every year, we look for any sign that the gender gap is starting to narrow between the number of males and females in the safety profession, but unfortunately, 2023 doesn't look like it's the year that will happen. Males account for more than two-thirds of all respondents (70%), and they earn nearly \$13,000 more on average than females. A year ago, males accounted for 68% of the total and earned nearly \$12,000 more than females, so if anything, the gap has widened over the past year—not an encouraging sign at all.

There's also not much evidence that the safety profession is becoming more ethnically diverse, as 82% of all respondents are whites/Caucasian—the same percentage as we saw in 2022. The next-largest group, Hispanic/Latino, accounts for 7% (up from 5% in 2022). As we noted earlier, our survey draws most of its respondents from the manufacturing and construction industries, which obviously still have a lot of work to do in encouraging and promoting a more diverse workplace.

While our survey results don't really reflect it, more than two-thirds of respondents (68%) say their companies have launched diversity, equity and inclusion (DEI) initiatives, a slight tick up from the 67% we saw in 2022. If nothing else, that at least offers some hope that things could be changing for the better in the not-too-distant future.

#### It's not Just What You do but Where You do it

The most populous region of the United States for safety professionals is the North Central region, also known as the Midwest. One-third of all safety leaders lives in one of the Midwest states, which makes sense since that's where most of the manufacturing facilities in the country are located. The area with the highest salaries is the Pacific region (with most of those respondents living in California). Now before those of you living in Iowa or Wisconsin start daydreaming about moving out West to gain a big salary bump, you'll want to factor in the differences in the cost of living between the Midwest and the West Coast. That \$19,000 gap between Midwest salaries (\$94,339) and West Coast salaries (\$113,294) narrows considerably when you start comparing, for instance, the average cost of housing.

EHS professionals work in various settings, with the largest percentage (37%) working in a plant or facility. One-quarter (25%) are corporate staff, and 11% work at a worksite or construction site. That coincides with EHS Today's readership demographics, which focuses largely on the manufacturing and construction industries.

When we asked how satisfied they were with EHS as a career path, 84% of those surveyed said they're either satisfied or very satisfied with the safety profession. Only 2% said they're unsatisfied, and hardly anybody—less than a handful of the 744 respondents—said they're very unsatisfied. That's very positive news for the EHS profession, and an illustration of how EHS people view their careers as more of a calling than simply a job.

Respondents aren't quite as satisfied with their current jobs as they are with the EHS profession as a whole, but the numbers are still encouraging.

## Construction lost as much as \$40B on poor productivity in 2022

### Dive Brief:

- U.S. contractors wasted between \$30 billion and \$40 billion in 2022 due to labor inefficiencies, and it appears to be getting worse, according to a new survey from FMI Corp.
- Nearly half of respondents (45%) said they saw declining labor productivity on their jobsites in the last 12 to 18 months, compared to 23% who claimed improvements. The report describes labor as “the largest, riskiest, yet most controllable variable cost” in construction and said that these problems could worsen in coming months.
- The report emphasizes construction’s already thin labor margins, and respondents estimated the industry could have saved \$25 billion of the wasted funds with improved management practices.

### Dive Insight:

FMI, a Raleigh, North Carolina-based consulting and investment banking firm with clients in the built environment, said that high-performing companies can increase productivity through intense planning, reliable budgeting and documentation and buy-in from all stakeholders. These also happen to be many of the principles championed by lean construction methods.

On top of wasted money on productivity, construction faces a well-documented shortage of workers compared to demand. Estimates put the industry’s current need at half a million.

“We’re all impacted by the labor shortage, there’s no getting around that. The solution will be in how to do more with less,” said Keyan Zandy, CEO of Dallas-area contractor Skiles Group. “In a nutshell, you need the right people working together, sharing ideas and solutions, and making strategic decisions.”

Zandy, a lean construction proponent, said the real solution lies in people and “how they work together,” collaborating and connecting early in the preconstruction process.

Lean practices are commonplace on projects from many major general contractors, said Les Hiscoe, president and CEO of Boston-based Shawmut Design and Construction, who said that he has found a lot of the inefficiencies in the project lifecycle occur during handoffs.

“If an electrician says they’re going to be done in five days, it might actually be done in four, but they round it up to five to give themselves a little buffer. So then, maybe the drywall says, ‘Well, I’m also gonna take five.’ But they might have one built in for a day that’s not quite ready,” Hiscoe said. “So if you take two out of five days as not entirely necessary, that’s 40% waste right there.”

### Schedule, trust, flow

Hiscoe said Shawmut schedules early with sub-contractors and stakeholders, builds trust with them and holds each team accountable to deliver on time, which can make a huge difference. From project to project, that adds up, he said.

Charlie Murphy, senior vice president and lean manager for Turner Construction, said the contractor often turns to crew leads for their expertise to create “flow” on the jobsite, working efficiently from one area to another to allow more work done at once.

Murphy attributed the increased labor inefficiencies, in part, to an increase in infrastructure and manufacturing projects, which are often quicker to market.

“When you don’t have good planning time, those impacts show up downstream,” he said. “We can’t give up on that upstream planning, it’s such an important part of the project.”

Asked to distill the best method to decreasing inefficiencies and minimizing wasted labor costs, Murphy said, “Slow down to speed up. Plan. Engage the crew leads. And create an environment where the workers are respected.”



### 1 in 7 US workers want to leave their current job within the next year, Yoh report says

About 1 in 7 employed Americans would like to leave their current job for a new one in the next 12 months, according to an Oct. 9 report from Yoh, an international talent and outsourcing company owned by Day & Zimmermann.

On the other hand, 28% of workers said they love their job and wouldn't leave their company for any reason.

"Companies should have a finger on the pulse of their workforce and avoid assuming the best when it comes to their feelings, perceptions and attitudes," Emmett McGrath, president of Yoh, said in a statement.

"The data demonstrates that a significant slice of workers currently hold at least some reservations about their job," McGrath said. "Employee engagement efforts continue to be valuable tools to connect with workers, listen to their concerns and needs, and take meaningful actions to ensure employees are satisfied in their current roles and remain loyal to their employers."

In a survey of 1,175 U.S. adults who are employed full-time or part-time, a quarter said they'd leave their current job in the next 12 months only if they received a higher salary or better benefits.

Other changes didn't appear to be as enticing. About 7% of those surveyed said they'd leave their current job during the next year if they received the same pay but could work on more exciting projects. Similarly, about 6% said they'd leave their current job if they received the same pay but no longer had to work for their current boss.

Looking ahead, about 14% of workers said it would benefit their career long-term to leave their current job now for a new one. In addition, 14% said they believe they will need to look for a job in the next three years to receive the raise they feel they deserve, and 11% have been unsatisfied with their annual raises — or the lack of a raise — and would consider another job because of it.

Among those surveyed, older employees appear to be more loyal to their current employer than their younger colleagues. About 42% of workers over age 55 said they love their job and wouldn't leave, as compared to 19% of those between ages 18-34.

As high turnover rates continue, retention remains a top priority for both operations and HR this year, according to a recent Gallagher report. In response, employers are creating more comprehensive benefits

and compensation packages to boost the employee experience.

Unfortunately, turnover costs have increased to more than \$57,000 annually on average, according to an Express Employment Professionals report, and the remaining employees feel the added stress. Communicating with those employees — and potentially conducting stay interviews — could help them feel heard and more likely to remain.

Pay transparency can also improve retention rates and reduce turnover, according to a recent Pay-scale report. HR professionals can also provide total compensation statements that show employees how their pay is set and what additional factors play into their overall rewards.

'A low bar': How California's new workplace violence prevention plan tried to make workplaces safer

California employers have less than nine months to comply with the state's new law requiring workplace violence prevention plans. The law, which was signed by Gov. Gavin Newsom Sept. 30, goes into effect July 1, 2024.

Under SB 553, most employers will need to maintain logs on violent incidents, as well as provide training to workers on reporting incidents. The bill also permits collective bargaining representatives to seek temporary restraining orders for workers who were victims of violence or threats of violence.

The law is the first of its kind in the country to establish "general industry workplace violence prevention safety requirements," according to representatives from labor and employment firm Littler, and closely mirrors similar legislation Cal/OSHA implemented in April 2017 for healthcare employers.

"California is the first state to require workplace violence prevention. What we've seen is California is often a bellwether for other states, so where they go legislatively, other states often follow," Marisa Randazzo, executive director of threat management at Ontic, a security software company, told HR Dive.

There might not be as much legwork involved for California employers as they might think, Randazzo explained. California law already requires employers to maintain injury and illness prevention plans, and the new workplace violence prevention plans can be added to those existing documents.

The new law requires employers to:

- Designate someone to be responsible for the workplace violence prevention plan
- Establish procedures to prevent and respond to workplace violence
- Keep records of all threats and incidents of workplace violence, as well as responses to those threats and incidents
- Regularly train workers on how to report workplace violence concerns

In keeping logs of perceived threats and incidents, employers will better be able to track trends and identify more potential risks, Randazzo said. They'll be able to see, for example, if more problems occur in certain locations or within specific departments and be able to make changes to address issues, like adding lighting or enhanced security, she said.

"California employers now have to keep track of violence and threats right in their workplace. It's so important from a prevention standpoint; it's not just a matter of complying with the law. The more information that employers can capture, the better job they can do long term with keeping their workplaces safe for everybody," Randazzo said. State Senator Dave Cortese, D-San Jose, the bill's author, introduced the bill in response to a 2021 shooting at the Santa Clara Valley Transportation Authority railyard in San Jose that killed 10 people, including the shooter.

"On that horrible day, we quickly realized how safety protocols can and must be enhanced. In the following days and months, more solutions for preventing workplace violence emerged," Cortese said in a statement released after the bill was signed into law in September. "SB 553 is the result of a months-long negotiation between workers, businesses and Cal/OSHA. This groundbreaking law will help workers and employers establish a plan for the types of workplace violence that

are on the rise."

Co-workers often are the first to notice problematic behavior, said Randazzo, who previously worked as a chief research psychologist for the U.S. Secret Service. They may notice changes in a friend at work and become worried but don't want to get their friend in trouble by reporting them, she said.

"When we dissect incidents of workplace violence that have occurred, we find out typically that a lot of people had information, but they didn't know what to do with it. This legislation provides direction on what to do with that, and it can and should be a low bar for reporting," Randazzo said.

Violent events often are preceded by "red flag behavior" by people who are suicidal or don't care anymore what happens to themselves, Randazzo said. And the more employers know, the more they can do to figure out what's driving that behavior or inclination toward violence and can try to help solve those underlying problems, she said.

## Benefits and Challenges of Exoskeleton Use in Construction

EHS Today Staff

Given the fact that construction workers are at t high risk for work-related musculoskeletal disorders (WMSDs). many companies are turning to exoskeletons, both passive and active, to alleviate injuries.

Passive exoskeletons support a posture or movement using unpowered mechanisms (e.g., springs, dampers, or counterbalance forces), whereas active exoskeletons involve powered force/torque generating elements (e.g., electric motors, pneumatics, or hydraulics).

A NIOSH Science blog, published a study, that looked into In a study preventing MSK injuries using exoskeletons. The articles notes the increasing interest in the use of wearable exoskeletons in the prevention of WMSDs in construction workplaces because of cost, portability, and potential effectiveness.

The blog summed up both the benefits and challenges of using exoskeletons in construction.

### Potential Benefits

- Exoskeletons have the potential to serve as an ergonomic intervention to assist construction workers who are performing manual repetitive handling tasks and reduce risk of WMSD.
- Exoskeletons have demonstrated, in some uses, to be simple, lightweight, comfortable and easy-to-use by workers.
- Exoskeletons can help managers and safety and health professionals to mitigate the risks of developing WMSDs among construction workers and enhance worker safety.

### Potential Challenges

More research is needed to determine the:

- Most existing exoskeleton assessments were conducted in laboratory settings, involving healthy, young participants, making it difficult to generalize the results to actual worksites and to other populations (such as older workers or those who have experienced physical disabilities or previous injuries)
- Impact on time-to-completion measures, product flow rates, and/or work quality.
- Acceptability of specific exoskeletons by workers.
- Cost-benefit comparison between construction trade-specific applications of exoskeletons and other interventions.



## Capitol Connection Q&A for Contractors

Like sausage, they are making new law every day too! Contractors who fail to keep up could find themselves behind the curve. If you missed the change in NV this October that could be you. Life changes things daily. Change is just about the only constant you can count on and why having an expert resource keeping up lets your focus remain on the job...

**Q:** We have a Joint Venture license that was formed to bid on some work. The contract was awarded to the Joint Venture and the work was complete, but there may be some minor repair/warranty work remaining. One of the JV entities has agreed to sell their interest in the JV to the other entity. At the time of the sale, that entity will withdraw/disassociate from the Joint Venture. What impact will that on the license? Will it immediately be terminated? If so, can the JV obtain an extension from the CSLB to complete the contract closeout and any repair/warranty work?

**A:** When one of the JV entities disassociates, the JV license will be cancelled. The remaining entity can request a continuance of the license to complete projects contracted for or in progress prior to the date of the disassociation. The continuance can be requested for a "reasonable amount of time" to be determined by the Board. The request must be made in writing and received within 90 days of the disassociation of entity being removed.

I would suggest providing a copy of your warranty to the CSLB to show the time it covers. If it's a year, they may give you year (?) Otherwise, obviously transfer the contracts to the entity who will be performing the work for when the continuance expires.

**Renewal Reminders:** To ensure a timely renewal of your license, be sure to keep your license information updated! Items you will want to keep in order are bonds, insurance, current Officers of record, current Qualifying Individual, and Secretary of State entity

status.

A new law became effective October 1, 2023 in NV which affects all residential contractors. The statute requires all contractors performing residential improvement work comply with one of the following:

1. A down payment or deposit amount cannot exceed \$1000 or 10% of the aggregate contract price, whichever is less, of any initial down payment or deposit paid or promised to be paid to the residential contractor by the owner before the start of work, OR,
2. The provisions of item 1 do not apply if the residential contractor has filed a Bond solely for the protection of consumers in the amount of \$100,000, or has been granted relief by the Board pursuant to subsection 5 of NRS 624.270.

Regardless of which option you choose, this new law requires that you update existing contracts to ensure compliance. The new language which must be included in all contracts for residential improvement on single-family residences must include can be found here [http://nscb.nv.gov/residential\\_improvements.html](http://nscb.nv.gov/residential_improvements.html).

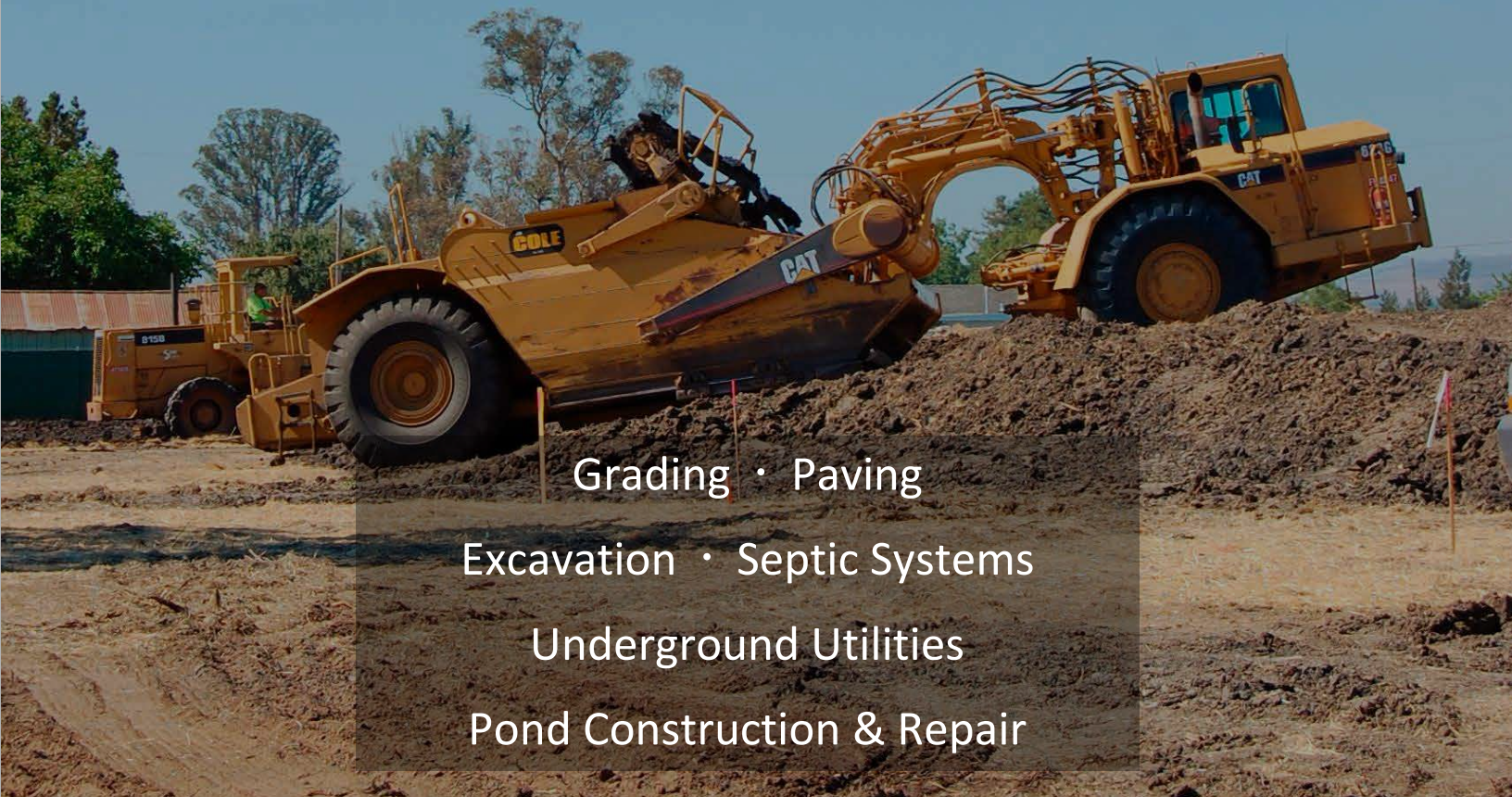
