## Sustainability Concerns Are Impacting PPE Purchasing Decisions

Eighty percent of safety managers believe that sustainability is an important purchase criterion when it comes to choosing PPE, according to a new study conducted by the International Safety Equipment Association (ISEA), the American Society of Safety Professionals (ASSP) and EHS Today. And the PPE suppliers are paying attention to that trend, as almost all (96%) of the safety equipment and PPE suppliers surveyed said they already have several sustainable business practices in place. What's more, 44% have formal, company-wide sustainability programs.

The study, "Protecting Workers and Planet: Sustainability in the PPE and Safety Equipment Industry," examines how safety equipment suppliers are increasingly offering products that not only protect workers but also support companies' corporate sustainability goals. Both EHS professionals and safety product suppliers participated in confidential surveys about current practices and needs, as well as expectations for the future.

"Over the last several years, the growth of

sustainable products has skyrocketed, especially in the consumer world," says Cam Mackey, ISEA's president and CEO. "And, while most businesses are still developing their own approach towards sustainable purchasing, now is the time for providers of PPE and safety equipment to prepare for a future where a certain degree of sustainability practices will likely be table stakes."

"[EHS] professionals are well positioned to influence change within their organizations to promote better sustainability practices," adds Jim Thornton, president of ASSP. "Increased worker expectations in this area are prompting companies to invest in the future and to invest in people as part of the triple bottom line—people, planet and prosperity."

According to the survey, 70% of safety professionals believe it's important for PPE suppliers to calculate the sustainability benefits of their products, making it easier to factor sustainability into the purchase decision.

That doesn't necessarily mean users are likely to pay considerably more for sustainable PPE, but the survey indicates they're twice as likely to pay a "sustainability premium" for suppliers who quantify sustainability benefits.


Safety professionals also emphasized that sustainability, while increasingly important, does not supersede the need to protect workers from harm. As Mackey points out, "Since several end-users voiced concerns about taking focus away from PPE's core purpose of protection, suppliers should provide proof points that their sustainable products are able to perform and protect equally or more effectively than their traditional ones."

### The sustainability attributes most important to safety professionals are:

- Improved product longevity/durability (important to 96% of respondents)
- Streamlined/reduced packaging (87%)
- Packaging with recycled/recyclable materials (86%) (see chart).

Given that safety professionals are typically among their companies' most vocal supporters of sustainability initiatives, investing in sustainable practices could prove to be a winning strategy for PPE suppliers going forward.

## Employer Strategies for Health Programs for 2024

As companies are planning for the impact that inflation will have on their health plan costs, they are also considering the impact this will have on employees. And of course benefits has always been a large factor in attracting employees.

So when Mercer released its Health and Benefit Strategies for 2024, they looked into how employers will prepare for rising health care costs while continuing to adapt benefit to improve attraction and retention and better meet the needs of the whole workforce. The survey was conducted from February 14 through March 10, 2023.

The firm reports that the average per-employee cost of employer-sponsored health insurance rose by 3.2% in 2022, according to its Mercer’s 2022 National Survey of Employer-Sponsored Health Plans. This relatively modest increase was only about half the rate of general inflation for 2022, which ended the year at 6.5%.

The group notes that typically, health benefit cost growth runs higher than the CPI. One factor holding down cost growth in 2022 was simply timing — because healthcare providers typically have multi-year contracts with health plans, employer plan sponsors were shielded from the full impact of inflation.

“However, we can expect that wage increases and higher supply costs in the healthcare sector will result in higher prices over the next few years as provider contracts are renewed. Employers projected an average cost increase of 5.4% for 2023, and we should be prepared for continued accelerated cost growth in 2024 and beyond,” the report said.

### Strategies

A majority of respondents to the survey, 64% said they were making enhancements to their health

and well-being offerings in 2024. While 28% aren’t planning to do this, they have within the past two years. And just 8% were not making any enhancements.

One aspect of the report discusses the benefits that will be offered in 2024 that fall into the category of financial support work and living expenses. Employers are providing other forms of support to address financial wellness.

### The breakdown of the benefits as follows:

- Free/Subsidized meals at work 21%
- Subsidized phone/internet for remote working 21%
- Stipend for home office set-up/supplies 19%
- Employer-provided of subsidized transportation 18%
- Student loans-refinancing assistance 14%
- Lifestyle account for well-being activities 13%
- Employer-paid legal services 9%
- Employer-provided or subsidized housing 2%

The report also discusses a variety of other strategies including addressing healthcare affordability.

## **Taking the Time to Do Safety Right**

Last summer, I received notice that my city would be replacing the pipes and redoing the storm drains on my street. I was excited about not having my water run through old lead pipes, but I didn't find the estimated timeline of work exciting: one year.

After a few false starts, work began in November 2022, around Thanksgiving. As I write this, the work is still ongoing.

There have been phases of work involving all sorts of heavy machinery digging several feet into the ground, tearing up driveways and sidewalks, laying pipes and pouring concrete. There have also been changes in traffic patterns, road closures, gigantic holes covered by steel grates, planned water shutoffs and unplanned water shutoffs.

In fact, I've gotten so used to the noises between the hours of 7 a.m. and 5 p.m. that it was once several days before I realized no one was working outside my windows. (I honestly think it took me so long to notice because I was hearing phantom beeps!)

Prior to this project, I knew very little about infrastructure, but I have learned some by talking with the construction crew and my own observations. The biggest lesson I have learned is that projects—even ones seemingly as straightforward as replacing pipes and storm drains on a residential street—are serious undertakings that require significant time. One year has proved to be an accurate estimate, unfortunately.

I'm sure many of you have similar experiences with getting safety programs and other safety-based initiatives up and running. You may not be digging down 14 feet into the ground, but you are drilling down into long-standing beliefs, practices and company culture—and that can be just as arduous to deconstruct and rebuild.

Safety, as with infrastructure projects, requires exhaustive preplanning to scope the program. That's followed by extensive research to find a viable solution. Then, there's the persuasive art of selling others on the idea and securing the resources (e.g., time, funding and people) to help bring the idea into fruition.

No matter how good an idea is in concept, implementation is a completely different beast. That's assuming you are fortunate enough to not run into any unexpected bumps in the road that could delay or derail any project. All projects, no matter how big or seemingly small, are difficult. They require serious commitment, dedication and perseverance. They are not for the faint of heart.

For much of the time, a project can seem like it's one hair shy of breaking the camel's back. It can often feel like nothing's going right, or progress isn't being made. In fact, it can often seem worse than before your project began. With construction, the machinery, supplies and road signs are clear indicators of work in progress. They may even post a cute sign saying, "Progress at work. Pardon the dust." It's understood that things are messy, but that's part of the process.


With safety projects, the process is pretty similar, but the work isn't as visible. In my opinion, that can make it more challenging for people to be patient and remain dedicated. That's because you're asking people to have faith in the end result without having anything to show for it in the meantime. Plus, they might not think anything was wrong or that change was needed in the first place.

There's the saying, "It's always worse until it gets better." It's cliché, but it's also true. You can be trudging along for days, weeks or months before a metaphorical flip is switched and everything starts falling into place. Once it does, the changes gain momentum and it can feel like the project is completed in a matter of seconds. Afterwards, it's impossible to stop marveling at the end result.

That may all be true, but that doesn't mean that there aren't speedbumps and headaches along the way. Perhaps the best we can do is remember they will not last forever. Progress takes work, but in the end it's all worth it. At least, that's what I keep telling myself.

One of these days, hopefully soon, I will marvel at the new curbs, pristine driveway aprons, smooth asphalt, and guzzle water that's not touched any lead pipes. For now, I continue to drive slow, dodge giant craters and remind myself that this will one day be a distant memory.

## OSHA, EPA Investigations Lead to Convictions in Deadly Mill Explosion Case

A federal jury in Madison, Wisconsin, on Oct. 13, convicted current and former Didion Milling Inc. officials of workplace safety, environmental, fraud and obstruction of justice charges following a deadly explosion in 2017 at a corn mill that Didion Milling operated in Cambria, Wisconsin. The explosion killed five workers and seriously injured others.

Didion Milling Vice President of Operations, Derrick Clark, was convicted of conspiring to falsify documents, making false Clean Air Act compliance certifications as Didion’s “responsible official” and obstructing the Occupational Safety and Health Administration’s (OSHA) investigation of the explosion at the corn mill by making false and misleading statements during a deposition.

Former Didion Milling Food Safety Superintendent, Shawn Mesner, was convicted of participating in a fraud conspiracy against Didion Milling’s customers and conspiring to obstruct and mislead OSHA for his role in falsifying sanitation records used at Didion to track the completion of cleanings designed to remove accumulations of corn dust at the mill.

“Derrick Clark and Shawn Messner chose to intentionally mislead OSHA investigators and made false statements about their knowledge of working conditions at the plant to protect themselves and cover their mistakes,” said OSHA Regional Administrator Bill Donovan in Chicago, in a statement. “Their blatant actions demonstrated a callous disregard for the loss of life, injuries and property damage that occurred under their leadership at the Didion Mill. Both Clark and Messner ignored their legal and moral obligation to protect workers before and after the explosion. OSHA is committed to taking all necessary action to hold employers responsible for protecting workers on the job.”

A permit issued under the Clean Air Act required compliance by Didion Milling at its corn mill including the operation of baghouses equipment, which are designed to limit the release of particulate matter like corn dust into the environment. The permit also required a “responsible official,” a senior manager with authority, to periodically certify the mill’s compliance with air pollution control permit conditions and disclose known permit violations.

Clark falsely certified Didion's compliance without disclosing that baghouse logs – documentation on maintenance of baghouse equipment – had been systematically falsified to conceal permit violations.

Grain dust can be explosive, and OSHA safety standards require grain milling facilities like the Didion Milling corn mill to develop and implement housekeeping programs, including regular cleanings, to reduce grain dust accumulation. Didion Milling maintained its master sanitation schedule to record the performance of required cleanings. Clark and Mesner were convicted of participating in a conspiracy to falsify that cleaning log, including directing others to backfill entries for uncompleted cleanings.

Federal law gives OSHA six months to gather facts and issue appropriate citations after a safety violation occurrence. In matters involving worker deaths, evidence that corporate managers knew about violations can result in issuance of a "willful" citation and a criminal referral. OSHA subpoenaed Clark's testimony in September 2017, during the corn mill explosion fatality investigation. Clark gave false and misleading testimony about his knowledge of problems with the dust collection system at Didion's corn mill, his knowledge of explosion hazards and his knowledge of prior fires at the facility.

Didion Milling sold its milled corn products to food and beverage manufacturers. Sanitation at food manufacturing facilities is necessary for food safety, and excessive accumulations of grain dust can cause food safety problems. Through deceptive means, including repeatedly presenting a falsified cleaning log to food safety auditors, Mesner conspired to deceive Didion's customers about its sanitation practices. As food safety superintendent, Mesner directed operations personnel to falsify the log to make it appear as if the cleaning schedule was being followed.

The jury also acquitted former Didion Milling environmental manager James Lenz of charges relating to falsifying environmental records and conspiring to make false statements and obstruct agency proceedings.

Didion Milling previously pleaded guilty to falsifying the cleaning logs and baghouse logs at the mill and agreed to pay a criminal fine of \$1,000,000 and restitution of \$10.25 million to the victims of the 2017 explosion. Didion Milling shift superintendents Nicholas Booker, Michael Bright and Joel Niemeyer previously pleaded guilty to false statement charges for participating in the falsification of the cleaning logs and baghouse logs. Didion Milling shift superintendent Anthony Hess pleaded guilty to obstructing OSHA by making false and misleading statements about the accuracy of the cleaning log during a sworn statement taken as part of OSHA's investigation into the mill explosion. Former Didion Milling environmental manager Joseph Winch previously pleaded guilty to conspiracy to conceal environmental violations from regulators by falsifying compliance certifications and providing falsified logs to regulators.

## **Tips from 3 of construction's best places to work**

Les Hiscoe likes to point out to his son the buildings in New York City he has worked on. The CEO of Shawmut Design and Construction says he watches buildings under construction from his apartment in the city.

"I bring my son over to the window. I'm like, 'Hey, check it out. Here's what they're doing today.' And he's like, 'Dad, enough,'" Hiscoe said. Pride in the physical results of labor help workers enjoy their jobs, Hiscoe said

"There is such a rewarding part about construction when you physically put work in place, and then when you finally finish what you started and you walk by it, you go, 'I'm really proud of that,'" he said.

The Boston-based construction firm recently won second place in Fortune magazine's Best Workplaces in Construction ranking in the small and medium category, just below a Maryland home building firm. In a survey, 95% of employees said the company is a great place to work.

Other construction-related businesses making Fortune's list of 40 companies total PCL, Hilti, Moss Construction Management, Toll Brothers, Southland and Suffolk, all in the large companies category. Company leaders such as Hiscoe say there are tactics they follow to make their companies sought-after places to work.

### **Having a voice**

For one thing, Shawmut is 100% employee-owned, as is Denver-based PCL, which took fourth place among large companies and was the top commercial contractor in that category. PCL President and COO of U.S. operations Deron Brown said about 90% of PCL's salaried employees have purchased company stock.

"It gives us a sense of ownership. It gives us a sense of 'You have a bigger say in this large company' and people listen," he said.

Of course, not every company has employees who literally buy into its success. The key, Brown said, is to invest in culture.

"You've got to listen to your employees," he said. "It's listening and feeling like they have a voice and they're engaged and they are a part of your company, and they're not just an employee getting a paycheck."

Brown said leaders should remember the experience of rising through the ranks, recalling the experience of entering the workforce at a junior level and the pressures people face from work everyday.

### **People first**

Hiscoe said he thinks focusing on people first and maintaining an enthusiastic energy helped with results.

"If they feel great when they come to work and they show up at a client's construction site or office or meeting, that shows through," he said. "That I'm super jazzed and energized at my place of work, I'm going to deliver excellently for you because I love what I do."

Suzanne Roeder, chief growth officer at Suffolk, said to "always sweat the small stuff," and focus on carefully choosing who to hire, promote and figure out who may not fit into the culture in the long term.

"Sweating the small stuff" is caring about all the small moments in people's lives, both inside and outside of the workplace," Roeder said. "There is no silver bullet or initiative that will make a company a great place to work. Excellent company culture is built on how your manager responds in a challenging situation."

### **Addressing ills**

A recent survey named construction the happiest U.S. industry, but those who work in it say it still has shortcomings. Construction has a suicide rate of roughly 45 per 100,000 workers, 18 more than the national rate for all industries, according to the CDC.

"I think jobsites can be isolated," Hiscoe said, adding workers may try to work through injuries, rely on painkillers or work longer hours to make extra money. "We've addressed the problem head on by talking to all people in the field, our craftworkers at all the subcontractor levels. We want people to be able to talk to us."

If someone has just worked a double shift, for example, Hiscoe said he wants those nearby to care about how they get home and that they don't drive while fatigued.

"I think that level of caring has to get pushed harder in our industry," he said.

Brown pointed out the mental health epidemic, highlighted by more stress at work and social media.

## DOL won't extend overtime rule comment period

Stakeholders will not get extra time to weigh in on proposed overtime rules, the U.S. Department of Labor said Oct. 10. The comment period will close early next month as planned.

The proposal would expand overtime eligibility to those paid about \$55,068 per year; today, the salary threshold sits at \$35,568 per year. It also would enable automatic updates to the figure.

DOL said it received requests for an extension to the comment period, but said the original, 60-day time frame was reasonable. The Fair Labor Standards Act rules in question have been updated several times in recent years and the agency held numerous listening sessions during the past year, it said; "As a result,

stakeholders are generally familiar with the issues addressed in the NPRM."

The agency also pointed out that it posted the proposal to its website nine days before the comment period opened, giving stakeholders a head start on the comment period.

As of Oct. 12, the department had received more than 1,800 online comments.



## Capitol Connection Q&A for Contractors

**If you are unsure, best to ask an expert! Let me untwist a ‘monkey wrench’ for one contractor, and you might avoid testing in one place, but not another. Okay, you got ‘busted’ is there still a chance to get your contractor license?...**

**Q:** I am a Business Broker and I have a client who is in the process of buying a landscape business located in Nevada that also operates in Arizona. They typically do normal maintenance and some planting of plants and converting from grass to desert. They do a very small amount of major overhaul with large plants and trees. We are unsure if they are required to hold a license or not, could you help answer that?

**A:** Your client will need a contractor’s license in Nevada if they are doing landscaping work over \$1000 in labor and materials. For the work described, a contractor’s license may not be required in Arizona. A license would be required if they are doing hardscaping work such as irrigation systems, concrete, patios, low voltage lighting, outdoor kitchens, etc.

**Q:** It’s time to renew our license. The CSLB says the license cannot be renewed until our Officer list is updated as reflected with the CA Secretary of State. In looking at the SOS records, they don’t seem to be updated either! In fact, none of the individuals most recently listed are even with the Company anymore. Our Company has gone through several personnel changes and have obviously failed to notify the State of California. To add another monkey wrench in the situation, our “RME” is now an Officer so that’s not even correct! Can you tell us what needs to be done to get everything updated and the license renewed?

**A:** First, you will need to file a new Statement of Information listing your most current President, Secretary, and Treasurer. Then you can update the CSLB with your new Officers and at the same time file to disassociate the individuals who are no longer with the Company. Remember, each new Officer you are

adding will be required to get fingerprinted so being that your license expires soon, you should start the process asap! Let us know if you need any assistance, it can be tricky updating a license where there are no current authorized signers.

**Q:** You helped me replace my dad on our CA contractor’s license and I was able to waive the examination requirement. I’m wondering if I can do the same thing on our NV license?

**A:** You were able to waive the exams based on being an employee of your father’s company for over five years. Unfortunately, Nevada doesn’t offer that same waiver option. You are absolutely going to be required to take the NV exams.

**Q:** I want to obtain a CA Contractor License, but I have a criminal history. What are my chances of being approved? I read that I need to pass a Background check.

**A:** The determination is made on a case-by-case basis, but the CSLB will review your history to determine if the crimes are substantially related to the duties of a Contractor. Criteria include nature and gravity of the offense, number of years elapsed since the date of the offense, and the rehabilitation efforts made.
